EXPLANATORY NOTE

Mae'r Rheoliadau hyn, sy'n gymwys i Gymru, yn diwygio'r Rheoliadau Ardrethu Annomestig (Newid Rhestri ac Apelau) (Cymru) 2005. Mae'r Rheoliadau hynny yn ymwneud â newidiadau i'r rhestri ardrethu annomestig (a gaiff eu llunio o dan Ddeddf Cyllid Llywodraeth Leol 1988) gan swyddogion prisio, cynigion ar gyfer newidiadau o'r fath gan bersonau eraill ac apeliadau i dribiwnlys prisio os cyfyd anghytundeb ynglŷn â chynnig rhwng y swyddog prisio a pherson arall.

Mae'r diwygiadau a wneir gan y Rheoliadau hyn yn tynnu'r cyfeiriadau at y Rheoliadau Tribiwnlysoedd Prisio a'r Dreth Gymuned 1989 (O.S. 1989/439) a ddatgymhwyswyd o ran tribiwnlysoedd yng Nghymru gan Rheoliadau Tribiwnlysoedd Prisio (Cymru) 1995 (O.S. 1995/3056), ac yn mewnosod darpariaethau sy'n niwtral o ran rhyw os oes eu hangen (Rheoliad 2).

These Regulations, which apply to Wales, amend the Non-Domestic Rating (Alterations of Lists and Appeals) (Wales) Regulations 2005. Those Regulations cover the alteration of non-domestic rating lists (which are compiled under the Local Government Finance Act 1988) by valuation officers, proposals for such alterations from other persons and appeals to valuation tribunal where there is disagreement about a proposal between the valuation officer and another person.

The amendments made by these Regulations remove the references to the Valuation and Community Charge Tribunals Regulations 1989 (S.I. 1989/439) which were disapplied to tribunals in Wales by the Valuation Tribunals (Wales) Regulations 1995 (S.I. 1995/3056), and insert gender-neutral provisions where required (Regulation 2).

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 55(2) i (6) a (7A), 143(1) a (2), a pharagraff 12 i Atodlen 7A a pharagraffau 1 ac 8 i Atodlen 11 o Ddeddf Cyllid Llywodraeth Leol 1988(1) ac sydd bellach wedi eu breinio yng Nghynulliad Cenedlaethol Cymru, ac ar ôl ymgynghori â'r Cyngor Tribiwnlysoedd fel sy'n ofynnol gan adran 8 o Ddeddf Tribiwnlysoedd ac Ymchwiliadau 1992(2):

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 55(2) to (6) and (7A), 143(1) and (2) of , and paragraph 12 of Schedule 7A and paragraphs 1 and 8 of Schedule 11 to, the Local Government Finance Act 1988(1) and now vested in the National Assembly for Wales, and after consultation with the Council on Tribunals as required by section 8 of the Tribunals and Inquiries Act 1992(2):

Enwi, cymhwyso a chychwyn

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Ardrethu Annomestig (Newid Rhestri ac Apelau) (Cymru) (Diwygio) 2006 a deuant i rym ar 5 Ebrill 2006.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

Title, application and commencement

1.-(1) The title of these Regulations is the Non-Domestic Rating (Alteration of Lists and Appeals) (Wales) (Amendment) Regulations 2006 and they come into force on 5 April 2006.

(2) These Regulations apply in relation to Wales.

Dehongli

2.-(1) Diwygir Rheoliadau Ardrethu Annomestig (Newid Rhestri ac Apelau) (Cymru) 2005(3) fel a ganlyn.

(2) Yn rheoliad 8(3), ar ôl y geiriau "service on him", rhodder "or her".

Interpretation

2.-(1) The Non-Domestic Rating (Alteration of Lists and Appeals) (Wales) Regulations 2005(3) are amended as follows.

(2) In regulation 8(3), after the words "service on him", insert "or her".

(7) Yn rheoliad 31(4)(a) ar ôl y geiriau "to permit him", rhodder "or her".

(8) Yn rheoliad 33(4), yn lle'r geiriau "sent to him", rhodder "sent to that party".

(9) Dirymir rheoliad 43(1).

(3) In regulation 13(3), after the words "supplied to him", insert "or her".

(4) In regulation 25(7), for the words "paragraph 6(a)", substitute "paragraph (6)(a)".

(5) In regulation 26-

(a) for the words "a chairman appointed under regulation 8 of the Valuation and Community Charge Tribunals Regulations 1989", substitute "a chairperson of the relevant valuation tribunal"; and

(b) for the word "chairman's", substitute "chairperson's".

(6) In regulation 30(1), for the word "chairman", substitute "chairperson" in both places where it occurs.

(7) In regulation 31(4)(a), after the words "to permit him", insert "or her".

(8) In regulation 33(4), for the words "sent to him", substitute "sent to that party".

(9) Regulation 43(1) is revoked.
