Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) 1988 ("y prif Reoliadau") sy'n darparu ar gyfer peidio â chodi taliadau'r Gwasanaeth Iechyd Gwladol ("GIG") ac ar gyfer talu treuliau teithio mewn achosion penodol.

These Regulations further amend the National Health Service (Travelling Expenses and Remission of Charges) Regulations 1988 ("the principal Regulations") which provide for the remission of National Health Service ("NHS") charges and for the payment of travelling expenses in certain cases.

Mae gan rai personau hawl awtomatig i beidio â thalu taliadau'r GIG ac i gael taliadau am dreuliau teithio am eu bod yn cael budd-daliadau penodedig y wladwriaeth.

Some persons are automatically entitled to the remission of NHS charges and to the payment of travelling expenses because they are in receipt of specified state benefits.

Nid oes gan lawer o bersonau hawl awtomatig i beidio â thalu taliadau'r GIG ac i gael taliadau am dreuliau teithio. Mae'r prif Reoliadau'n cynnwys darpariaeth ar gyfer cyfrifo incwm, cyfalaf a gofynion hawlydd (a rhai ei deulu, pan fônt yn berthnasol). Gwneir y cyfrifiad hwn drwy gymhwyso darpariaethau wedi'u haddasu Rheoliadau Cymhorthdal Incwm (Cyffredinol) 1987 a nodir yn Atodlen 1 i'r prif Reoliadau.

Many persons are not automatically entitled to the remission of NHS charges and payment of travelling expenses; accordingly, the principal Regulations contain provision for a calculation of a claimant's income, capital and requirements (and of those of his or her family, where relevant). This calculation is made applying the modified provisions of the Income Support (General) Regulations 1987 that are set out in Schedule 1 to the principal Regulations.

Mae rheoliadau 2 a 3 yn diwygio Atodlen 1 i'r prif Reoliadau i gynyddu'r terfynau cyfalaf a ddefnyddir i gyfrifo'r hawl i beidio â thalu ac ad-dalu treuliau teithio.

Regulations 2 and 3 amend Schedule 1 to the principal Regulations to uprate the capital limits used in the calculation of entitlement to remission of charges and repayment of travelling expenses.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd gan adrannau 83A, 126(4) a 128(1) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977(1) drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred by sections 83A, 126(4) and 128(1) of the National Health Service Act 1977(1) hereby makes the following Regulations:

**Title, commencement, application and interpretation**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) (Diwygio) (Cymru) 2006, a deuant i rym ar 24 Mai 2006.

1.-(1) The title of these Regulations is the National Health Service (Travelling Expenses and Remission of Charges) (Amendment) (Wales) Regulations 2006 and they come into force on 24 May 2006.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(2) These Regulations apply in relation to Wales.

(3) Yn y Rheoliadau hyn, ystyr "y prif Reoliadau" (*"the principal Regulations"*) yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a

(3) In these Regulations, "the principal Regulations" (*"y prif Reoliadau"*) means the National Health Service (Travelling Expenses and Remission of Charges)
