EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Polisi Amaethyddol Cyffredin (Gwin) (Cymru) 2001 ("Rheoliadau 2001"), sy'n darparu ar gyfer gorfodi yng Nghymru Reoliadau'r Gymuned Ewropeaidd sy'n ymwneud â chynhyrchu a marchnata gwin a chynhyrchion perthynol.

These Regulations further amend the Common Agricultural Policy (Wine) (Wales) Regulations 2001 ("the 2001 Regulations"), which provide for the enforcement in Wales of European Community Regulations concerned with the production and marketing of wine and related products.

Mae'r Rheoliadau hyn—

These Regulations—

- (a) yn disodli cyfeiriadau at y Bwrdd Safonau Gwin â chyfeiriadau at yr Asiantaeth Safonau Bwyd (rheoliad 2(1) i (3)) a thrwy hynny roi cyfrifoldeb i'r Asiantaeth Safonau Bwyd dros y swyddogaethau gorfodi o dan Reoliadau 2001 a oedd gynt yn gyfrifoldeb ar y Bwrdd Safonau Gwin;
- (b) yn gwneud diwygiadau canlyniadol eraill sy'n codi o ganlyniad i'r newidiadau a wnaed mewn perthynas â'r swyddogaethau gorfodi hynny (rheoliad 2(4) a (6));
- (c) yn diweddarau'r diffiniad o "y Comisiynwyr" yn rheoliad 2(1) o Reoliadau 2001 ar ôl breinio'r swyddogaethau a oedd gynt yn arferadwy gan Gomisiynwyr y Tollau Tramor a Chartref yn y Comisiynwyr Cyllid a Thollau (rheoliad 2(5)(a));
- (ch) yn diweddarau cyfeiriadau at ddeddfwriaeth y Gymuned Ewropeaidd drwy wneud newidiadau i'r diffiniadau yn Rheoliadau 2001 (rheoliad 2(5)(b) ac (c)), rhoi Atodlen 1 newydd yn lle'r Atodlen 1 sydd yn Rheoliadau 2001 (rheoliad 2(7) ac Atodlen 1) a diweddarau Rhannau III a Rhan V o Atodlen 2 i Reoliadau 2001 (rheoliad 2(8)(a) a (b) ac Atodlen 2);

- (a) replace references to the Wine Standards Board with references to the Food Standards Agency (regulation 2(1) to (3)) thereby making the Food Standards Agency responsible for the enforcement functions under the 2001 Regulations that were previously the responsibility of the Wine Standards Board;
- (b) make other consequential amendments arising as a result of the changes made in relation to those enforcement functions (regulation 2(4) and (6));
- (c) update the definition of "the Commissioners" in regulation 2(1) of the 2001 Regulations following the vesting of functions previously exercisable by the Commissioners of Customs and Excise in the Commissioners for Revenue and Customs (regulation 2(5)(a));
- (d) update references to European Community legislation by making changes to the definitions in the 2001 Regulations (regulation 2(5)(b) and (c)), substituting a new Schedule 1 to the 2001 Regulations (regulation 2(7) and Schedule 1) and updating Parts III and Part V of Schedule 2 to the 2001 Regulations (regulation 2(8)(a) and (b) and Schedule 2);

- (d) yn sefydlu gweithdrefn newydd i adolygu gwaharddiadau etc ar symud cynhyrchion y sector gwin (rheoliad 2(7));
 - (dd) yn cywiro gwall yn eitem 12 o'r tabl a geir yn Rhan V o Atodlen 2 i Reoliadau 2001 (rheoliad 2(8)(c));
 - (e) yn ychwanegu Gamay a Gewurztraminer at y rhestr o amrywogaethau gwinwydd y caniateir eu defnyddio i gynhyrchu gwin yng Nghymru (rheoliad 2(9)); a
 - (f) yn cynnwys darpariaethau trosiannol (rheoliad 3).
- (e) put in place a different procedure for the review of prohibitions etc on the movement of wine-sector products (regulation 2(7));
 - (f) correct an error in item 12 of the table set out in Part V of Schedule 2 to the 2001 Regulations (regulation 2(8)(c));
 - (g) add Gamay and Gewurztraminer to the list of vine varieties that may be used in the production of wines in Wales (regulation 2(9)); and
 - (h) contain transitional provisions (regulation 3).

Mae Cynulliad Cenedlaethol Cymru, ac yntau wedi'i ddynodi(1) at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(2) o ran polisi amaethyddol cyffredin y Gymuned Ewropeaidd.

The National Assembly for Wales, being designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to the common agricultural policy of the European Community.

Cafwyd ymgynghori agored a thryloyw â'r cyhoedd yn ystod cyfnod paratoi'r Rheoliadau fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor(3) sy'n pennu egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn pennu gweithdrefnau o ran materion diogelwch bwyd, fel y'i diwygiwyd gan Reoliad (EC) Rhif 1642/2003 Senedd Ewrop a'r Cyngor(4).

There has been open and transparent public consultation during the preparation of the following Regulations as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(3) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety, as amended by Regulation (EC) No. 1642/2003 of the European Parliament and of the Council(4).

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Polisi Amaethyddol Cyffredin (Gwin) (Cymru) (Diwygio) 2006. Mae'r Rheoliadau hyn yn dod i rym ar 1 Gorffennaf 2006 ac maent yn gymwys o ran Cymru.

1.—(1) The title of these Regulations is the Common Agricultural Policy (Wine) (Wales) (Amendment) Regulations 2006. These Regulations come into force on 1 July 2006 and apply in relation to Wales.

(2) Yn y Rheoliadau hyn ystyr “y prif Reoliadau” (“*the principal Regulations*”) yw Rheoliadau'r Polisi Amaethyddol Cyffredin (Gwin) (Cymru) 2001(5).

Amendment of the 2001 Regulations

2.—(1) The 2001 Regulations are amended as follows.

(2) In each of the provisions specified in paragraph (3), for the words "Wine Standards Board", wherever occurring, substitute the word "Agency".

(3) The provisions referred to in paragraph (2) are—

- (a) the definition of "enforcement authority" ("*awdurdod gorfodi*") in regulation 2(1);
- (b) regulations 3(1), (3), and (4), 8(3) and 9(4) and
- (c) regulation 18 and in the Welsh text of that regulation substituting "ei ddynodi" for "ei dynodi".

(4) In regulation 2(1)—

(a) insert at the appropriate place the following definition—

"the Agency" ("*yr Asiantaeth*") means the Food Standards Agency;"; and

(b) omit the definition of "the Wine Standards Board".

(5) In regulation 2(1)—

(a) For the definition of "the Commissioners" ("*y Comisiynwyr*") substitute "the Commissioners" means the Commissioners for Revenue and Customs;";

(b) For the definition of "Council Regulation (EC) No 1493/1999" ("*Reoliad y Cyngor (EC) Rhif 1493/1999*") substitute "Council Regulation (EC) No. 1493/1999" means Council Regulation (EC) No. 1493/1999(1) on the common organisation of the market in wine, as last amended by Commission Regulation (EC) No. 1795/2003(2), and references in Schedules 2 and 5 to "Regulation 1493/1999" are to be construed accordingly;";

(c) Insert the following definitions in their appropriate alphabetical places—

“ystyr “Rheoliad y Cyngor (EEC) Rhif 2392/86” (“*Council Regulation (EEC) No. 2392/86*”) yw Rheoliad y Cyngor (EEC) Rhif 2392/86(1) sy’n sefydlu cofrestr o winllannoedd y Gymuned, fel y’i diwygiwyd ddiwethaf gan Reoliad y Cyngor (EC) Rhif 1631/98(2), ac mae’r cyfeiriad yn rhan VII o Atodlen 2 i “Reoliad 2392/86” i’w ddehongli yn unol â hynny;”.

(6) Yn rheoliad 3(5), hepgorer y geiriau “Bwrdd Safonau Gwin neu’r”

(7) Yn lle rheoliad 10, rhodder y rheoliad canlynol—

“Adolygu gwaharddiadau etc ar symud cynhyrchion y sector gwin

10.—(1) Mae’r rheoliad hwn yn gymwys pan fo un o swyddogion awdurdodedig yr Asiantaeth—

- (a) wedi rhoi hysbysiad o dan reoliad 8(2) (“hysbysiad rheoliad 8”); neu
- (b) wedi gwrthod rhoi cydsyniad i symud cynnyrch sector gwin a reolir o dan reoliad 9 (“gwrthodiad rheoliad 9”).

(2) Caiff person y rhoddwyd hysbysiad rheoliad 8 iddo, neu y gwrthodwyd cydsyniad iddo o dan reoliad 9, wneud cais am gael adolygiad o’r hysbysiad neu’r gwrthodiad.

(3) Mae cais a wneir gan berson o dan baragraff (2) i’w wneud i’r Asiantaeth cyn pen 6 mis ar ôl cael yr hysbysiad rheoliad 8 neu’r gwrthodiad rheoliad 9.

(4) Pan anfonir hysbysiad rheoliad 8 neu wrthodiad rheoliad 9 drwy’r post mewn amlen ragdaleidig ac arni’r cyfeiriad cywir, yna , oni phrofir y gwrthwyneb, bernir bod yr hysbysiad neu’r gwrthodiad, yn ôl y digwydd, wedi’i gael y diwrnod gwaith nesaf os bydd yn cael ei anfon drwy bost dosbarth cyntaf ac ar y diwrnod gwaith ar ôl hynny os anfonir ef drwy bost ail ddosbarth.

(5) Pan wneir cais am hynny o dan baragraff (2) cyn pen y cyfnod a bennir ym mharagraff (3)—

- (a) rhaid i’r Asiantaeth enwebu person o’r rhestr a sefydlir o dan baragraff (6) i benderfynu a ddylai’r hysbysiad rheoliad 8 neu’r gwrthodiad rheoliad 9, yn ôl y digwydd, sefyll;
- (b) rhaid i’r person a enwebir roi cyfle i’r person ac i’r Asiantaeth gyflwyno sylwadau ar y mater; ac
- (c) rhaid i’r person a enwebir, cyn pen mis ar ôl cael ei enwebu, benderfynu a ddylai’r hysbysiad rheoliad 8 neu’r gwrthodiad rheoliad 9 sefyll a rhaid iddo hysbysu’r ceisydd a’r Asiantaeth am ei benderfyniad.

““Council Regulation (EEC) No. 2392/86” (“*Rheoliad y Cyngor (EEC) Rhif 2392/86*”) means Council Regulation (EEC) No. 2392/86(1) establishing a Community vineyard register, as last amended by Council Regulation (EC) No. 1631/98(2), and the reference in Part VII of Schedule 2 to “Regulation 2392/86” is to be construed accordingly;”.

(6) In regulation 3(5), omit the words “the Wine Standards Board or”.

(7) Substitute regulation 10 with the following regulation—

“Review of prohibitions etc on movement of wine-sector products

10.—(1) This regulation applies where an authorised officer of the Agency—

- (a) has given a notice under regulation 8(2) (“a regulation 8 notice”); or
- (b) has refused to give consent to the movement of a controlled wine-sector product under regulation 9 (“a regulation 9 refusal”).

(2) A person to whom a regulation 8 notice has been given, or who has been refused consent under regulation 9, may request a review of the notice or the refusal.

(3) A request made by a person under paragraph (2) is to be made to the Agency within 6 months of the receipt of the regulation 8 notice or regulation 9 refusal.

(4) Where a regulation 8 notice or regulation 9 refusal is sent by post in a properly addressed, pre-paid envelope then, unless the contrary is proved, the notice or refusal, as the case may be, is deemed to have been received on the next working day where it is sent by first class post and on the next but one working day where it is sent by second class post.

(5) Where a request is made under paragraph (2) within the period specified in paragraph (3)—
