**Title, commencement and extent**

1.-(1) The title of this Order is the Local Health Boards (Establishment) (Wales) (Amendment) Order 2006 which comes into force on 6 July 2006.

(2) This Order applies in relation to Wales.

- (c) for "Rhondda Cynon Taff Local Health Board" (*"Bwrdd Iechyd Lleol Rhondda Cynon Taf"*) substitute "Rhondda Cynon Taff Teaching Local Health Board" (*"Bwrdd Addysgu Iechyd Lleol Rhondda Cynon Taf"*).
