Mae'r Gorchymyn hwn yn dirymu tri offeryn statudol ac yn diwygio offerynnau statudol eraill o ganlyniad i Ddeddf Ombwdsmon Gwasanaethau Cyhoeddus (Cymru) 2005 (2005 p.10) ("y Ddeddf"). Mae'r Gorchymyn hwn hefyd yn gwneud darpariaethau trosiannol mewn perthynas â swyddogaethau'r Comisiynydd Lleol yng Nghymru o dan Ran III o Ddeddf Llywodraeth Leol 2000 (p.22).

This Order revokes three statutory instruments and amends others in consequence of the Public Services Ombudsman (Wales) Act 2005 (2005 c.10) ("the Act"). This Order also makes transitional provisions in respect of the functions of the Local Commissioner in Wales under Part III of the Local Government Act 2000 (c.22).

Mae'r Ddeddf yn sefydlu swydd Ombwdsmon Gwasanaethau Cyhoeddus Cymru ("yr Ombwdsmon"). Mae'r Ddeddf yn diddymu swyddi Ombwdsmon Gweinyddiaeth Cymru, Comisiynydd Gwasanaeth Iechyd Cymru ac Ombwdsmon Tai Cymdeithasol Cymru. Mae hefyd yn diddymu'r Comisiwn dros Weinyddu Lleol yng Nghymru (gan gynnwys swydd y Comisiynydd Lleol yng Nghymru). Yn fras, mae'r Ddeddf yn gwneud darpariaeth i'r Ombwdsmon ymchwilio i'r materion hynny a oedd o fewn cylch gwaith yr ombwdsmon a'r comisiynwyr hynny yng Nghymru.

The Act establishes the office of the Public Services Ombudsman for Wales ("the Ombudsman"). The Act abolishes the offices of the Welsh Administration Ombudsman, the Health Service Commissioner for Wales and the Social Housing Ombudsman for Wales. It also abolishes the Commission for Local Administration in Wales (including the office of the Local Commissioner for Wales). Broadly speaking, the Act makes provision for the Ombudsman to investigate those matters that were within the remit of those ombudsmen and commissioners in Wales.

The Ombudsman will have responsibility for investigating maladministration and service failure by the National Assembly for Wales; its sponsored public bodies (the equivalent, in Wales, of non-departmental public bodies) and a number of other publicly funded bodies; Welsh health service bodies (primarily NHS Trusts and Local Health Boards in Wales); certain health service providers in Wales; local government

Coming into force 1 April 2006

The National Assembly for Wales, in exercise of powers conferred on it by sections 43(1) and (2) and 44(1) of the Public Services Ombudsman (Wales) Act 2005(1) hereby makes the following Order:

Title, commencement, application and interpretation

1.-(1) The title of this Order is the Public Services Ombudsman (Wales) Act 2005 (Transitional Provisions and Consequential Amendments) Order 2006 and it shall come into force on 1 April 2006.

(2) This Order applies in relation to Wales.

(3) In this Order-

"the Act" ("*y Ddeddf*") means the Public Services Ombudsman (Wales) Act 2005;

"co-opted member" ("*aelod cyfetholedig*") means, in relation to a relevant authority, a person who is not a member of the authority but who-

(a) is a member of any committee or sub-committee of the authority, or

(b) is a member of, and represents the authority on, any joint committee or joint sub-committee of the authority,

and who is entitled to vote on any question which falls to be decided at any meeting of that committee or sub-committee; and

4.-(1) Mae paragraff (2) yn gymwys os-

- (a) oes honiad wedi cael ei wneud i Gomisiynydd Lleol yng Nghymru o dan adran 69 Deddf Llywodraeth Leol 2000(3) cyn y dyddiad y daw adran 38 o'r Ddeddf i rym, a
- (b) nad yw'r honiad wedi cael ei benderfynu gan y Comisiynydd hwnnw cyn y dyddiad hwnnw.

(2) Ar y dyddiad y daw adran 38 o'r Ddeddf i rym ac ar ôl hynny, mae Rhan III o Ddeddf Llywodraeth Leol 2000 a rheoliadau a gorchmynion a wnaed oddi tani yn parhau i fod yn gymwys at ddibenion yr honiad er gwaethaf darpariaethau'r Ddeddf neu'r Gorchmyn hwn.

(3) Mae paragraff (4) yn gymwys os-

- (a) galesid (heblaw am ddarpariaethau'r Ddeddf) bod wedi gwneud honiad i Gomisiynydd Lleol yng Nghymru, a
- (b) yw'r honiad yn honiad bod aelod neu aelod cyfetholedig (neu gyn aelod neu gyn aelod cyfetholedig) o awdurdod perthnasol yng Nghymru wedi methu neu y gall fod wedi methu â chydymffurfio â chod ymddygiad yr awdurdod cyn y dyddiad y daw adran 38 o'r Ddeddf i rym.

(4) Ar y dyddiad y daw adran 38 o'r Ddeddf i rym ac ar ôl hynny, mae Rhan III o Ddeddf Llywodraeth Leol 2000(4) a rheoliadau a gorchmynion a wnaed oddi tani yn parhau i fod yn gymwys at ddibenion galluogi i'r honiad gael ei wneud, ac at ddibenion yr honiad os y'i gwneir, er gwaethaf darpariaethau'r Ddeddf neu'r Gorchmyn hwn.

"relevant authority" ("*awdurdod perthnasol*") means a county council, a county borough council, a National Park authority established under section 63 of the Environment Act 1995(1) or a fire and rescue authority constituted by a scheme under section 2 of the Fire and Rescue Services Act 2004(2) or a scheme to which section 4 of that Act applies.

Revocation and amendment of subordinate legislation

2. The subordinate legislation referred to in Schedule 1 is revoked.

3. Schedule 2 contains amendments to subordinate legislation.

Transitional provisions

4.-(1) Paragraph (2) applies if-

- (a) an allegation has been made to a Local Commissioner in Wales under section 69 of the Local Government Act 2000(3) before the date on which section 38 of the Act comes into force, and
- (b) the allegation has not been determined by that Commissioner before that date.

(2) On and after the date on which section 38 of the Act comes into force, Part III of the Local Government Act 2000 and regulations and orders made thereunder continue to apply for the purposes of the allegation despite the provisions of the Act or this Order.

(3) Paragraph (4) applies if-

- (a) an allegation could (but for the provisions of the Act) have been made to a Local Commissioner in Wales, and
- (b) the allegation is an allegation that a member or co-opted member (or former member or co-opted member) of a relevant authority in Wales has failed or may have failed to comply with the authority's code of conduct before the date on which section 38 of the Act comes into force.

(4) On and after the date on which section 38 of the Act comes into force, Part III of the Local Government Act 2000(4) and regulations and orders made thereunder continue to apply for the purposes of enabling the allegation to be made, and for the purposes of the allegation if made, despite the provisions of the Act or this Order.
