EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Yn ôl adrannau 5 (1) a (2) o Ddeddf Lles Anifeiliaid 2006 (p.45) ("y Ddeddf") tramgwydd yw gwneud y canlynol i anifeiliaid sy'n cael eu gwarchod o dan y Ddeddf honno:

It is an offence under section 5(1) and (2) of the Animal Welfare Act 2006 (c.45) ("the Act") to do the following to animals protected by that Act:

- (a) rhoi triniaeth waharddedig;
- (b) peri rhoi triniaeth waharddedig; neu
- (c) o dan amgylchiadau penodedig, ganiatáu i berson arall roi triniaeth waharddedig.

- (a) carry out a prohibited procedure;
- (b) cause the carrying out of a prohibited procedure; or
- (c) in specified circumstances, permit another person to carry out a prohibited procedure .

Ystyr "rhoi triniaeth waharddedig" yw gwneud rhywbeth sy'n cynnwys ymyrryd â meinweoedd sensitif (e.e. croen) neu strwythur esgyrn yr anifail heblaw at ei drin yn feddygol (gweler adran 5(3) o'r Ddeddf).

A prohibited procedure is one which involves interference with the sensitive tissues (e.g. skin) or bone structure of the animal, otherwise than for the purpose of its medical treatment (see section 5(3) of the Act).

Mae'r Rheoliadau hyn yn pennu'r triniaethau nad ydynt yn dramgwyddau yn ôl adran 5(1) a 5(2). Gan ddibynnu ar yr anifeiliaid y mae'r triniaethau i'w rhoi iddynt, caiff y triniaethau hynny gynnwys triniaethau at:

These Regulations specify the procedures to which the offences in section 5(1) and 5(2) do not apply. Depending upon the animals to which they are to be applied, such procedures may include those for the purposes of:

- (a) adnabod yr anifeiliaid (fel tagiau clust);
- (b) rheoli atghenhedlu (fel ysbaddu, cyweirio neu dorri ar anifail, a fasdoriad (hynny yw, fasetomi)); ac
- (c) triniaethau at ddibenion eraill (fel laparosgopi) (*Atodlen 1*).

- (a) identification (such as ear tagging);
- (b) the control of reproduction (such as castration and vasectomy); and
- (c) other purposes (such as laparoscopy) (Schedule 1).

Am rai o'r triniaethau hyn, ac unwaith eto gan ddiwynnu ar yr anifeiliaid y mae caniatâd i'w rhoi iddynt, mae Atodlenni 2 i 9 yn gosod cyfyngiadau ar roi'r driniaeth (fel pennu oedran y mae'n rhaid i'r anifail fod ynddo, neu bennu bod rhaid rhoi anesthetig).

O ran triniaethau penodol y caniateir eu rhoi i foch, mae'r Rheoliadau hyn yn gweithredu paragraff 8 o Bennod I o'r Atodiad i Gyfarwyddeb y Cyngor 91/630/EEC sy'n gosod y safonau gofynnol ar gyfer gwarchod moch (OJ Rhif L340, 11.12.1991, t.33), fel y'i diwygiwyd gan Gyfarwyddeb y Cyngor 2001/88/EC, OJ Rhif L316, 1.12.2001, t.1), Cyfarwyddeb y Comisiwn 2001/93/EC (OJ Rhif L316, 1.12.2001, t.36) a Rheoliad y Cyngor (EC) Rhif 806/2003 (OJ Rhif L122, 16.5.2003, t.1). O ran tocio pig ieir dodwy, mae'r Rheoliadau hyn yn gweithredu paragraff 8 o'r Atodiad i Gyfarwyddeb y Cyngor 1999/74/EC sy'n gosod y safonau gofynnol ar gyfer gwarchod ieir dodwy (OJ Rhif L203, 3.8.1999, p.53, fel y'i diwygiwyd ddiwethaf gan Reoliad y Cyngor (EC) Rhif 806/2003 (OJ Rhif L122, 16.5.2003, t.1).

Mae arfarniad rheoliadol wedi'i baratoi. Gellir cael copïau ohono oddi wrth Swyddfa'r Prif Swyddog Milfeddygol, Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd CF10 3NQ.

For certain of these procedures, and again depending upon the animals in respect of which they are permitted, Schedules 2 to 9 apply restrictions to the carrying out of the procedure (such as specifying a required age for the animal, or requiring the administration of an anaesthetic).

In respect of certain procedures permitted to be applied to pigs, these Regulations implement paragraph 8 of Chapter I of the Annex to Council Directive 91/630/EEC laying down minimum standards for the protection of pigs (OJ No. L340, 11.12.1991, p.33), as amended by Council Directive 2001/88/EC (OJ No. L316, 1.12.2001, p.1), Commission Directive 2001/93/EC (OJ No. L316, 1.12.2001, p.36) and Council Regulation (EC) No. 806/2003 (OJ No. L122, 16.5.2003, p.1). In respect of the beak trimming of laying hens, these Regulations implement paragraph 8 of the Annex to Council Directive 1999/74/EC laying down minimum standards for the protection of laying hens (OJ No. L203, 3.8.1999, p.53), as amended by Council Regulation (EC) No. 806/2003 (OJ No. L122, 16.5.2003, p.1).

Mae Cynulliad Cenedlaethol Cymru, sef o ran Cymru, yr awdurdod cenedlaethol priodol at ddibenion arfer y pwerau a roddwyd gan 5(4) o Ddeddf Lles Anifeiliaid 2006(1), yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau hynny.

The National Assembly for Wales being, in relation to Wales, the appropriate national authority for the purpose of exercising the powers conferred by section 5(4) of the Animal Welfare Act 2006(1), makes the following Regulations in exercise of those powers.

Yn unol ag adran 5(5) o'r Ddeddf honno, mae'r Cynulliad wedi ymgynghori â'r personau hynny sydd yn ei farn ef yn briodol am eu bod yn cynrychioli buddiannau y mae a wnelo'r Rheoliadau hyn â hwy.

In accordance with section 5(5) of that Act, the Assembly has consulted those persons appearing to it to represent interests with which these Regulations are concerned as it considered appropriate.

Enwi, cychwyn a chymhwyso

1. Enw'r Rheoliadau hyn yw Rheoliadau Anffurfio (Triniaethau a Ganiateir) (Cymru) 2007. Maent yn gymwys i Gymru a deuant i rym ar 28 Mawrth 2007.

Title, commencement and application

1. The title of these Regulations is the Mutilations (Permitted Procedures) (Wales) Regulations 2007. They apply in relation to Wales and come into force on 28 March 2007.

Dehongli

2. Yn y Rheoliadau hyn-

ystyr "a ffermir" ("*farmed*") yw, o ran anifail, a fegir neu a gedwir at gynhyrchu bwyd, gwlan neu groen neu at ddibenion ffermio eraill;

mae "ceffylau" ("*horses*") yn cynnwys merlod, asynnod, a mulod;

ystyr "dadimpio" ("*disbudding*") yw tynnu impiadau cyrn gwartheg, geifr neu ddefaid;

ystyr "dofednod" ("*poultry*") yw ffowls domestig, tyrcwn, gwyddau, hwyaid, ieir gini, soffieir, ffesantod a phetrisod;

Interpretation

2. In these Regulations-

"the Act" ("*y Ddeddf*") means the Animal Welfare Act 2006;

"cattle" ("*gwartheg*") means all animals of the bovine species including bison and buffalo;

"desnooding" ("*torri crogrib*") means removal of a turkey's snood;

"disbudding" ("*dadimpio*") means removal of the horn bud of cattle, goats or sheep;

ystyr "y Ddeddf" ("*the Act*") yw Deddf Lles Anifeiliaid 2006;

ystyr "ffowlyn domestig" ("*domestic fowl*") yw aelod dof o'r rhywogaeth *Gallus gallus*;

ystyr "gwartheg" ("*cattle*") yw pob anifail o'r rhywogaeth fuchol gan gynnwys bison a byfflo;

ystyr "triniaeth waharddedig" ("*prohibited procedure*") yw triniaeth sy'n cynnwys ymyrryd â meinweoedd sensitif neu strwythur esgryn yr anifail heblaw at ddibenion ei drin yn feddygol;

ystyr "iâr ddodwy" ("*laying hen*") yw iâr o'r rhywogaeth *Gallus gallus* sydd wedi cyrraedd aeddfedrwydd dodwy ac sy'n cael ei chadw i gynhyrchu wyau na fwriedir iddynt ddeor;

ystyr "offeryn addas" ("*suitable instrument*") yw, o ran unrhyw driniaeth, offeryn sydd mewn cyflwr da ac sydd wedi'i ddylunio at roi'r driniaeth honno neu a ddefnyddir yn gyffredin at roi'r driniaeth honno;

ystyr "torri crib" ("*dubbing*") yw tynnu crib ffowlyn domestig;

ystyr "torri crogrib" ("*desnooding*") yw tynnu crogrib twrci;

ystyr "yn bwrw eu melfed" ("*in velvet*") yw o ran cynn carw, y broses sy'n cynnwys y melfed yn raffio hyd nes i'r rhan fwyaf ohono gael ei fwrw.

"domestic fowl" ("*ffowlyn domestig*") means a domesticated member of the species *Gallus gallus*;

"dubbing" ("*torri crib*") means removal of the comb of a domestic fowl;

"farmed" ("*a ffermir*") means an animal bred or kept for the production of food, wool or skin or for other farming purposes;

"horses" ("*ceffylau*") includes ponies, asses, donkeys, jennets and mules;

"in velvet" ("*yn bwrw eu melfed*") means, in relation to the antlers of a deer, until the velvet is frayed and the greater part of it has been shed;

"laying hen" ("*iâr ddodwy*") means a hen of the species *Gallus gallus* which has reached laying maturity and is kept for production of eggs not intended for hatching;

"poultry" ("*dofednod*") means domestic fowl, turkeys, geese, ducks, guinea fowl, quails, pheasants and partridges;

"prohibited procedure" ("*triniaeth waharddedig*") means a procedure which involves interference with the sensitive tissues or bone structure of an animal, otherwise than for the purpose of its medical treatment;

"suitable instrument" ("*offeryn addas*") means in relation to any procedure, an instrument that is in a fit state of repair and has been designed, or is of a kind commonly used, for the purpose of performing that procedure.

Eithriadau i'r gwaharddiad ar anffurfio

3. Nid yw adran 5(1) a (2) o'r Ddeddf yn gymwys i driniaeth a restrir yn Atodlen 1, ar yr amod y rhoddir y driniaeth-

- (a) yn unol ag unrhyw ofyniad perthnasol yn Atodlenni 2 i 9;
- (b) mewn dull sy'n cadw lefel y boen a'r dioddefaint i'r anifail i leiafswm;
- (c) mewn amgylchiadau hylan; ac
- (ch) yn unol ag arferion da.

Cyfalwmi triniaethau gwaharddedig mewn argyfwng

4.-(1) Nid yw adran 5(1) a (2) o'r Ddeddf yn gymwys pan fo triniaeth waharddedig yn cael ei rhoi mewn argyfwng er mwyn arbed bywyd yr anifail a warchodir(1) neu er mwyn lledfu ei boen.

(2) Rhaid i unrhyw driniaeth a roddir o dan baragraff (1) gael ei rhoi yn unol â rheoliad 3, i'r graddau y mae'n ymarferol o dan yr holl amgylchiadau.

Exceptions to the prohibition on mutilations

3. Section 5(1) and (2) of the Act does not apply to a procedure listed in Schedule 1, providing that the procedure is carried out-

- (a) in accordance with any relevant requirement in Schedules 2 to 9;
- (b) in such a way as to minimise the pain and suffering it causes to the animal;
- (c) in hygienic conditions; and
- (d) in accordance with good practice.

Performance of prohibited procedures in an emergency

4.-(1) Section 5(1) and (2) of the Act does not apply where a prohibited procedure is carried out in an emergency for the purpose of saving the life or relieving the pain of the protected animal(1).

(2) Any procedure carried out under paragraph (1) must be carried out in accordance with regulation 3, so far as this is practicable in all of the circumstances.

(2) Nid yw'r cyfyngiad ym mharagraff (1) yn gymwys i-

- (a) tocio cynffonnau, neu
- (b) ysbaddu

Persons who may carry out permitted procedures

5.-(1) Any procedure permitted under regulation 3 may only be carried out by a veterinary surgeon or any other person permitted to carry out that procedure under the Veterinary Surgeons Act 1966(1) or the Veterinary Surgeons (Exemptions) Order 1962(2).

(2) The restriction in paragraph (1) does not apply to-

- (a) tail docking, or
- (b) castration

of pigs aged not more than 7 days.
