1. Mae'r Rheoliadau hyn yn diwygio Rheoliadau Strategaethau Iechyd, Gofal Cymdeithasol a Llesiant (Cymru) 2003 (O.S. 2003/154 (Cy.24)) ("y prif Reoliadau").

1. These Regulations amend the Health, Social Care and Well-being Strategies (Wales) Regulations 2003 (S.I. 2003/154 (W.24)) ("the principal Regulations").

2. Mae'r Rheoliadau hyn-

2. These Regulations-

- (a) yn diwygio rheoliad 2 o'r prif Reoliadau drwy ddileu'r cyfeiriad at "Awdurdod Iechyd" yn y diffiniad o "corff GIG" (rheoliad 2(2));
- (b) yn diwygio rheoliad 4 o'r prif Reoliadau drwy ddileu'r angen i gyrff cyfrifol ymgynghori cyn llunio eu strategaethau (rheoliad 2(3));
- (c) yn ehangu rheoliad 5(2)(dd)(v) o'r prif Reoliadau i gynnwys yr angen i'r strategaeth fynd i'r afael ag anghydraddoldebau sy'n ymwneud ag anabledd, hil, rhyw, iaith, oedran, cyfeiriadedd rhywiol, crefydd a chred (rheoliad 2(4));
- (ch) yn diwygio rheoliad 6 o'r prif Reoliadau i ddileu'r gofynion a fyddai'n cael eu gosod ar gyrff cyfrifol pe baent yn bwriadu peidio ag ymrwymo i drefniadau comisiynu (rheoliad 2(5));

- (a) amend regulation 2(i) of the principal Regulations by removing Health Authority from the definition of "NHS Body" (regulation 2(2));
- (b) amend regulation 4 of the principal Regulations to remove the need for responsible bodies to consult before formulating their strategies (regulation 2(3));
- (c) extend regulation 5(2)(f)(v) of the principal Regulations to include the need for the strategy to address inequalities relating to disability, race, gender, language, age, sexual orientation, religion and belief (regulation 2(4));
- (d) amend regulation 6 of the principal Regulations to remove requirements placed on responsible bodies in the event of them proposing not to enter into commissioning arrangements (regulation 2(5));

(d) yn diwygio rheoliad 7 o'r prif Reoliadau i gynnwys yn rheoliad 7(1) gynlluniau a wneir o dan adran 26 o Ddeddf Plant 2004; rhoi yn lle'r cyfeiriad yn rheoliad 7(1)(c) at adran 28 o Ddeddf Iechyd 1999 gyfeiriad at adran 17 o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006 a dileu'r gofyniad yn rheoliadau 7(2), 7(4) a 7(5) i gyhoeddi cynlluniau a restrir yn rheoliad 7(1) fel rhan o'r strategaeth (rheoliad 2(6));

(dd) yn diwygio rheoliad 10 o'r prif Reoliadau i leihau'r cyfnod gweithredol ar gyfer pob strategaeth i 3 blynedd (rheoliad 2(7)).

**3.** Mae Arfarniad Rheoliadol am yr effaith a gaiff y Rheoliadau hyn ar gostau busnes wedi'i baratoi a'i osod yn Llyfrgell Cynulliad Cenedlaethol Cymru. Gellir cael copiâu ohono oddi wrth yr Uned Strategaeth, yr Adran Iechyd a Gwasanaethau Cymdeithasol, Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

(e) amend regulation 7 of the principal Regulations to include in regulation 7(1) plans made under section 26 of the Children Act 2004; replace the reference in regulation 7(1)(c) to section 28 of the Health Act 1999 with section 17 of the National Health Service (Wales) Act 2006 and to remove the requirement in regulations 7(2), 7(4) and 7(5) to publish plans listed in regulation 7(1) as part of the strategy (regulation 2(6));

(f) amend regulation 10 of the principal Regulations to reduce the operative period for each strategy to 3 years (regulation 2(7)).

The National Assembly for Wales, in exercise of the powers conferred by section 40(4), (5), (6) and (9) and section 203(2) of the National Health Service (Wales) Act 2006(1), makes the following Regulations-

**Enwi, dehongli a chychwyn****Title, interpretation and commencement**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Strategaethau Iechyd, Gofal Cymdeithasol a Llesiant (Cymru) (Diwygio) 2007.

1.-(1) The title of these Regulations is the Health, Social Care and Well-being Strategies (Wales) (Amendment) Regulations 2007.

(2) Daw'r Rheoliadau hyn i rym ar 1 Ebrill 2007.

(2) These regulations come into force on 1 April 2007.

(3) Yn y Rheoliadau hyn ystyr "y prif Reoliadau" (*the principal Regulations*) yw Rheoliadau Strategaethau Iechyd, Gofal Cymdeithasol a Llesiant (Cymru) 2003(2).

(3) In these Regulations "the principal Regulations" (*the principal Regulations*) means the Health, Social Care and Well-being Strategies (Wales) Regulations 2003(2).

**Diwygio'r prif Reoliadau****Amendment of the principal regulations**

2.-(1) Mae'r prif Reoliadau yn cael eu diwygio'n unol â darpariaethau canlynol y rheoliad hwn.

2.-(1) The principal Regulations are amended in accordance with the following provisions of this regulation.

(2) Yn rheoliad 2(b), hepgorer y geiriau "Awdurdod Iechyd" lle maent yn ymddangos y tro cyntaf.

(2) In regulation 2(i), omit the words "Health Authority" where they first occur.

(3) Yn rheoliad 4(3), hepgorer yr holl eiriau hyd at ddiwedd y paragraff hwnnw ar ôl y geiriau "rhaid i'r cyrff cyfrifol gydweithredu â'r personau neu'r cyrff a restrir yn rheoliad 3(1)".

(3) In regulation 4(3), omit all the words to the end of that paragraph after the words "the responsible bodies shall co-operate with the persons or bodies listed in regulation 3(1)".

(1) 2006 p.42. Mae cyfeiriadau yn y Ddeddf at y term "Welsh Ministers" i gael eu heffaith tan ddiwedd y cyfnod cychwynnol, o fewn ystyr y term hwnnw yn Neddf Llywodraeth Cymru 2006 (p.32), fel cyfeiriadau at Gynulliad Cenedlaethol Cymru, a gyfansoddiwyd gan Ddeddf Llywodraeth Cymru 1998 (p.38), yn rhinwedd adran 5 o Ddeddf y Gwasanaeth Iechyd Gwladol (Darpariaethau Canlyniadol) 2006 (p.43) a pharagraff 10 o Atodlen 3 iddi.

(1) 2006 c.42. References in the Act to "Welsh Ministers" are to have effect until the end of the initial period, within the meaning of the Government of Wales Act 2006 (c.32), as references to the National Assembly for Wales, constituted by the Government of Wales Act 1998 (c.38), by virtue of section 5 of and paragraph 10 of Schedule 3 to the National Health Service (Consequential Provisions) Act 2006 (c.43).

(2) O.S. 2003/154 (Cy.24).

(2) S.I. 2003/154 (W.24).

(4) Yn rheoliad 5(2)(dd)(v), ar ôl y gair "llesiant" mewnosoder y geiriau "gan gynnwys anghydraddoldebau sy'n ymwneud â hil, anabledd, rhyw, iaith, oedran, cyfeiriadedd rhywiol a chrefydd a chred".

(5) Yn rheoliad 6, hepgorer paragraffau (2) a (3).

(6) Mae rheoliad 7 yn cael ei ddiwygio'n unol â'r darpariaethau canlynol:

- (a) ar ôl paragraff (1)(a), mewnosoder yr is-baragraff canlynol "(aa) cynlluniau plant a pobl ifanc o dan adran 26(1) o Ddeddf Plant 2004";
- (b) ym mharagraff (1)(c), yn lle'r geiriau "adran 28 o Ddeddf Iechyd 1999" rhodder "adran 17 o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006";
- (c) ym mharagraff (2), hepgorer yr holl eiriau hyd at ddiwedd y paragraff hwnnw ar ôl y geiriau "cynlluniau a restrir ym mharagraff (1) uchod";
- (ch) ym mharagraff (4), hepgorer yr holl eiriau hyd at ddiwedd y paragraff ar ôl y geiriau "fel rhan o'u dyletswydd i baratoi strategaeth";
- (d) ym mharagraff (5), hepgorer yr holl eiriau hyd at ddiwedd y paragraff ar ôl y geiriau "fel rhan o'u dyletswydd i baratoi strategaeth".

(7) Yn rheoliad 10(4), rhodder y ffigur "3" yn lle'r ffigur "5".

(4) In Regulation 5(2)(f)(v), after the words "well-being," insert the words "including inequalities which relate to race, disability, gender, language, age, sexual orientation and religion and belief".

(5) In regulation 6, omit paragraphs (2) and (3).

(6) Regulation 7 is amended in accordance with the following provisions:

- (a) after paragraph (1)(a), insert the following subparagraph "(aa) children and young people's plans under section 26(1) of the Children Act 2004";
- (b) in paragraph (1)(c), replace the words "section 28 of the Health Act 1999" with "section 17 of the National Health Service (Wales) Act 2006";
- (c) in paragraph (2), omit all the words to the end of that paragraph after the words "the plans listed in (1) above" ;
- (d) in paragraph (4), omit all the words to the end of the paragraph after the words "as part of their duty to prepare a strategy";
- (e) in paragraph (5), omit all the words to the end of the paragraph after the words "as part of their duty to prepare a strategy".

(7) In regulation 10(4), substitute the figure "3" for the figure "5".
