EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau.)

1. Mae'r Rheoliadau hyn yn diwygio Rheoliadau Ychwanegion Bwyd (Cymru) 2003 sy'n gweithredu yng Nghymru Gyfarwyddeb 2002/46/EC Senedd Ewrop a'r Cyngor ar gyd-ddynesiad cyfreithiau'r Aelod-wladwriaethau ar atchwanegiadau bwyd (OJ Rhif L183, 12.7.2002, t.51). Mae'r Rheoliadau hyn yn gweithredu yng Nghymru Gyfarwyddeb y Comisiwn 2006/37/EC (OJ Rhif L94, 1.4.2006, t.32) sy'n diwygio Atodiad II i Gyfarwyddeb 2002/46/EC o ran cynnwys sylweddau penodol.

1. These Regulations amend the Food Supplements (Wales) Regulations 2003 which implement in Wales Directive 2002/46/EC of the European Parliament and of the Council on the approximation of the laws of the Member States relating to food supplements (OJ No. L183, 12.7.2002, p.51). These Regulations implement in Wales Commission Directive 2006 / 37 /EC (OJ No. L 94, 1.4.2006, p.32) amending Annex II to Directive 2002/46/EC as regards the inclusion of certain substances.

2. Mae Rheoliadau 2003 yn gwahardd gwerthu atchwanegiad bwyd y defnyddiwyd fitamin neu fwyn wrth ei gynhyrchu oni bai i'r fitamin hwnnw neu i'r mwyn hwnnw gael ei restru yn Atodlen 1 i'r Rheoliadau hynny ac oni bai ei fod ar ffurf a restrir yn Atodlen 2 (y rhestrri cadarnhaol), yn ddarostyngedig i ddarpariaeth drosiannol (rheoliad 5 ac Atodlenni i'r Rheoliadau hynny).

2. The 2003 Regulations prohibit the sale of a food supplement in the manufacture of which a vitamin or mineral has been used unless that vitamin or mineral is listed in Schedule 1 to those Regulations and is in a form listed in Schedule 2 (the positive lists), subject to a transitional provision (regulation 5 and Schedules to those Regulations).

3. Mae'r Rheoliadau hyn-

3. These Regulations-

- (a) yn ychwanegu ffurf arall ar y fitamin ffolad a ffurf arall ar y mwyn haearn at y rhestr gadarnhaol yn Atodlen 2 yn Rheoliadau 2003 (rheoliad 5) ac yn gwneud diwygiad canlyniadol (rheoliad 4);
- (b) yn diweddarau'r diffiniad o "Cyfarwyddeb 2002/46/EC" yn Rheoliadau 2003 (rheoliad 3).

- (a) add another form of the vitamin folate and another form of the mineral iron to the positive list in Schedule 2 to the 2003 Regulations (regulation 5) and make a consequential amendment (regulation 4);
- (b) update the definition of "Directive 2002/46/EC" in the 2003 Regulations (regulation 3).

4. Mae arfarniad rheoliadol wedi'i baratoi ar gyfer y Rheoliadau hyn a'i roi yn Llyfrgell Cynulliad Cenedlaethol Cymru ynghyd â Nodyn Trosi sy'n nodi sut y mae prif elfennau Cyfarwyddeb 2006/37/EC yn cael eu trosi yn y Rheoliadau hyn. Gellir cael copïau gan yr Asiantaeth Safonau Bwyd, Llawr 11, Southgate House, Caerdydd, CF10 1EW.

4. Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd gan adrannau 16(1)(a) ac (e), 17(1), 26(1)(a) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1) ac sydd bellach wedi'u breinio ynddo(2), ac wedi rhoi sylw yn unol ag adran 48(4A) o'r Ddeddf honno, i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd ac ar ôl ymgynghoriad cyhoeddus agored a thryloyw wrth lunio'r Rheoliadau fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor(3) sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd, yn gwneud y Rheoliadau canlynol.

The National Assembly for Wales, in exercise of the powers conferred by sections 16(1)(a) and (e), 17(1), 26(1)(a) and (3) and 48(1) of the Food Safety Act 1990(1) and now vested in it(2), having had regard, in accordance with section 48(4A) of that Act, to relevant advice given by the Food Standards Agency, and after open and transparent public consultation during the preparation of the Regulations as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(3) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety, makes the following Regulations.

Enwi, cychwyn a chymhwysu

1. Enw'r Rheoliadau hyn yw Rheoliadau Atchwanegiadau Bwyd (Cymru) (Diwygio) 2007, deuant i rym ar 6 Ebrill 2007 ac maent yn gymwys o ran Cymru.

Title, commencement and application

1. The title of these Regulations is the Food Supplements (Wales) (Amendment) Regulations 2007, they will come into force on 6 April 2007 and apply in relation to Wales.

2. Diwygir Rheoliadau Ychwanegion Bwyd (Cymru) 2003(1) diwygio yn unol â rheoliadau 3 i 5.

3. Yn rheoliad 2(1) (dehongli) yn y diffiniad o "Cyfarwyddeb 2002/46" mewnosoder ar y diwedd ", fel y'i diwygiwyd gan Gyfarwyddeb y Comisiwn 2006/37/EC(2) sy'n diwygio Atodiad II i Gyfarwyddeb 2002/46/EC Senedd Ewrop a'r Cyngor o ran cynnwys sylweddau penodol".

4. Yn Atodlen 1 (fitaminau a mwynau y caniateir eu defnyddio wrth gynhyrchu ychwanegion bwyd), yn Adran 1 (fitaminau), yn lle "Asid ffolig" rhodder "Ffolad".

5. Yn Atodlen 2 (ffurf ar sylweddau fitamin a mwyn y caniateir eu defnyddio wrth gynhyrchu ychwanegion bwyd)-

- (a) yn adran A (fitaminau), yn eitem 10 yn lle'r pennawd "ASID FFOLIG" rhodder "FFOLAD", ac o dan y pennawd (diwygiedig) hwnnw rhodder ar y diwedd "(b) calsiwm L-methylffolad";
- (b) yn adran B (mwynau) o flaen "Carbonad cwprig" mewnosoder "Bisglycinad fferus".

Llofnodwyd ar ran Cynulliad Cenedlaethol Cymru o dan adran 66(1) o Ddeddf Llywodraeth Cymru 1998(3).

Amendment of the Food Supplements (Wales) Regulations 2003

2. The Food Supplements (Wales) Regulations 2003(1) are amended in accordance with regulations 3 to 5.

3. In regulation 2(1) (interpretation), in the definition of "Directive 2002/46" insert at the end ", as amended by Commission Directive 2006/37/EC(2) amending Annex II to Directive 2002/46/EC of the European Parliament and of the Council as regards the inclusion of certain substances".

4. In Schedule 1 (vitamins and minerals which may be used in the manufacture of food supplements), in Section 1 (vitamins), for "Folic acid" substitute "Folate".

5. In Schedule 2 (form of vitamin and mineral substances which may be used in the manufacture of food supplements)-

- (a) in section A (vitamins), at item 10 for the heading "FOLIC ACID" substitute "FOLATE", and under that (revised) heading insert at the end "(b) calcium-L-methylfolate";
- (b) in section B (minerals) before "Cupric carbonate" insert "Ferrous bisglycinate".
