Mae'r Rheoliadau hyn yn diwygio Rheoliadau Anifeiliaid a Chynhyrchion Anifeiliaid (Mewnforio ac Allforio) (Cymru) 2006 (O.S. 2006/1536 (Cy. 153)) ("y prif Reoliadau").

These Regulations amend the Animals and Animal Products (Import and Export) (Wales) Regulations 2006 (S.I. 2006/1536 (W. 153)) ("the principal Regulations").

Mae rheoliad 2 yn diwygio rheoliad 16(4) o'r prif Reoliadau er mwyn rhoi effaith i'r estyniad tan 1 Gorffennaf 2007 ar waharddiad cyfredol yr Undeb Ewropeaidd ar fewnforio adar caeth o'r tu allan i'r Undeb Ewropeaidd. Darperir ar gyfer y gwaharddiad gan ddeddfwriaeth y Gymuned o dan Benderfyniad y Comisiwn 2005/760/EC ynghylch mesurau diogelu penodol o ran fflw adar pathogenig iawn mewn trydydd gwledydd penodol ar gyfer mewnforio adar caeth (OJ Rhif L285, 28.10.2005, t. 52), fel y'i diwygiwyd, yn benodol gan Benderfyniad y Comisiwn 2005/862/EC, a chan Benderfyniad y Comisiwn dyddiedig 23 Mawrth 2007 (OJ Rhif L84, 24.03.2007, t.44), sy'n rhoi effaith i estyniad pellach ar y gwaharddiad.

Regulation 2 amends regulation 16(4) of the principal Regulations so as to give effect to the extension until 1 July 2007 of the current European Union ban on the import of captive birds from outside the European Union. The ban is provided for in Community legislation under Commission Decision 2005/760/EC concerning certain protection measures in relation to highly pathogenic avian influenza in certain third countries for the import of captive birds (OJ No. L285, 28.10.2005, p. 52), as amended, in particular by Commission Decision 2005/862/EC, and by Commission Decision of 23 March 2007 (OJ No. L84, 24.03.2007, p.44), which gives effect to the further extension of the ban.

Mae rheoliadau 3 a 4 yn dirymu diwygiadau cynharach i'r prif Reoliadau a oedd yn rhoi effaith i estyniadau blaenorol ar y gwaharddiad i fewnforio.

Regulations 3 and 4 revoke earlier amendments to the principal Regulations which gave effect to previous extensions of the import ban.

The National Assembly for Wales is designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to the common agricultural policy of the European Community.

The National Assembly for Wales makes these Regulations in exercise of the powers conferred on it by that section:

1.-(1) The title of these Regulations is the Animals and Animal Products (Import and Export) (Wales) (Imports of Captive Birds) Regulations 2007.

(2) These Regulations apply in relation to Wales and come into force on 1 April 2007.

2. In regulation 16(4) of the Animals and Animal Products (Import and Export) (Wales) Regulations 2006(3), for "1 April 2007" substitute "1 July 2007".

3. Regulation 2(3) of the Animals and Animal Products (Import and Export) (Wales) (Amendment) Regulations 2006(4) is revoked.
