1. Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn diwygio Rheoliadau Bwyd at Ddefnydd Maethol Neilltuol (Ychwanegu Sylweddau at Ddibenion Maethol Penodol) (Cymru) 2002 fel y'i diwygiwyd ("y prif Reoliadau").

2. Mae'r Rheoliadau hyn yn rhoi ar waith Gyfarwyddeb y Comisiwn 2006/34/EC (OJ Rhif L83, 22.3.2006, t.14) sy'n diwygio'r Atodiad i Gyfarwyddeb 2001/15/EC o ran cynnwys sylweddau penodol.

3. Mae'r prif Reoliadau yn gymwys i fwyd ar gyfer y rhan fwyaf o ffyrdd penodol o'i ddefnyddio'n faethol (ceir diffiniad o "bwyd DMN dynodedig" yn rheoliad 2(1) o'r Rheoliadau hynny). Mae'r Rheoliadau hynny yn cyfyngu ar werthu bwydydd o'r fath pan fo sylwedd sy'n cwympo o fewn un o'r chwe categori canlynol wedi cael ei ychwanegu ato at ddiben maethol penodol: fitaminau; mwynau; asidau amino; carnitin a thawrin; niwcetolitau; colin ac inositol. Mewn achos o'r fath rhaid i'r sylwedd fod wedi'i restru o dan y categori perthnasol yn Atodlen 1 neu, yn achos bwydydd at ddibenion meddygol arbennig, yn Atodlen 1 neu 2. Mae yna randdirymiad ag iddo derfyn amser yn achos sylweddau a restrir yn Atodlen 3 (rheoliad 3(5) o'r Rheoliadau hynny).

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

1. These Regulations, which apply in relation to Wales, amend the Food for Particular Nutritional Uses (Addition of Substances for Specific Nutritional Purposes) (Wales) Regulations 2002 as amended ("the principal Regulations").

2. These Regulations implement Commission Directive 2006/34/EC (OJ No. L83, 22.3.2006, p.14) amending the Annex to Directive 2001/15/EC as regards the inclusion of certain substances.

3. The principal Regulations apply to food for most particular nutritional uses (definition of "designated PNU food" in regulation 2(1) of those Regulations). Those Regulations restrict the sale of such food where there has been added to it for a specific nutritional purpose a substance falling within one of the following six categories: vitamins; minerals; amino acids; carnitine and taurine; nucleotides; choline and inositol. In such a case the substance must be listed under the relevant category in Schedule 1 or, as regards foods for special medical purposes, Schedule 1 or 2. There is a time-limited derogation as respects substances listed in Schedule 3 (regulation 3(5) of those Regulations).

4. Mae'r Rheoliadau hyn-

- (a) yn ychwanegu sylweddau penodol at y rhestr yn y categoriâu fitaminau a mwynau y ceir eu hychwanegu at ddibenion maethol penodol at fwydydd DMN dynodedig (heb unrhyw derfyn amser) (rheoliad 4);
- (b) yn ychwanegu sylwedd yn y categori mwynau at y rhestr o sylweddau y ceir eu hychwanegu at ddibenion maethol penodol at fwydydd at ddibenion meddygol arbennig (heb unrhyw derfyn amser) (rheoliad 5);
- (c) yn diweddu'r diffiniad o "Cyfarwyddeb 2001/15" (rheoliad 3).

5. Mae'r Rheoliadau hyn hefyd diwygio Rheoliadau Hysbysiadau o Farchnata Bwyd at Ddibenion Maethol Penodol (Cymru a Lloegr) 2002 i'r graddau y maent yn gymwys o ran Cymru er mwyn dileu geiriau dianghenraíd o reoliad 6 o'r Rheoliadau hynny (rheoliad 6).

6. Mae arfarniad rheoliadol wedi'i baratoi ar gyfer y Rheoliadau hyn ac wedi'i roi yn llyfrgell Cynulliad Cenedlaethol Cymru, ynghyd â chopi o'r nodyn trosi sy'n ymwnaed â'r Rheoliadau hyn. Gellir hefyd gael copiâu oddi wrth yr Asiantaeth Safonau Bwyd, Llawr 11, Southgate House Caerdydd CF10 1EW.

4. These Regulations-

- (a) add certain substances to the list in the categories of vitamins and minerals which may be added for specific nutritional purposes in designated PNU foods (without any time limit) (regulation 4);
- (b) add a substance in the minerals category to the list of substances which may be added for specific nutritional purposes in foods for special medical purposes (without any time limit) (regulation 5);
- (c) update the definition of "Directive 2001/15" (regulation 3).

5. These Regulations also amend the Notification of Marketing of Food for Particular Nutritional Uses (England and Wales) Regulations 2002 in so far as they apply in relation to Wales to remove unnecessary wording from regulation 6 of those Regulations (regulation 6).

6. A full regulatory appraisal has been prepared for these Regulations and has been placed in the Library of the National Assembly for Wales along with a copy of the transposition note relating to these Regulations. Copies are also available from the Food Standards Agency, 11th Floor, Southgate House, Cardiff CF10 1EW.

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by sections 16(1)(f), 17(1), 26(3) and 48(1) of the Food Safety Act 1990(1) and now vested in it(2).

The National Assembly for Wales has had regard to relevant advice given by the Food Standards Agency as required by section 48(4A) of that Act.

There has been open and transparent public consultation during the preparation of the Regulations as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3).

2. Diwygir y prif Reoliadau yn unol â rheoliadau 3 i 5.

3. Yn rheoliad 2(1) (dehongli), yn y diffiniad o "Cyfarwyddeb 2001/15", ar ôl "Cyfarwyddeb 2004/5/EC" mewnosoder "a Chyfarwyddeb y Comisiwn 2006/34/EC(2)".

4. Yn Atodlen 1 (sylweddau y ceir eu hychwanegu at ddibenion maethol penodol at fwyd DMN dynodedig)-

- (a) yn yr Adran sy'n ymwneud â Chategori 1 (fitaminau), yn lle'r pennawd "FOLIC ACID" rhodder "FOLATE", ac o dan y pennawd (diwygiedig) hwnnw mewnosoder ar y diwedd "- calcium-L-methylfolate";
- (b) yn yr Adran sy'n ymwneud â Chategori 2 (mwynau), o dan y pennawd "IRON" mewnosoder ar y diwedd "- ferrous bisglycinate".

5. Yn Atodlen 2 (sylweddau ychwanegol y ceir eu hychwanegu at ddibenion maethol penodol at fwydydd at ddibenion meddygol arbennig) mewnosoder ar y dechrau-

Title, commencement, application and interpretation

1.-(1) The title of these Regulations is the Food for Particular Nutritional Uses (Addition of Substances for Specific Nutritional Purposes) (Wales) (Amendment) Regulations 2007.

(2) These Regulations come into force on 25 January 2007.

(3) These Regulations apply in relation to Wales.

(4) In these Regulations "the principal Regulations" means the Food for Particular Nutritional Uses (Addition of Substances for Specific Nutritional Purposes) (Wales) Regulations 2002(1).

Amendment of the principal Regulations

2. The principal Regulations are amended in accordance with regulations 3 to 5.

3. In regulation 2(1) (interpretation), in the definition of "Directive 2001/15", after "Directive 2004/5/EC" insert "and Commission Directive 2006/34/EC(2)".

4. In Schedule 1 (substances which may be added for specific nutritional purposes in designated PNU foods)-

- (a) in the Section concerning Category 1 (vitamins), for the heading "FOLIC ACID" substitute "FOLATE", and under that (revised) heading insert at the end "- calcium-L-methylfolate";
- (b) in the Section concerning Category 2 (minerals), under the heading "IRON" insert at the end "- ferrous bisglycinate".

5. In Schedule 2 (additional substances which may be added for specific nutritional purposes in foods for special medical purposes) insert at the beginning-

"Category 2. Minerals

magnesium L-aspartate".
