Mae'r Rheoliadau hyn yn diwygio Rheoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) 2006 er mwyn codi'r ffi sy'n daladwy gan ymgwymerwyr am arolygiadau o'u gwaith gan awdurdodau stryd yng Nghymru o dan reoliad 3 o'r Rheoliadau hynny.

These Regulations amend the Street Works (Inspection Fees) (Wales) Regulations 2006 so as to increase the fee payable by undertakers for inspections of their work by street authorities in Wales under regulation 3 of those Regulations.

Mae'r ffi am arolygiadau o'r fath, a newidiwyd ddiwethaf yn Ebrill 2004, yn codi o 14.3% o £21 i £24.

The fee for such inspections, which was last altered in April 2004, is increased by 14.3% from £21 to £24.

Cafodd Asesiad Effaith Rheoliadol ei baratoi ynglŷn â'r rheoliadau hyn. Mae hwn ar gael i'w archwilio yn swyddfeydd Trafnidiaeth Cymru, Llywodraeth Cynulliad Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 75 a 104(1) o Ddeddf Ffyrdd Newydd a Gwaith Stryd 1991(1), ac a freiniwyd ynddynt hwy bellach (2), drwy hyn yn gwneud y rheoliadau a ganlyn:

The Welsh Ministers, in exercise of the powers conferred on the Secretary of State by sections 75 and 104(1) of the New Roads and Street Works Act 1991(1), and now vested in them(2), make the following regulations:

**Enwi, cychwyn a chymhwyso**

1. Enw'r Rheoliadau hyn yw Rheoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) (Diwygio) 2007. Deuant i rym ar 10 Gorffennaf 2007 ac maent yn gymwys o ran Cymru.

**Title, commencement and application**

1. The title of these Regulations is the Street Works (Inspection Fees) (Wales) (Amendment) Regulations 2007. They come into force on 10 July 2007 and apply in relation to Wales.

**Rhagarweiniol**

2. Diwygir Rheoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) 2006(3) fel a ganlyn.

**Preliminary**

2. The Street Works (Inspection Fees) (Wales) Regulations 2006(3) are amended as follows.

**Diwygio rheoliad 3 (ffioedd arolygu)**

3. Yn rheoliad 3, ym mharagraffau (1) ac (8), yn lle "£21.00" rhodder "£24.00".

**Amendment to regulation 3 (inspection fees)**

3. In regulation 3, in paragraphs (1) and (8), for "£21.00" substitute "£24.00".

(2) Cafodd swyddogaethau'r Ysgrifennydd Gwladol o dan adrannau 75 a 104(1) eu trosglwyddo, i'r graddau y maent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672), erthygl 2 ac Atodlen 1. Amnewidiwyd adran 75 yn rhagolygol gan adran 58(2) o Ddeddf Rheoli Traffig 2004 (p.18). Cafodd swyddogaethau Cynulliad Cenedlaethol Cymru o dan yr adrannau 75 a 104(1) dywededig eu trosglwyddo i Weinidogion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006.

(2) The functions of the Secretary of State under sections 75 and 104(1) were transferred, so far as exercisable in relation to Wales, to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672), article 2 and Schedule 1. Section 75 is prospectively substituted by section 58(2) of the Traffic Management Act 2004 (c.18). The functions of the National Assembly for Wales under the said sections 75 and 104(1) were transferred to the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006.
