EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Iechyd Planhigion (Ffioedd Arolygu Mewnforio) (Cymru) (Rhif 2) 2006 (O.S. 2006/2832 (Cy. 253)) ("y prif Reoliadau"). Mae'r prif Reoliadau yn rhoi ar waith Erthygl 13d o Gyfarwyddeb y Cyngor 2000/29/EC (OJ Rhif L 169, 10.7.00, t. 1), sy'n ei gwneud yn ofynnol i Aelod-wladwriaethau godi ffioedd i dalu'r costau sy'n digwydd oherwydd gwiriadau dogfennol, gwiriadau adnabod a gwiriadau iechyd planhigion ar fewnforion penodol o ran planhigion, cynhyrchion planhigion a phethau eraill o drydydd gwledydd.

These Regulations amend the Plant Health (Import Inspection Fees) (Wales) (No.2) Regulations 2006 (S.I. 2006/2832 (W. 253)) ("the principal Regulations"). The principal Regulations implement Article 13d of Council Directive 2000/29/EC (OJ No. L 169, 10.7.00, p. 1), which requires member States to charge fees to cover the costs occasioned by the documentary checks, identity checks and plant health checks of certain imports of plants, plant products and other objects from third countries.

Mae Atodlen 2 i'r prif Reoliadau yn cynnwys darpariaeth am gyfraddau gostyngol ar gyfer planhigion penodol a chynhyrchion planhigion penodol a'r rheini'n gyfraddau y cytunwyd arnynt o dan y weithdrefn y darperir ar ei chyfer yn Erthyglau 13d(2) a 18(2) o'r Gyfarwyddeb. Mae'r Rheoliadau hyn yn rhoi Atodlen 2 newydd i'r prif Reoliadau yn lle'r hen un, i roi ei effaith i'r cytundeb diweddaraf mewn perthynas â ffioedd cyfradd ostyngol.

Schedule 2 to the principal Regulations includes provision for reduced rates for certain plants and plant products agreed under the procedure provided for in Articles 13d(2) and 18(2) of the Directive. These Regulations substitute a new Schedule 2 to the principal Regulations, to give effect to the latest agreement in respect of reduced rate fees.

The Welsh Ministers, with the consent of the Treasury, make the following Regulations in exercise of the powers conferred by section 56(1) of the Finance Act 1973(1) and now vested in them:

Title, commencement and application

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Iechyd Planhigion (Ffioedd Arolygu Mewnforio) (Cymru) (Diwygio) 2007.

1.-(1) The title of these Regulations is the Plant Health (Import Inspection Fees) (Wales) (Amendment) Regulations 2007.

(2) Daw'r Rheoliadau hyn i rym ar 13 Gorffennaf 2007 ac maent yn gymwys o ran Cymru.

(2) These Regulations come into force on 13 July 2007 and apply in relation to Wales.

Amendment of the Plant Health (Import Inspection Fees) (Wales) (No.2) Regulations 2006

2.-(1) Diwygir Rheoliadau Iechyd Planhigion (Ffioedd Arolygu Mewnforio) (Cymru) (Rhif 2) 2006(2) fel a ganlyn.

2.-(1) The Plant Health (Import Inspection Fees) (Wales) (No. 2) Regulations 2006(2) are amended as follows.

(2) Yn Atodlen 1, mewnosoder ", neu ran o hynny" ar ôl y geiriau canlynol bob tro y maent yn ymddangos: "am bob 100 o unedau ychwanegol", "am bob 1,000 o unedau ychwanegol", "am bob 10 kg ychwanegol", "am bob 100 kg ychwanegol", "am bob 1,000 kg ychwanegol" ac "am bob 25,000 kg ychwanegol".

(2) In Schedule 1, insert ", or part thereof" after the following words each time they appear: "for each additional 100 units", "for each additional 1,000 units", "for each additional 10kg", "for each additional 100kg", "for each additional 1,000kg" and "for each additional 25,000kg".
