Mae'r Rheoliadau hyn yn diwygio Rheoliadau Iechyd Planhigion (Ffioedd Arolygu Mewnforio) (Cymru) (Rhif 2) 2006 (O.S. 2006/2832 (Cy.253)) ("y prif Reoliadau"). Mae'r prif Reoliadau yn rhoi ar waith Erthygl 13d o Gyfarwyddeb y Cyngor 2000/29/EC (OJ Rhif L 169, 10.7.00, t. 1), sy'n ei gwneud yn ofynnol i Aelod-wladwriaethau godi ffioedd i dalu'r costau sy'n digwydd oherwydd gwiriadau dogfennol, gwiriadau adnabod a gwiriadau iechyd planhigion ar fewnforion penodol o ran planhigion, cynhyrchion planhigion a phethau eraill o drydydd gwledydd.

These Regulations amend the Plant Health (Import Inspection Fees) (Wales) (No. 2) Regulations 2006 (S.I. 2006/2832 (W.253)) ("the principal Regulations"). The principal Regulations implement Article 13d of Council Directive 2000/29/EC (OJ No. L 169, 10.7.00, p. 1), which requires Member States to charge fees to cover the costs occasioned by the documentary checks, identity checks and plant health checks of certain imports of plants, plant products and other objects from third countries.

Mae'r Rheoliadau hyn: (a) yn ymestyn cymhwysiad y prif Reoliadau at lwythi sydd wedi'u ffurfio o nwyddau sy'n tramwy o fewn y Gymuned Ewropeaidd y cytunodd Gweinidogion Cymru gyda chorff swyddogol pwynt mynediad y nwyddau hyn yn unol â Gorchymyn Iechyd Planhigion (Cymru) 2006 (O.S. 2006/1643 (Cy.158)), y byddent hwy, Gweinidogion Cymru, yn gyfrifol am faterion penodol; a (b) yn gosod Atodlen 2 newydd yn lle'r un bresennol yn y prif Reoliadau, i roi eu heffaith i'r cyfraddau gostyngol diweddaraf y cytunwyd arnynt ar gyfer arolygiadau o ddeunydd penodol. (Mae Atodlen 2 i'r prif Reoliadau yn cynnwys darpariaeth am gyfraddau gostyngol ar gyfer planhigion penodol a chynhyrchion planhigion penodol a'r rheini'n gyfraddau y cytunwyd arnynt o dan y weithdrefn y darperir ar ei chyfer yn Erthyglau 13d(2) a 18(2) o'r Gyfarwyddeb.) These Regulations: (a) extend the application of the principal Regulations to consignments consisting of goods in transit within the European Community in respect of which the Welsh Ministers have agreed with the official body of point of entry for those goods, in accordance with the Plant Health (Wales) Order 2006 (S.I. 2006/1643 (W.158)), that they the Welsh Ministers would be responsible for certain matters; and (b) substitute a new Schedule 2 instead of the current one in the principal Regulations, to give effect to the latest agreed reduced rates for inspections of certain material. (Schedule 2 to the principal Regulations includes provision for reduced rates for certain plants and plant products agreed under the procedure provided for in Articles 13d(2) and 18(2) of the Directive.) The changes to the fees made by these Regulations, which are set at a proportion of the standard fee (described in Schedule 1 to the principal Regulations) corresponding to the rate of inspection,
