EXPLANATORY NOTE

1. Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn gweithredu Cyfarwyddeb y Comisiwn 2006/33/EC sy'n diwygio Cyfarwyddeb 95/45/EC ynglŷn â'r lliwiau melyn y machlud FCF (E110) a thitaniwm deuocsid (E171) (OJ Rhif L82, 21.3.2006, t.10).

1. These Regulations, which apply in relation to Wales, implement Commission Directive 2006/33/EC amending Directive 95/45/EC as regards sunset yellow FCF (E110) and titanium dioxide (E171) (OJ No. L82, 21.3.2006, p.10).

2. Maent yn gwneud hyn drwy ddiweddarau'r diffiniad o "Directive 95/45/EC" (Cyfarwyddeb y Comisiwn 95/45/EC sy'n gosod meini prawf purdeb penodol sy'n ymwneud â lliwiau sydd i'w defnyddio mewn bwydydd, OJ Rhif L226, 29.9.1995, t.1) sy'n ymddangos yn rheoliad 2(1) o Rheoliadau Lliwiau mewn Bwyd 1995 (O.S. 1995/3124, fel y'i diwygiwyd eisoes) i adlewyrchu'r diwygiadau a wnaed i'r Gyfarwyddeb honno gan Gyfarwyddeb y Comisiwn 2006/33/EC (*rheoliad 2*).

2. They do so by updating the definition of "Directive 95/45/EC" (Commission Directive 95/45/EC laying down specific criteria of purity concerning colours for use in foodstuffs, OJ No. L226, 29.9.1995, p.1) that appears in regulation 2(1) of the Colours in Food Regulations 1995 (S.I. 1995/3124, as already amended) to reflect the amendments made to that Directive by Commission Directive 2006/33/EC (*regulation 2*).

3. Mae Cyfarwyddeb y Comisiwn 2006/33/EC yn diwygio Cyfarwyddeb y Comisiwn 95/45/EC drwy roi meini prawf purdeb diwygiedig ar gyfer lliwiau melyn y machlud FCF (E110) a thitaniwm deuocsid (E171).

3. Commission Directive 2006/33/EC amends Commission Directive 95/45/EC by substituting revised purity criteria for the colours sunset yellow FCF (E110) and titanium dioxide (E171).

4. Ni luniwyd Arfarniad Rheoliadol llawn ar gyfer yr offeryn hwn, gan na ragwelir unrhyw effaith ar y sectorau preifat na gwirfoddol.

4. A full Regulatory Appraisal has not been produced for this instrument as no impact on the private or voluntary sectors is foreseen.

5. Mae Nodyn Trosi sy'n nodi sut y mae prif elfennau'r ddeddfwriaeth Ewropeaidd y cyfeirir ati uchod yn cael eu trosi yn y Rheoliadau hyn wedi'i baratoi a'i osod yn Llyfrgell Cynulliad Cenedlaethol Cymru. Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 16(1)(a), 17(1), 26(1) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990 a pharagraff 1 o Atodlen 1 iddi(1) ac sydd bellach wedi'u breinio ynddo ef(2).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by sections 16(1) (a), 17(1), 26(1) and (3) and 48(1) of, and paragraph 1 of Schedule 1 to, the Food Safety Act 1990(1) and now vested in it(2).

Yn unol ag adran 48(4A) o'r Ddeddf honno, mae wedi rhoi ystyriaeth i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd.

In accordance with section 48 (4A) of that Act, it has had regard to relevant advice given by the Food Standards Agency.

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(3) cafwyd ymgynghoriad cyhoeddus agored a thryloyw tra bu'r Rheoliadau canlynol yn cael eu llunio.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3) there has been open and transparent public consultation during the preparation of the following Regulations.

Title, application and commencement

1. The title of these Regulations is the Colours in Food (Amendment) (Wales) Regulations 2007, which apply in relation to Wales and which come into force on 10 April 2007.

Amendment of the Colours in Food Regulations 1995

2.-(1) The Colours in Food Regulations 1995(1) are amended in so far as they apply in relation to Wales in accordance with paragraph (2).

(2) In paragraph (1) of regulation 2 (interpretation), for the definition of "Directive 95/45/EC" there is substituted the following definition -

""Directive 95/45/EC" means Commission Directive 95/45/EC laying down specific criteria of purity concerning colours for use in foodstuffs(2) as amended by Directive 1999/75/EC(3), Directive 2001/50/EC(4), Directive 2004/47/EC(5) and Directive 2006/33/EC(6);".
