**Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau
Teithio a Pheidio â Chodi Tâl) (Cymru) (Diwygio) 2008**

Addasu'r Rheoliadau Cymhorthdal Incwm yn Atodlen 1 i'r prif Reoliadau

2.—(1) Mae Atodlen 1 i'r prif Reoliadau (Addasu Rheoliadau Cymhorthdal Incwm (Cyffredinol) 1987) wedi'i diwygio fel a ganlyn.

(2) Yn Nhabl A, yn lle'r addasiad i reoliad 45 o'r Rheoliadau Cymhorthdal Incwm (Terfyn Cyfalaf), rhodder—

“Yn lle'r rheoliad hwn rhodder—

“Capital Limit

45 For the purposes of regulations 5(2)(e) and 6(1)(a) of the National Health Service (Travelling Expenses and Remission of Charges) (Wales) Regulations 2007 the capital limit is—

- (a) for a claimant permanently residing in accommodation as defined in regulation 19A— £22,000;
- (b) in any other case—£16,000.””.

(3) Yn Nhabl A, yn yr addasiad i reoliad 53 o'r Rheoliadau Cymhorthdal Incwm, yn lle “(a) until 8 April 2007 £16,000; (b) from 9 April 2007 £17,250” rhodder “£19,000”.

(4) Yn Nhabl A, yn yr addasiadau i reoliad 66A o'r Rheoliadau Cymhorthdal Incwm (trin benthyciadau i fyfyrwyr), yn lle'r cofnod cyntaf, rhodder—

“Yn lle paragraff (1), rhodder—

“(1) A student loan must be treated as income unless it is—

- (a) a hardship loan; or
- (b) an additional loan, as described in the Guide to Student Support issued by the Student Awards Agency for Scotland 2007-2008(1), paid pursuant to an application for a loan under regulation 5(1) or (9) of the Education (Student Loans) (Scotland) Regulations 2007 (applications for loans)(2),

in which case it will be disregarded.””.

(5) Yn Nhabl A, yn yr addasiadau i Atodlen 9 i'r Rheoliadau Cymhorthdal Incwm (symiau i'w diystyru wrth gyfrifo incwm heblaw enillion) yn lle'r cofnod cyntaf rhodder—

“Ym mharagraff 15(1) yn lle “sub-paragraph (3)” rhodder “sub-paragraphs (1A), (1B) and (3)”.

Mewnosoder ar ôl paragraff 15(1)—

“(1A) In respect of a voluntary payment made to a student, sub-paragraph (1) will only apply to £20 of that payment.
