This Order provides for the transfer of staff from North East Wales National Health Service Trust to the North Wales National Health Service Trust from the 1 July 2008.

This Order also provides for the transfer of all property, rights and liabilities of the North East Wales National Health Service Trust to be transferred to the North Wales National Health Service Trust on 1 July 2008.

Mae Gweinidogion Cymru drwy arfer y pwerau a roddwyd gan adran 203(9) a (10) o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006 a pharagraff 29 o Atodlen 3 iddi(1) ac ar ôl cwblhau'r ymgynghori statudol fel y'i rhagnodwyd o dan baragraff 29(4) o Atodlen 3 i'r Ddeddf honno(2), drwy hyn yn gwneud y Gorchymyn hwn.

The Welsh Ministers in exercise of powers conferred by section 203(9) and (10) and paragraph 29 of Schedule 3 to the National Health Service (Wales) Act 2006(1); after completion of statutory consultation as prescribed under paragraph 29(4) of that Act(2), hereby make this Order.

**Enwi, cychwyn a dehongli**

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gogledd-ddwyrain Cymru (Trosglwyddo Staff, Eiddo, Hawliau a Rhwymedigaethau) 2008 a daw i rym ar 1 Gorffennaf 2008.

(2) Yn y Gorchymyn hwn, onid yw'r cyd-destun yn mynnu fel arall:

ystyr "y dyddiad trosglwyddo" ("*the transfer date*") "yw 1 Gorffennaf 2008;

ystyr "yr hen ymddiriedolaeth" ("*the old trust*") yw Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gogledd-ddwyrain Cymru a sefydlwyd ar 4 Ionawr 1999;

ystyr "yr ymddiriedolaeth newydd" ("*the new trust*") yw Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gogledd Cymru a sefydlwyd ar 25 Mehefin 2008.

**Title, Commencement and Interpretation**

1.—(1) The title of this Order is the North East Wales National Health Service Trust (Transfer of Staff, Property, Rights and Liabilities) Order 2008 and it comes into force on 1 July 2008.

(2) In this Order, unless the context otherwise requires:

"the new trust" ("*yr ymddiriedolaeth newydd*") means the North Wales National Health Service Trust established on 25 June 2008.

"the old trust" ("*yr hen ymddiriedolaeth*") means North East Wales National Health Service Trust established on 4 January 1999

"the transfer date" ("*y dyddiad trosglwyddo*") means the 1 July 2008;

### **Trosglwyddo cyflogaeth i'r trosglwyddai**

2.—(1) Yn ddarostyngedig i baragraff (3), trosglwyddir contract cyflogaeth unrhyw berson a oedd yn union cyn y dyddiad trosglwyddo yn cael ei gyflogi gan yr hen ymddiriedolaeth i'r ymddiriedolaeth newydd ar y dyddiad trosglwyddo a bydd y contract hwnnw'n effeithiol fel pe bai wedi'i wneud yn wreiddiol rhwng y person a gyflogir felly a'r ymddiriedolaeth newydd.

(2) Heb ragfarnu paragraff (1) uchod—

- (a) yn rhinwedd yr erthygl hon, trosglwyddir yr holl hawliau, pwerau, dyletswyddau a rhwymedigaethau o dan contract neu mewn cysylltiad â contract y mae'r paragraff hwnnw'n gymwys iddo i'r ymddiriedolaeth newydd ar y dyddiad trosglwyddo;
- (b) bernir bod unrhyw beth a wnaed cyn y dyddiad hwnnw gan yr hen ymddiriedolaeth neu mewn perthynas â hi ynglŷn â'r contract hwnnw neu'r cyflogai hwnnw, o'r dyddiad trosglwyddo ymlaen wedi'i wneud gan yr ymddiriedolaeth newydd neu mewn perthynas â hi.

(3) Nid yw paragraffau (2) a (3) uchod yn rhagfarnu unrhyw hawl sydd gan unrhyw gyflogai i derfynu ei contract cyflogaeth os gwneir newid sylweddol er niwed i'r cyflogai yn ei amodau gwaith, ond ni fydd unrhyw hawl o'r fath yn codi yn unig oherwydd y newid mewn cyflogwr a bernir gan yr erthygl hon.

### **Trosglwyddo eiddo, hawliau a rhwymedigaethau**

3. Ar y dyddiad trosglwyddo trosglwyddir holl eiddo, hawliau a rhwymedigaethau'r hen ymddiriedolaeth, sydd heb eu crybwyll yn erthygl 2 uchod, i'r ymddiriedolaeth newydd gan gynnwys heb gyfyngiad—

- (a) y ddyletswydd i baratoi'r cyfrifon sydd heb eu cwblhau gan yr hen ymddiriedolaeth a chyflawni'r holl ddyletswyddau statudol mewn perthynas â'r cyfrifon hynny;
- (b) eiddo ymddiriedol yr hen ymddiriedolaeth a restrir yn Atodlen 1.
- (c) elusennau'r hen ymddiriedolaeth a restrir yn Atodlen 2.

### **Trosglwyddo swyddogaethau'r hen ymddiriedolaeth i'r ymddiriedolaeth newydd**

4. Trosglwyddir holl swyddogaethau'r hen ymddiriedolaeth i'r ymddiriedolaeth newydd a byddant yn cael effaith o'r dyddiad trosglwyddo ymlaen.

### **Transfer of employees to the transferee**

2.—(1) Subject to paragraph (3), any person who immediately before the transfer date, was employed by the old trust shall have their contract of employment transferred to the new trust on the transfer date and that contract will have effect as if originally made between the person so employed and the new trust.

(2) Without prejudice to paragraph (1) above —

- (a) all the rights, powers, duties and liabilities under or in connection with a contract to which that paragraph applies will, by virtue of this article, be transferred to the new trust on the transfer date;
- (b) anything done before that date by, or in relation to, the old trust in respect of that contract or that employee, will be deemed from the transfer date to have been done by, or in relation to, the new trust.

(3) Paragraphs (1) and (2) are without prejudice to any right of any employee to terminate his or her contract of employment if a substantial change is made to his or her detriment in his or her working conditions, but no such right shall arise by reason only of the change in employer effected by this article.

### **Transfer of property, rights and liabilities**

3. On the transfer date all the property, rights and liabilities of the old trust, not referred to in article 2 above, shall be transferred to the new trust, including without limitation—

- (a) the duty to prepare the outstanding accounts of the old trust and to perform all statutory duties relating to those accounts;
- (b) the trust property of the old trust listed in Schedule 1;
- (c) the charities of the old trust listed in Schedule 2.

### **Transfer of functions of the old trust to the new trust**

4. With effect from the transfer date, all the functions of the old trust are transferred to the new trust.
