Coming into force

1 October 2009

The Welsh Ministers, in exercise of powers conferred on them by sections 18(1) and 204(1) of the National Health Service (Wales) Act 2006(1(1)), after completion of the consultation prescribed under section 18(3) of that Act, make the following Order:

Title, commencement and interpretation

1–(1) The title of this Order is the Velindre National Health Service Trust (Establishment) (Amendment) Order 2009 and it comes into force on 1 October 2009.

(2) In this Order, “the principal Order” (“*y prif Orchymyn*”) means the Velindre National Health Service Trust (Establishment) Order 1993(2).

Amendment of article 3 of the principal Order

2. Article 3(2)(d) of the principal Order is omitted.
