Mae Rheoliadau 2001 yn gwneud darpariaeth ynghylch swyddogaethau disgyblu Cyngor Addysgu Cyffredinol Cymru.

Effaith y diwygiad a'r dirymiad yw bod swyddogaethau Pwyllgor Ymchwilio sy'n perthyn i Gyngor Addysgu Cyffredinol Cymru yn cael eu gwahardd os yw Gweinidogion Cymru neu'r Ysgrifennydd Gwladol yn dymuno ystyried achos gyda'r bwriad o arfer pwerau o dan adran 142 o Ddeddf Addysg 2002, neu os yw'r Bwrdd Gwahardd Annibynnol wedi cynnwys neu'n dymuno ystyried cynnwys yr athro neu'r athrawes yn y rhestrau o'r gwaharddedig a gedwir o dan Ddeddf Diogelu Grwpiau Hyglwyf 2006.

Er bod y cynllun gwahardd o dan y Ddeddf Diogelu Grwpiau Hyglwyf 2006 yn disodli'r system o roi cyfarwyddiadau o dan adran 142 o Ddeddf Addysg 2002, cedwir y cyfeiriad at y system honno gan fod angen gwahardd swyddogaethau Pwyllgor Ymchwilio mewn perthynas ag achosion sy'n cael eu hystyried o dan adran 142 o Ddeddf Addysg 2002 ond nad ydynt wedi dod i ben ar 12 Hydref 2009.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the General Teaching Council for Wales (Disciplinary Functions) Regulations 2001 ("the 2001 Regulations") and revoke an amendment made to the 2001 Regulations by the General Teaching Council for Wales (Disciplinary Functions) (Amendment) Regulations 2009.

The 2001 Regulations make provision about the disciplinary functions of the General Teaching Council for Wales.

The effect of the amendment and revocation is that the functions of an Investigating Committee of the General Teaching Council for Wales are excluded if the Welsh Ministers or the Secretary of State wish to consider a case with a view to exercising powers under section 142 of the Education Act 2002, or if the Independent Barring Board have included or want to consider including the teacher in the barred lists maintained under the Safeguarding Vulnerable Groups Act 2006.

Although the barring scheme under the Safeguarding Vulnerable Groups Act 2006 replaces the system of giving directions under section 142 of the Education Act 2002, the reference to that system is retained as it is necessary to exclude an Investigating Committee's functions in relation to cases that are being considered under section 142 of the Education Act 2002 but have not been concluded on 12 October 2009.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 6, 14(3) a 42(6) o Ddeddf Addysgu ac Addysg Uwch 1998 a pharagraff 1(1) a (4) o Atodlen 2 iddi(1) ac sydd bellach wedi eu breinio ynddynt hwy(2), ac ar ôl ymgynghori â Chyngor Addysgu Cyffredinol Cymru'n unol ag adran 42(9) o'r Ddeddf honno, yn gwneud y Rheoliadau a ganlyn:

The Welsh Ministers, in exercise of the powers conferred on the Secretary of State by sections 6, 14(3) and 42(6) of, and paragraph 1(1) and (4) of Schedule 2 to, the Teaching and Higher Education Act 1998(1) and now vested in them(2), and after consulting the General Teaching Council for Wales in accordance with section 42(9) of that Act, make the following Regulations:

**Title and commencement**

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Disgyblu) (Diwygio Rhif 2) 2009.

1.—(1) The title of these Regulations is the General Teaching Council for Wales (Disciplinary Functions) (Amendment No. 2) Regulations 2009.

(2) Daw'r rheoliad hwn a rheoliad 2 i rym ar 7 Medi 2009.

(2) This regulation and regulation 2 come into force on 7 September 2009.

(3) Daw rheoliad 3 i rym ar 12 Hydref 2009.

(3) Regulation 3 comes into force on 12 October 2009.

3. The General Teaching Council for Wales (Disciplinary Functions) Regulations 2001(2) are amended by adding after regulation 9(1)(b) the following —

- (c) the Independent Barring Board, established under section 1 of the Safeguarding Vulnerable Groups Act 2006(3), has included, or is considering whether to include, a registered teacher in either of the barred lists maintained under section 2 of that Act."
