The Welsh Ministers make the following regulations in exercise of the powers conferred by sections 71, 128, 129 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1).

Title, commencement and application

1.—(1) The title of these Regulations is the National Health Service (Optical Charges and Payments) (Amendment) (Wales) Regulations 2009 which come into force on 11 March 2009.

(2) These Regulations apply in relation to Wales.

2. In the definition of "NHS sight test fee" in regulation 1(2) of the National Health Service (Optical Charges and Payments) Regulations 1997(2) —
