- (b) yn gyrrff eraill a ganiateir am y tro gan unrhyw gorff sy'n cwympo o fewn paragraff (a) i weithredu ar ei ran wrth ddyfarnu graddau.

Mae'r Gorchymyn hwn yn diwygio Gorchymyn 2007 ac yn diweddu'r rhestr o gyrrff a geir yn yr atodlen i'r Gorchymyn hwnnw. Caiff nifer o gyrrff eu hepgor o'r Atodlen gan nad oes ganddynt bellach bwerau i ddyfarnu graddau neu am eu bod wedi cyfuno â chyrrff eraill. Cafodd nifer o gyrrff newydd eu mewnosod yn yr Atodlen gan ei bod yn ymddangos i Weinidogion Cymru fod y cyrrff hynny bellach yn cwympo o fewn naill ai (a) neu (b) uchod. **EXPLANATORY NOTE**

*(This note is not part of the Order)*

The Education (Recognised Bodies) (Wales) Order 2007 ("the 2007 Order") lists all the bodies appearing to the Welsh Ministers to be recognised bodies within section 214 (2) (a) or (b) of the Education Reform Act 1988 ("the 1988 Act"). Such bodies are either:

- (a) universities, colleges or bodies authorised by Royal Charter or by or under an Act of Parliament to grant degrees; or
- (b) bodies which are for the time being permitted by any body falling within paragraph (a) to act on its behalf in the granting of degrees.

The Order amends the 2007 Order and updates the list of bodies contained in the schedule to that Order. A number of bodies are omitted from the Schedule as they no longer have degree awarding powers or have merged with other bodies. A number of new bodies have been inserted into the Schedule as these bodies now appear to the Welsh Ministers to fall within either (a) or (b) above. A number of minor amendments have also been made to the Schedule to take account of name changes since the 2007 Order was made.

The Welsh Ministers, in exercise of the powers conferred upon the Secretary of State by section 216(1) of the Education Reform Act 1988(1) and now vested in them(2), make the following Order:

**Title, commencement and application**

1.—(1) The title of this Order is the Education (Recognised Bodies) (Wales) (Amendment) Order 2009 and it comes into force on 6 April 2009.

(2) This Order applies in relation to Wales.

**Amendment to the Education (Recognised Bodies) (Wales) Order 2007**

2.—(1) The Education (Recognised Bodies) (Wales) Order 2007(3) is amended as follows.

**3. In the Schedule—**

(a) omit—

- (i) "Henley Management College"; and
- (ii) "University of Paisley".

(b) for—

- (i) "Buckinghamshire Chilterns University College", substitute "Buckinghamshire New University";
- (ii) "University of Central England in Birmingham", substitute "Birmingham City University";

- (v) "Newman College of Higher Education, Birmingham", substitute "Newman University College".

- (a) "Arts Institute at Bournemouth, The";
- (b) "Ashridge (Bonar Law Memorial) Trust (also known as "Ashridge"))";
- (c) "University College Birmingham";
- (d) "Glyndŵr University (Prifysgol Glyndŵr)";
- (e) "Norwich University College of the Arts";
- (f) "Swansea Metropolitan University (Prifysgol Fethropolitan Abertawe)";
- (g) "Trinity University College (Coleg Prifysgol y Drindod)";
- (h) "UHI Millennium Institute"; and
- (i) "University of the West of Scotland".
