Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl 2007 ("y prif Reoliadau").

Mae'r prif Reoliadau yn gwneud darpariaeth fel bod pobl sydd naill ai'n cael budd-daliadau penodol oddi wrth y wladwriaeth neu sydd ar incwm isel yn cael peidio â thalu taliadau penodol neu gael ad-daliad ohonynt, a'r taliadau hynny fel arall yn daladwy o dan Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006 ("taliadau GIG") a chael taliad am dreuliau teithio a dynnwyd wrth gael gwasanaethau GIG penodol ("treuliau teithio GIG").

Wrth gyfrifo adnoddau a gofynion person o dan y prif Reoliadau er mwyn canfod a oes gan berson hawl i beidio â thalu taliadau GIG a chael taliad am dreuliau teithio GIG, defnyddir fersiwn addasedig o Reoliadau Cymhorthdal Incwm (Cyffredinol) 1987.

Mae rheoliad 2 yn cynyddu swm yr incwm y caiff person sy'n derbyn credyddau treth ei dderbyn tra bydd yn parhau i fod â hawl i beidio â thalu ffi o gwbl ac i gael taliad llawn o dan reoliad 5 o'r prif Reoliadau.

Mae rheoliad 3 yn gwneud newidiadau i'r terfynau cyfalaf a ddefnyddir i gyfrifo hawl i beidio â thalu ac i gael taliad drwy gynyddu'r terfyn cyfalaf isaf o £19,000 i £20,750 ar gyfer pobl sy'n byw'n barhaol mewn cartrefi gofal.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations further amend the National Health Service (Travelling Expenses and Remission of Charges) (Wales) Regulations 2007 ("the principal Regulations").

The principal Regulations make provision so that persons who are either in receipt of certain state benefits or who are on a low income are able to obtain the remission or repayment of certain charges which would otherwise be payable under the National Health Service (Wales) Act 2006 ("NHS charges") and the payment of travelling expenses incurred in obtaining certain NHS services ("NHS travelling expenses").

In calculating a person's resources and requirements under the principal Regulations in order to establish whether a person can claim entitlement to the remission of NHS charges and the payment of NHS travelling expenses, a modified version of the Income Support (General) Regulations 1987 is applied.

Regulation 2 increases the amount of income which a person in receipt of tax credits may receive whilst remaining entitled to full remission and payment under regulation 5 of the principal Regulations.

Regulation 3 makes changes to the capital limits used for calculating entitlement to remission and payment by increasing the lower capital limit from £19,000 to £20,750 for people living permanently in care homes.

The Welsh Ministers, in exercise of the powers conferred by sections 130, 131, 132 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1), hereby make the following Regulations:

Title, commencement, application and interpretation

1.—(1) The title of these Regulations is the National Health Service (Travelling Expenses and Remission of Charges) (Wales) (Amendment) (No.2) Regulations 2009.

(2) These Regulations come into force on 6 April 2009.

(3) These Regulations apply in relation to Wales.

(4) In these Regulations "the principal Regulations" ("y prif Reoliadau") means the National Health Service (Travelling Expenses and Remission of Charges) (Wales) Regulations 2007(2).

Amendment of regulation 5 of the principal Regulations

2. In regulation 5 of the principal Regulations (entitlement to full remission and payment), in paragraph (1), for "£15,050" substitute "£15,276".
