Mae'r Rheoliadau hyn yn gosod terfyn cyflymder o 50 milltir yr awr ar ddarn penodol o Draffordd yr M4 yn Sir Fynwy.

Mae'r pŵer i wneud rheoliadau o dan adran 17(2) a (3) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984 (ac eithrio mewn perthynas â ffyrrd arbennig yn gyffredinol) gan Weinidogion Cymru i'r graddau y maent yn arferadwy o ran Cymru. Mae'r Rheoliadau hyn yn dirymu'r terfyn cyflymder presennol o 50 milltir yr awr a osodir gan Reoliadau Traffordd yr M4 (Man Casglu Tollau Rogiet, Sir Fynwy) (Terfyn Cyflymder 50 mya) 2005, sy'n ymwneud â rhan o'r darn o draffordd a lywodraethir gan y Rheoliadau hyn.

Ystyrir bod y terfyn cyflymder 50 milltir yr awr yn rhagofal diogelwch hanfodol er mwyn galluogi traffig i arafu wrth ddynesu at Fan Casglu Tollau Ail Bont Hafren ac uno'n diogel o'r bythau toll yn y Man Casglu Tollau.

Ni wnaed asesiad effaith rheoleiddiol llawn ar gyfer yr offeryn hwn gan mai er mwyn diogelwch ar y ffordd y mae'n cael ei wneud ac nid yw'n effeithio ar gostau busnes.

The M4 Motorway (Rogiet Toll Plaza, Monmouthshire) (50 mph Speed Limit) Regulations 2010

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose a speed limit of 50 miles per hour on a specified length of the M4 Motorway in the County of Monmouthshire.

The power to make regulations under section 17(2) and (3) of the Road Traffic Regulation Act 1984 (except with respect to special roads generally) lies with the Welsh Ministers so far as they are exercisable in relation to Wales. The Regulations revoke the existing 50 miles per hour speed limit imposed by the M4 Motorway (Rogiet Toll Plaza, Monmouthshire) (50 mph Speed Limit) Regulations 2005, which relate to part of the length of motorway governed by these Regulations.

The 50 miles per hour speed limit is considered an essential safety precaution to enable traffic to slow down on the approaches to the Second Severn Crossing Toll Plaza and to merge safely from the toll booths at the Plaza.

A full regulatory impact assessment has not been produced for this instrument as it is made for highway safety reasons and it has no impact on the costs of business.

2. Yn y Rheoliadau hyn—
ystyr "y draffordd" ("the motorway") yw Traffordd Llundain i Dde Cymru (yr M4).

Gosod terfyn cyflymder

3. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 50 milltir yr awr ar y rhan honno o gerbytffordd y draffordd tua'r gorllewin yn Rogiet yn Sir Fynwy sy'n estyn o bwynt 800 o fetrau i'r dwyrain o linell ganol trosbont Heol yr Orsaf hyd at bwynt 752

The M4 Motorway (Rogiet Toll Plaza, Monmouthshire) (50 mph Speed Limit) Regulations 2010

Made	27 May 2010
Laid before the National Assembly for Wales	3 June 2010
Coming into force	24 June 2010

The Welsh Ministers, in exercise of the powers conferred upon them by section 17(2) and (3) of the Road Traffic Regulation Act 1984(1) and after consultation with representative organisations in accordance with section 134(2)(2) of that Act, make the following Regulations.

Title and commencement

1. These Regulations come into force on 24 June 2010 and their title is The M4 Motorway (Rogiet Toll Plaza, Monmouthshire) (50 mph Speed Limit) Regulations 2010.

Interpretation

2. In these Regulations—

"the motorway" means the London – South Wales Motorway (M4).

Imposition of speed limit

3. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on that area of the westbound carriageway of the motorway at Rogiet in the County of Monmouthshire which extends from a point 800 metres east of the centre line of Station Road
