Mae Deddf Diogelu Grwpiau Hyglwyf 2006 ("Deddf 2006") yn darparu'r fframwaith deddfwriaethol i gynllun fetio a gwahardd newydd ar gyfer y bobl sy'n gweithio gyda phlant ac oedolion hyglwyf. Mae adran 13 o Ddeddf 2006 yn gwneud yn ofynnol bod gwiriad yn cael ei gynnal ar unrhyw berson a benodir i gorff llywodraethu sefydliad addysgol. Mae Rheoliadau Deddf Diogelu Grwpiau Hyglwyf 2006 (Cyfnod Rhagnodedig a Swyddog Priodol) (Cymru) 2010 ("rheoliadau 2010") yn rhagnodi, at ddibenion adran 13, y cyfnod y bydd yn rhaid cyflawni'r gwiriad ynddo, a'r swyddog priodol a fydd yn gyfrifol am gyflawni'r gwiriad.

Mae'r Ysgrifennydd Gwladol yn cynnal adolygiad o'r cynllun fetio a gwahardd. O ganlyniad i'r adolygiad hwnnw, ni fydd adran 13 o Ddeddf 2006 yn cael ei chychwyn yn llawn ar 26 Gorffennaf 2010. O ganlyniad, mae'r Rheoliadau hyn yn dirymu rheoliadau 2010 cyn iddynt ddod i rym ar 26 Gorffennaf 2010.

The Safeguarding Vulnerable Groups Act 2006 ("the 2006 Act") provides the legislative framework for a new vetting and barring scheme for people who work with children and vulnerable adults. Section 13 of the 2006 Act requires that a check be made in relation to any person appointed to the governing body of an educational establishment. The Safeguarding Vulnerable Groups Act 2006 (Prescribed Period and Appropriate Officer) (Wales) Regulations 2010 ("the 2010 regulations") prescribe, for the purposes of section 13, the period within which that check must be carried out and the appropriate officer responsible for carrying it out.

The Secretary of State is conducting a review of the vetting and barring scheme. As a consequence of that review section 13 of the 2006 Act will not be fully commenced on 26 July 2010. Consequently, these Regulations revoke the 2010 regulations before they come into force on 26 July 2010.

The Welsh Ministers, in exercise of the powers conferred on them by sections 13, 56(1), 60 and 61(5) of the Safeguarding Vulnerable Groups Act 2006(1) make the following Regulations:

**Title, commencement and application**

1.–(1) The title of these Regulations is the Safeguarding Vulnerable Groups Act 2006 (Prescribed Period and Appropriate Officer) (Wales) (Revocation) Regulations 2010 and they come into force on 25 July 2010.

(2) These Regulations apply in relation to Wales.

**Revocation**

2. The Safeguarding Vulnerable Groups Act 2006 (Prescribed Period and Appropriate Officer) (Wales) Regulations 2010(2) are revoked.
