Mae'r Rheoliadau hyn yn diwygio Rheoliadau Grant Dysgu'r Cynulliad (Addysg Bellach) 2008 ("Rheoliadau 2008") a Rheoliadau Grant Dysgu'r Cynulliad (Addysg Bellach) 2009 ("Rheoliadau 2009").

Mae Rheoliadau 2008 a Rheoliadau 2009 yn darparu ar gyfer talu grant i fyfyrwyr cymwys sy'n dilyn cyrsiau addysg bellach dynodedig yn ystod y blynnyddoedd academaidd sy'n dechrau ar neu ar ôl 1 Medi 2008 ac ar neu ar ôl 1 Medi 2009 yn y drefn honno. Mae cyrsiau dynodedig fel y'u diffinnir yn y rheoliadau hynny'n cynnwys cyrsiau sy'n cael eu hariannu gan Gyngor Dysgu a Sgiliau Lloegr.

Mae Deddf Prentisiaethau, Sgiliau, Plant a Dysgu 2009 (p. 22) yn gwneud darpariaeth ar gyfer diddymu Cyngor Dysgu a Sgiliau Lloegr ac ar gyfer sefydlu Asiantaeth Ddysgu Pobl Ifanc Lloegr a'r Prif Weithredwr Ariannu Sgiliau i ariannu cyrsiau addysg bellach yn Lloegr.

Mae'r Rheoliadau hyn yn diwygio Rheoliadau 2008 a Rheoliadau 2009 er mwyn gwneud darpariaeth i'r cyrsiau dynodedig a ddiffinnir yn y rheoliadau hynny gynnwys cyrsiau a ariennir gan Asiantaeth Ddysgu Pobl Ifanc Lloegr a chan y Prif Weithredwr Ariannu Sgiliau.

Nid oes Asesiad Effaith Rheoleiddiol wedi ei baratoi ar gyfer yr offeryn hwn, gan nad yw'n effeithio o gwbl ar gostau busnesau, elusennau neu gyrrff gwirfoddol. Bach iawn yw'r effaith ar y sector cyhoeddus.

**The Assembly Learning Grant
(Further Education) (Amendment)
Regulations 2010**

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Assembly Learning Grant (Further Education) Regulations 2008 ("the 2008 Regulations") and the Assembly Learning Grant (Further Education) Regulations 2009 ("the 2009 Regulations").

The 2008 Regulations and the 2009 Regulations provide for the payment of a grant to eligible students taking designated further education courses during the academic years beginning on or after 1 September 2008 and on or after 1 September 2009 respectively. Designated courses as defined in those regulations include courses funded by the Learning and Skills Council for England.

The Apprenticeships, Skills, Children and Learning Act 2009 (c. 22) makes provision for the Learning and Skills Council for England to be dissolved and for the establishment of the Young Person's Learning Agency for England and the Chief Executive of Skills Funding to fund further education courses in England.

These Regulations amend the 2008 Regulations and the 2009 Regulations to make provision for the designated courses defined in those regulations to include courses funded by the Young People's Learning Agency for England and by the Chief Executive of Skills Funding.

A Regulatory Impact Assessment has not been prepared for this instrument, as it has no impact on the costs of businesses, charities or voluntary bodies. The impact on the public sector is minimal.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 22, 42(6) a 43(1) o Ddeddf Addysgu ac Addysg Uwch 1998(1) ac sydd bellach yn arferadwy ganddynt hwy(2), yn gwneud y Rheoliadau canlynol:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Grant Dysgu'r Cynulliad (Addysg Bellach) (Diwygio) 2010.

(2) Daw'r Rheoliadau hyn i rym ar 1 Ebrill 2010 ac maent yn gymwys o ran Cymru.

The Welsh Ministers, in exercise of the powers conferred upon the Secretary of State by sections 22, 42(6) and 43(1) of the Teaching and Higher Education Act 1998(1) and now exercisable by them(2), make the following Regulations:

Title, commencement and application

1.-(1) The title of these Regulations is the Assembly Learning Grant (Further Education) (Amendment) Regulations 2010.

(2) These Regulations come into force on 1 April 2010 and apply in relation to Wales.

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adran 22 o Ddeddf Addysgu ac Addysg Uwch 1998 (ac eithrio i'r graddau y maent yn ymwneud â gwneud unrhyw ddarpariaeth a awdurdodir gan is-adran (2)(a), (c), (j) neu (k), (3)(e) neu (f) neu (5) o adran 22) i Gymulliad Cenedlaethol Cymru gan adran 44 o Ddeddf Addysg Uwch 2004 ac mae Gorchymyn Deddf Addysg Uwch 2004 (Cychwyn Rhif 2 a Darpariaeth Drosiannol) (Cymru) 2005 (O.S. 2005/1833 (Cy.149) (C.79)) fel y'i diwygiwyd gan Orchymyn Deddf Addysg Uwch 2004 (Cychwyn Rhif 2 a Darpariaeth Drosiannol) (Cymru) (Diwygio) 2006 (O.S. 2006/1660 (Cy.159) (C.56)) yn cyfeirio at hyn. Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru i Weinidogion Cymru yn rhinwedd paragraffau 30(1) a 30(2)(a) o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p.32).
