Mae'r Cod Ymarfer hwn yn disodli, o ran Cymru, y gwahanol Godau Ymarfer Amaethyddol Da ar gyfer Gwarchod Dŵr, Aer a Phridd a ddyroddwyd o ran Cymru a Lloegr gan y Weinyddiaeth Amaethyddiaeth, Pysgodfeydd a Bwyd ac Adran Amaethyddiaeth y Swyddfa Gymreig ym mis Hydref 1998.

Mae'r Gorchymyn hwn yn dirymu, i'r graddau mae'n gymwys yng Nghymru, Gorchymyn Dŵr (Atal Llygredd) (Cod Ymarfer) (Cymru) 1998 (O.S. 1998/3084) a gymeradwyodd y Cod Ymarfer Amaethyddol Da ar gyfer Gwarchod Dŵr.

Mae'n ofynnol i Asiantaeth yr Amgylchedd, yn ôl adran 97(2) o Ddeddf Adnoddau Dŵr 1991, ystyried a fu yna unrhyw weithredu'n groes i'r Cod Ymarfer, neu a yw gweithredu o'r fath yn debygol wrth benderfynu ar pa fodd a pha bryd i arfer y canlynol:

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order applies in relation to Wales. This Order approves, under section 97(1) of the Water Resources Act 1991, the Code of Good Agricultural Practice to protect water, soil and air quality which was issued by the Welsh Ministers on 30 March 2011 ("the Code of Practice"), in so far as the Code of Practice was issued for the purpose mentioned in Article 2.

The Code of Practice replaces, in relation to Wales, the separate Codes of Good Agricultural Practice for the Protection of Water, Air and Soil issued in relation to England and Wales by the Ministry of Agriculture, Fisheries and Food and the Welsh Office Agricultural Department in October 1998.

This Order revokes, in so far as it applies in Wales, the Water (Prevention of Pollution) (Code of Practice) (Wales) Order 1998 (S.I. 1998/3084) which approved the Code of Good Agricultural Practice for the Protection of Water.

The Environment Agency is required, by section 97(2) of the Water Resources Act 1991, to take into account whether there has been or is likely to be any contravention of the Code of Practice in determining when and how to exercise:

(i) its relevant functions, in relation to water discharge activities, under the Environmental Permitting (England and Wales) Regulations: S.I. 2010/675, and

(ii) unrhyw bwerau a roddir iddi gan reoliadau o dan adran 92 o'r Ddeddf honno.

Mae copiâu electronig o'r Cod Ymarfer i'w cael o wefan Llywodraeth Cynulliad Cymru neu ar ffurf copi caled o'r Adran Materion Gwledig, Llywodraeth Cynulliad Cymru, Parc Cathays Caerdydd CF10 3NQ.

Nid oes asesiad effaith rheoleiddiol wedi'i lunio ar gyfer yr Gorchymyn hwn, gan na ragwelir y bydd yn effeithio ar gostau busnes na'r sector gwirfoddol.

(ii) any powers conferred upon it by regulations under section 92 of that Act.

The Water (Prevention of Pollution) (Code of Good Agricultural Practice) (Wales) Order 2011

The Welsh Ministers, in exercise of the powers conferred by section 97(1) of the Water Resources Act 1991(1) and now vested in them(2), make the following Order.

The Welsh Ministers have consulted the Environment Agency in accordance with section 97(3)(3) of that Act.

**Title, commencement, application and interpretation**

1.-(1) The title of this Order is the Water (Prevention of Pollution) (Code of Good Agricultural Practice) (Wales) Order 2011.

(2) This Order comes into force on 19 April 2011.

(3) This Order applies in relation to Wales.

## Cymeradwyo'r Cod Ymarfer

2. Mae Gweinidogion Cymru yn cymeradwyo'r Cod Ymarfer i'r graddau y dyroddwyd y cod ymarfer at ddibenion–

- (a) rhoi cyfarwyddyd ymarferol i bobl sy'n ymwneud ag amaethyddiaeth gyda golwg ar weithgareddau a all gael effaith ar ddyfroedd wedi eu rheoli(2); a
- (b) hybu'r hyn sy'n ymddangos i Weinidogion Cymru yn arferion dymunol gan y cyfryw bersonau i osgoi llygru neu gwtogi hyd yr eithaf ar lygru unrhyw ddyfroedd o'r fath.

## Dirymu

3. Mae Gorchymyn Dŵr (Atal Llygredd) (Cod Ymarfer) (Cymru) 1998(3) wedi ei ddirymu i'r graddau y mae'n gymwys i Gymru.

(4) In this Order, "the Code of Practice" means the Code of Good Agricultural Practice to protect water, soil and air quality which was issued by the Welsh Ministers on 30 March 2011(1).

## Approval of the Code of Practice

2. The Welsh Ministers approve the Code of Practice in so far as the Code of Practice was issued for the purpose of–

- (a) giving practical guidance to persons engaged in agriculture with respect to activities that may affect controlled waters(2); and
- (b) promoting what appears to the Welsh Ministers to be desirable practices by such persons for avoiding or minimising the pollution of any such waters.

## Revocation

3. The Water (Prevention of Pollution) (Code of Practice) (Wales) Order 1998(3) is revoked in so far as it applies to Wales.
