EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations revoke in relation to Wales the Housing Renewal Grants (Prescribed Form and Particulars) Regulations 1996 (S.I. 1996/2891) and the Housing Renewal Grants (Prescribed Form and Particulars) (Welsh Form and Particulars) Regulations 1998 (S.I. 1998/1113). The 1996 and 1998 Regulations prescribed an English and Welsh form for applications for grants under Chapter 1 of Part 1 of the Housing Grants, Construction and Regeneration Act 1996 (for assistance from local housing authorities to the cost of works required for the provision of facilities for disabled persons in certain dwellings).

These Regulations also make the following consequential revocations in relation to Wales:

# The Housing Renewal Grants (Prescribed Form and Particulars) (Revocation) (Wales) Regulations 2011

Made 14 June 2011

*Laid before the National  
Assembly for Wales* 16 June 2011

*Coming into force* 7 July 2011

The Welsh Ministers make the following regulations in exercise of the powers conferred upon the Secretary of State by sections 2(2) and (4), 101 and 146(1) and (2) of the Housing Grants, Construction and Regeneration Act 1996(1) and section 26(3) of the Welsh Language Act 1993(2) and now vested in them so far as exercisable in relation to Wales:

## **Title, commencement and application**

1.—(1) The title of these Regulations is the Housing Renewal Grants (Prescribed Form and Particulars) (Revocation) (Wales) Regulations 2011 and they come onto force on 7 July 2011.

(2) These Regulations apply in relation to Wales.

Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adrannau 2(2) a (4), 101 a 146(1) a (2), i'r graddau y maent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan erthygl 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672); gweler y cofnod ar gyfer Deddf Graniatai Tai, Adeiladu ac Adfywiad 1996 yn Atodlen 1 i'r Gorchymyn hwnnw. Yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p.32) mae'r swyddogaethau a oedd yn arferadwy gynt gan Gynulliad Cenedlaethol Cymru bellach wedi eu breiniio yng Nghweiniadigion Cymru. Gwnaed diwygiadau i Ddeddf Graniatai Tai, Adeiladu ac Adfywiad 1996 nad ydynt yn berthnasol i'r Rheoliadau hyn.

(2) 1993 p.38. Roedd Gorchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672), erthyl 2(b) ac Atodlen 1, yn cyfarwyddo bod y pŵer yn adran 26(3) o Ddeddf yr Iaith Gymraeg 1993 yn arferadwy, o ran Cymru, gan Gymulliad Cenedlaethol Cymru a gyfansoddyd gan Ddeddf Llywodraeth Cymru 1998 (p.38), yn gydredol ag unrhyw Weinidog y Goron yr oedd y pŵer hwnnw'n arferadwy ganddo. Trosglwyddwyd y pŵer o'r Cynulliad hwnnw i Weinidogion Cymru yn rhinwedd adran 162(3) o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30(1) o Atodlen 11 i'r Ddeddf honno.

(1) 1996 c.53. The functions of the Secretary of State under sections 2(2) and (4), 101 and 146(1) and (2), so far as exercisable in relation to Wales, were transferred to the National Assembly for Wales by article 2 of the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672); see the entry for the Housing Grants, Construction and Regeneration Act 1996 in Schedule 1 to that Order. By virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32) the functions formerly exercisable by the National Assembly for Wales are now vested in the Welsh Ministers. Amendments have been made to the Housing Grants, Construction and Regeneration Act 1996 that are not relevant to these Regulations.

(2) 1993 c.38. The National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672), article 2(b) and Schedule 1, directed that the power in section 26(3) of the Welsh Language Act 1993 be exercisable, in relation to Wales, by the National Assembly for Wales constituted by the Government of Wales Act 1998 (c.38) concurrently with any Minister of the Crown by whom the power was exercisable. The power was transferred from that Assembly to the Welsh Ministers by virtue of section 162(3) of, and paragraph 30(1) of Schedule 11 to, the Government of Wales Act 2006 (c.32).
