Effaith cymhwysyo adran 26(2) i (4) o'r Ddeddf yw cadw contractau cyflogaeth cyflogeonion y corfforaethau a ddiddymwyd fel petai'r contractau cyflogaeth wedi cael eu gwneud yn wreiddiol rhwng y cyflogeonion hynny a Chorfforaeth Addysg Bellach Caerdydd a'r Fro ("Cardiff and Vale College Further Education Corporation"). Daw cyflogeonion y corfforaethau a ddiddymwyd yn gyflogeonion Corfforaeth Addysg Bellach Caerdydd a'r Fro ("Cardiff and Vale College Further Education Corporation") o 1 Awst 2011 ymlaen.

The Barry College Further Education Corporation and Coleg Glan Hafren Further Education Corporation (Dissolution) Order 2011

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order dissolves the further education corporations established to conduct Barry College ("Coleg y Barri") and Coleg Glan Hafren with effect from 1 August 2011. It provides for the transfer of the property, rights and liabilities of each corporation to Cardiff and Vale College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Caerdydd a'r Fro") and secures the employment rights of the employees of the dissolved corporations by applying, with modifications, section 26(2) to (4) of the Further and Higher Education Act 1992 ("the Act").

The application of section 26(2) to (4) of the Act has the effect of preserving the employment contracts of employees of the dissolved corporations as if the contracts of employment were originally made between the employees and the Cardiff and Vale College Further Education Corporation ("Corfforaeth Addysg Bellach Caerdydd a'r Fro"). The employees of the dissolved corporations will become employees of the Cardiff and Vale College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Caerdydd a'r Fro") from 1 August 2011.

A Regulatory Impact Assessment has not been prepared for this instrument as it has no impact on the costs of business.

The Welsh Ministers make the following Order in exercise of the powers conferred by section 27 of the Further and Higher Education Act 1992(1) on the Secretary of State and now vested in them(2).

In accordance with section 27(2) of that Act, Cardiff and Vale College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Caerdydd a'r Fro") (3) has consented to the transfer of the property, rights and liabilities of Barry College Further Education Corporation ("Corfforaeth Addysg Bellach

1. Enw'r Gorchymyn hwn yw Gorchymyn Corfforaeth Addysg Bellach Coleg y Barri a Chorfforaeth Addysg Bellach Coleg Glan Hafren (Diddymu) 2011 a daw i rym ar 1 Awst 2011.

## Dehongli

2. Yn y Gorchymyn hwn—

ystyr "y Ddeddf" ("the Act") yw Deddf Addysg Bellach ac Uwch 1992<sup>(3)</sup>; ac

ystyr "yr Hen Gorfforaethau" ("the Old Corporations") yw Corfforaeth Addysg Bellach Coleg y Barri ("Barry College Further Education Corporation") a Chorfforaeth Addysg Bellach Coleg Glan Hafren ("Coleg Glan Hafren Further Education Corporation").

## Diddymu a throsglwyddo

3. Ar 1 Awst 2011 mae pob un o'r Hen Gorfforaethau wedi eu diddymu ac mae eu holl eiddo, hawliau a rhwymedigaethau wedi eu trosglwyddo yn unol ag adran 27(2) o'r Ddeddf i Gorfforaeth Addysg Bellach Coleg Caerdydd a'r Fro ("Cardiff and Vale College Further Education Corporation"), sef corff corfforaethol sydd wedi ei sefydlu at ddibenion sy'n cynnwys darparu cyfleusterau neu wasanaethau addysgol.

## Trosglwyddo Staff

4. Mae adran 26(2), (3) a (4) o'r Ddeddf yn gymwys i unrhyw berson a gyflwyn gan yr Hen Gorfforaethau yn union cyn 1 Awst 2011 fel petai cyfeiriadau yn yr adran honno—

(a) at berson y mae'r adran honno yn gymwys iddo yn gyfeiriadau at berson sy'n gyflwynedig fel hynny;

The Welsh Ministers have consulted with Barry College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg y Barri") and Coleg Glan Hafren Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Glan Hafren"), in accordance with section 27(7) of that Act.

## Title and commencement

1. The title of this Order is the Barry College Further Education Corporation and Coleg Glan Hafren Further Education Corporation (Dissolution) Order 2011 and it comes into force on 1 August 2011.

## Interpretation

2. In this Order—

"the Act" ("y Ddeddf") means the Further and Higher Education Act 1992<sup>(3)</sup>; and

"the Old Corporations" ("yr Hen Gorfforaethau") means Barry College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg y Barri") and Coleg Glan Hafren Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Glan Hafren").

## Dissolution and transfer

3. On 1 August 2011 each of the Old Corporations is dissolved and all of their property, rights and liabilities are transferred in accordance with section 27(2) of the Act to the Cardiff and Vale College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Caerdydd a'r Fro"), being a body corporate established for purposes which include the provision of educational facilities or services.

## Transfer of staff

4. Section 26(2), (3) and (4) of the Act applies to any person employed by the Old Corporations immediately before 1 August 2011 as if the references in that section to—

(a) a person to whom that section applies were to a person so employed;

- (b) at y dyddiad gweithredol yn gyfeiriadau at 1 Awst 2011;
  - (c) at y trosglwyddwr yn gyfeiriadau at unrhyw un o'r Hen Gorfforaethau sy'n cyflogi'r person yn union cyn 1 Awst 2011; ac
  - (ch) at y gorfforaeth yn gyfeiriadau at Gorfforaeth Addysg Bellach Coleg Caerdydd a'r Fro ("Cardiff and Vale College Further Education Corporation").
- (b) the operative date were to 1 August 2011;
  - (c) the transferor were to such of the Old Corporations by whom the person is employed immediately before 1 August 2011; and
  - (d) the corporation were to Cardiff and Vale College Further Education Corporation ("Corfforaeth Addysg Bellach Coleg Caerdydd a'r Fro").
