EXPLANATORY NOTE

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) (Cymru) 2007 ("y prif Reoliadau"). Mae'r Rheoliadau hynny yn darparu ar gyfer talu treuliau teithio a pheidio â chodi ffioedd Gwasanaeth Iechyd Gwladol ('GIG') ar, ymhlith pobl eraill, bersonau sydd ar incwm isel, drwy gyfeirio at derfynau ar eu hincwm a'u cyfalaf.

These Regulations, which apply in relation to Wales, further amend the National Health Service (Travel Expenses and Remission of Charges) (Wales) Regulations 2007 ("the principal Regulations"). Those Regulations provide for the payment of travel expenses and the remission of National Health Service ('NHS') charges for, amongst others, persons on low incomes, by reference to limits on their income and capital.

Wrth gyfrifo adnoddau a gofynion person o dan y prif Reoliadau er mwyn canfod a yw'n cael hawlio hawl i beidio â thalu ffioedd GIG ac i gael taliad am dreuliau teithio GIG, defnyddir fersiwn addasedig o Reoliadau Cymhorthdal Incwm (Cyffredinol) 1987.

In calculating a person's resources and requirements under the principal Regulations in order to establish whether a person can claim entitlement to the remission of NHS charges and payment of NHS travelling expenses, a modified version of the Income Support (General) Regulations 1987 is applied.

Mae rheoliad 3 yn diweddarau cyfeiriadau at reoliadau ariannu myfyrwyr yng Nghymru, Lloegr a Gogledd Iwerddon. Mae'r rhain yn nodi'r hawliau i grantiau a benthyciadau sydd ar gael i fyfyrwyr. Mae symiau penodol o grantiau cynnal myfyrwyr yn cael eu diystyru wrth gyfrifo hawliau myfyrwyr i gael taliad am eu treuliau teithio ac i beidio â thalu ffioedd o dan y prif Reoliadau. Mae'n diweddarau hefyd y cyfeiriad at y 'Student Support Information Guide' a ddyroddir gan Asiantaeth Dyfarniadau Myfyrwyr yr Alban.

Regulation 3 updates references to student funding regulations in Wales, England and Northern Ireland. These set out the entitlement to grants and loans available to students. Certain amounts of student maintenance grants are disregarded in calculating the entitlement of students to the payment of travel expenses and the remission of charges under the principal Regulations. It also updates the reference to the Student Support Information Guide issued by the Student Awards Agency for Scotland.

Mae rheoliad 4 yn gwneud tri mân gywiriad i'r prif Reoliadau.

Regulation 4 makes three minor corrections to the principal Regulations.

Mae rheoliad 5 yn dirymu Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) (Cymru) (Diwygio) (Rhif 2) 2010.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar wneud Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, barnwyd nad oedd yn angenrheidiol gwneud asesiad effaith rheoleiddiol ynghylch costau a buddiannau tebygol cydymffurfio â'r Rheoliadau hyn.

Regulation 5 revokes the National Health Service (Travelling Expenses and Remission of Charges) (Wales) (Amendment) (No.2) Regulations 2010.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 130, 131, 132 a 203(9) a (10) o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006(1) ac a freiniwyd bellach ynddynt hwy(2).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 130, 131, 132 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1) and now vested in them(2).

Title, commencement and effect

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) (Cymru) (Diwygio) (Rhif 2) 2011.

1.—(1) The title of these Regulations is the National Health Service (Travelling Expenses and Remission of Charges) (Wales) (Amendment) (No.2) Regulations 2011.

(2) Mae'r Rheoliadau hyn yn dod i rym ar 1 Medi 2011 ac yn cael effaith o'r dyddiad hwnnw, ac eithrio fel a ddarperir ym mharagraffau (3) a (4).

(2) These Regulations come into force on 1 September 2011 and have effect from that date, except as provided in paragraphs (3) and (4).

Interpretation

2. In these Regulations—

"the 1987 Regulations" ("*Rheoliadau 1987*") means the Income Support (General) Regulations 1987(1); and

"the 2007 Regulations" ("*Rheoliadau 2007*") means the National Health Service (Travelling Expenses and Remission of Charges) (Wales) Regulations 2007(2).

Amendment of Table A of Schedule 1 to the 2007 Regulations

3.—(1) Column 2 of Table A of Schedule 1 to the 2007 Regulations (modifications of the Income Support (General) Regulations 1987) is amended as follows.

(2) In the modification of regulation 23 (calculation of income and capital of members of claimant's family and of a polygamous marriage) of the 1987 Regulations for the words "section 22(5) of the Act" substitute "section 136 of the Social Security Contributions and Benefits Act(3)".

(3) In the modification of regulation 62 of the 1987 Regulations (calculation of grant income) for the entry relating to the insertion of paragraph (2) substitute the following—

Mae'r Rheoliadau hyn felly yn cywiro'r cofnod yn y fersiwn Gymraeg o'r O.S. a lofnodwyd gan y Gweinidog.
