O dan adran 45 o Ddeddf Cyllid Llywodraeth Leol 1988 ("Deddf 1988") mae ardrethi annomestig yn daladwy ar hereditament sydd heb ei feddiannu os yw'n bodloni'r amodau a bennir yn adran 45(1). Mae'r amodau hynny'n cynnwys amod bod yr hereditament yn dod o fewn dosbarth rhagnodedig.

Mae Rheoliadau Ardrethu Annomestig (Eiddo Heb ei Feddiannu) (Cymru) 2008 yn rhagnodi dosbarth o hereditamentau heb eu meddiannu y mae ardrethi'n daladwy arnynt. Mae'r dosbarth hwnnw'n cynnwys pob hereditament heb ei feddiannu, os nad oes yr un o'r amodau yn rheoliad 4 yn gymwys iddo.

Mae rheoliad 4 yn eithrio o'r atebolwydd am ardrethi annomestig o dan adran 45 o Ddeddf 1988 pob hereditament a ddangosir mewn rhestr ardrethu annomestig, sydd â'i werth ardrethol yn llai na swm penodedig. Mae'r Rheoliadau hyn yn pennu mai £2,600 fydd y swm hwnnw ar gyfer hereditament a ddangosir yn y rhestr o 1 Ebrill 2011 ymlaen.

The Non-Domestic Rating
(Unoccupied Property) (Wales)
(Amendment) Regulations 2011

EXPLANATORY NOTE

(This note is not part of the Regulations)

Under section 45 of the Local Government Finance Act 1988 ("the 1988 Act") non-domestic rates are payable on an unoccupied hereditament if it fulfils the conditions set out in section 45(1). Those conditions include a condition that the hereditament falls within a prescribed class.

The Non-Domestic Rating (Unoccupied Property) (Wales) Regulations 2008 prescribe a class of unoccupied hereditaments on which rates are payable. The class consists of all unoccupied hereditaments to which none of the conditions in regulation 4 applies.

Regulation 4 excludes from liability for non-domestic rates under section 45 of the 1988 Act all hereditaments shown in a non-domestic rating list with a rateable value less than a specified amount. These Regulations set that figure at £2,600 for the purpose of a hereditament shown in the list from 1 April 2011.

The Welsh Ministers make the following Regulations in exercise of the powers conferred on the Secretary of State by sections 45(1)(d), (9) and 146(6) of the Local Government Finance Act 1988(1) and now vested in them(2).

Title, commencement, and application

1.-(1) The title of these Regulations is The Non-Domestic Rating (Unoccupied Property) (Wales) (Amendment) Regulations 2011 and they come into force on 28 February 2011.

(2) These Regulations apply in relation to Wales to financial years beginning on and after 1 April 2011.

Property liable for unoccupied property rates

2. In regulation 4(g) of the Non-Domestic Rating (Unoccupied Property) (Wales) Regulations 2008(3) for "£2,200" substitute "£2,600".
