This Order is the second commencement order made by the Welsh Ministers under the Health Act 2009 ("the Act").

Mae erthygl 2 yn dwyn i rym, ar 1 Chwefror 2012, adran 22 o'r Ddeddf (pŵer i wahardd gwerthiannau o beiriannau gwerthu) i'r graddau nad yw wedi ei dwyn i rym eisoes.

Article 2 brings into force on 1 February 2012 section 22 of the Act (power to prohibit sales from vending machines) in so far as it has not already been brought into force.

Title and interpretation

1.—(1) The title of this Order is the Health Act 2009 (Commencement No. 2) (Wales) Order 2011.

(2) In this Order, "the Act" ("*y Ddeddf*") means the Health Act 2009.
