Mae'r Rheoliadau hyn yn gosod y ffioedd am gymeradwyaethau at ddibenion y cynllun iechyd dofednod a sefydlwyd o dan Gyfarwyddeb y Cyngor 2009/158/EC ar 30 Tachwedd 2009 ar amodau iechyd anifeiliaid, sy'n llywodraethu'r fasnach mewn dofednod ac wyau deor o fewn y Gymuned a mewforion dofednod ac wyau deor o drydydd gwledydd (OJ Rhif L 343, 22.12.2009, t.74) a Rheoliadau'r Fasnach mewn Anifeiliaid a Chynhyrchion Perthynol (Cymru) 2011.

These Regulations set the fees for approvals for the purposes of the poultry health scheme established under Council Directive 2009/158/EC of 30 November 2009 on animal health conditions governing intra-Community trade in, and imports from third countries of, poultry and hatching eggs (OJ No. L 343, 22.12.2009, p.74) and the Trade in Animals and Related Products (Wales) Regulations 2011.

**Ffioedd mewn perthynas â'r cynllun iechyd

2.—(1) Y ffi am gymeradwyaeth at ddibenion y cynllun iechyd dofednod a sefydlwyd o dan baragraff 4 o Atodlen 2 i Rheoliadau'r Fasnach mewn Anifeiliaid a Chynhyrchion Perthynol (Cymru) 2011(2) yw £60 am gymeradwyaeth ddechreuol, ynghyd â ffi flynyddol o—

- (a) £62 ar gyfer haid neu ddeorfa; neu
- (b) £70 ar gyfer cyfuniad o haid a deorfa ar un safle.

(2) Os cyflawnir yr arolygiad blynyddol o dan y paragraff hwnnw gan swyddog Gweinidogion Cymru, y ffi am bob arolygiad (yn ychwanegol at y ffi flynyddol) yw—

- (a) £97 ar gyfer haid neu ddeorfa; neu
- (b) £143 ar gyfer cyfuniad o haid a deorfa ar un safle.

**The Poultry Health Scheme (Fees)  
(Wales) Regulations 2011**

The Welsh Ministers, with the consent of the Treasury, make these Regulations in exercise of the powers conferred by section 56(1) of the Finance Act 1973(1) and now vested in them.

**Title, application and commencement**

1. The title of these Regulations is the Poultry Health Scheme (Fees) (Wales) Regulations 2011. They apply in relation to Wales and come into force on 19 October 2011.

**Fees relating to the poultry health scheme**

2.—(1) The fee for approval for the purposes of the poultry health scheme established under paragraph 4 of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011(2) is £60 for initial approval, with an annual fee of—

- (a) £62 for a flock or hatchery; or
- (b) £70 for a combined flock and hatchery on one site.

(2) If the annual inspection under that paragraph is carried out by an officer of the Welsh Ministers the fee for each inspection (in addition to the annual fee) is—

- (a) £97 for a flock or hatchery; or
- (b) £143 for a combined flock and hatchery on one site.

Mae'r ffi sy'n daladwy gan labordy cymeradwy am y profion hyfedredd canlynol a gynhelir gan yr Asiantaeth Iechyd Anifeiliaid a'r Labordai Milfeddygol o dan baragraff 2 o Atodiad I i Gyfarwyddeb y Cyngor 2009/158/EC (ar amodau iechyd anifeiliaid, sy'n llywodraethu'r fasnach mewn dofednod ac wyau deor o fewn y Gymuned, a mewnforyn dofednod ac wyau deor o drydydd gwledydd(1)) fel a ganlyn.
