Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau Labelu Bwyd 1996 ("y prif Reoliadau") i'r graddau y maent yn gymwys o ran Cymru. Mae'r prif Reoliadau yn rhychwantu Prydain Fawr gyfan.

Mae'r Rheoliadau hyn yn gweithredu yng Nghymru y diwygiad a wnaed i Gyfarwyddeb y Comisiwn 2007/68/EC (OJ Rhif L310, 28.11.2007, t.11) gan Reoliad y Comisiwn (EU) Rhif 1266/2010 (OJ Rhif L347, 31.12.2010, t.27). Mae'r Gyfarwyddeb hon ei hun yn diwygio Atodiad IIIa i Gyfarwyddeb 2000/13/EC Senedd Ewrop a'r Cyngor o ran cynhwysion bwyd penodol (OJ Rhif L109, 6.5.2000, t.29). Y cynhwysion o dan sylw yw'r rhai sy'n debyg o achosi adwaith alergaidd mewn rhai defnyddwyr.

Mae'r Rheoliadau hyn yn diwygio'r prif Reoliadau o ran y gofynion labelu ar gyfer bwydydd sy'n cynnwys cynhwysion alergenig, gan gynnwys esempiadau labelu ar gyfer ffurfiau penodol ar y cynhwysion hynny, a'r rheini'n ffurfiau a broseswyd, drwy estyn o 31 Rhagfyr 2010 i 30 Mehefin 2012 y cyfnod trosiannol ar gyfer lysosym sy'n dod o wyau ac ar gyfer cynhyrchion albwm (a gynhyrchwyd o wyau) neu gynhyrchion llaeth (casein) pan ddefnyddir hwy yn asiantau diwaddodi mewn gwin, o ran gwinoedd a gafodd eu marcio, eu labelu neu eu gwerthu cyn y dyddiad hwnnw (*rheoliad 2*).

The Food Labelling (Declaration of

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations further amend the Food Labelling Regulations 1996 ("the principal Regulations") in so far as they apply in relation to Wales. The principal Regulations extend to the whole of Great Britain.

These Regulations implement in Wales the amendment made to Commission Directive 2007/68/EC (OJ No. L310, 28.11.2007, p.11) by Commission Regulation (EU) No. 1266/2010 (OJ No. L347, 31.12.2010, p.27). This Directive itself amends Annex IIIa to Directive 2000/13/EC of the European Parliament and of the Council as regards certain food ingredients (OJ No. L109, 6.5.2000, p.29). The ingredients in question are those that are likely to cause an allergic reaction in some consumers.

These Regulations amend the principal Regulations in respect of the labelling requirements for foods containing allergenic ingredients, including labelling exemptions for certain processed forms of those ingredients, by extending from 31 December 2010 to 30 June 2012 the transitional period for egg-derived lysozyme and for albumin (produced from egg) or milk (casein) products when used as fining agents in wine, in respect of wines that are marked, labelled or sold before that date (*regulation 2*).

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd gan adrannau 16(1)(e), 17(1), 26(1)(a) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1), ac sydd bellach wedi'u breinio ynddynt hwy(2).

Yn unol ag adran 48(4A) o'r Ddeddf honno, maent wedi rhoi sylw i gyngor perthnasol a roddwyd iddynt gan yr Asiantaeth Safonau Bwyd.

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(3), cafwyd ymgynghoriad cyhoeddus agored a

**The Food Labelling (Declaration of  
Allergens) (Wales) Regulations  
2011**

*Made* *20 February 2011*

*Laid before the National  
Assembly for Wales* *23 February 2011*

*Coming into force* *17 March 2011*

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(e), 17(1), 26(1)(a) and 48(1) of the Food Safety Act 1990(1), and now vested in them(2).

In accordance with section 48(4A) of that Act, they have had regard to relevant advice given by the Food Standards Agency.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3), there has been open and

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Labelu Bwyd (Datgan Alergenau) (Cymru) 2011.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru ac maent yn dod i rym ar 17 Mawrth 2011.

## Diwygio Rheoliadau Labelu Bwyd 1996

2.-(1) Diwygir Rheoliadau Labelu Bwyd 1996(1) (i'r graddau y maent yn gymwys o ran Cymru) yn unol â pharagraff (2).

(2) Yn rheoliad 50 (darpariaeth drosiannol), yn lle paragraff (15) rhodder y canlynol—

"(15) In any proceedings for an offence under regulation 44(1)(a) it shall be a defence to prove that—

- (a) (i) in the case of wine in which lysozyme (produced from egg) is used, or in which albumin (produced from egg) or a milk (casein) product has been used as a fining agent, the food concerned was sold before 30 June 2012 or marked or labelled before that date, or
  - (ii) in the case of any other food, the food concerned was sold before 31 May 2009 or marked or labelled before that date; and
- (b) the matters constituting the alleged offence would not have constituted an offence under these Regulations if the amendments made by regulation 2 of the Food Labelling (Declaration of Allergens) (Wales) Regulations 2011 had not been in operation when the food was sold.".

## Title, application and commencement

1.-(1) The title of these Regulations is the Food Labelling (Declaration of Allergens) (Wales) Regulations 2011.

(2) These Regulations apply in relation to Wales and they come into force on 17 March 2011.

## Amendment of the Food Labelling Regulations 1996

2.-(1) The Food Labelling Regulations 1996(1) are amended (in so far as they apply in relation to Wales) in accordance with paragraph (2).

(2) In regulation 50 (transitional provision), for paragraph (15) substitute the following—

"(15) In any proceedings for an offence under regulation 44(1)(a) it shall be a defence to prove that—

- (a) (i) in the case of wine in which lysozyme (produced from egg) is used, or in which albumin (produced from egg) or a milk (casein) product has been used as a fining agent, the food concerned was sold before 30 June 2012 or marked or labelled before that date, or
  - (ii) in the case of any other food, the food concerned was sold before 31 May 2009 or marked or labelled before that date; and
- (b) the matters constituting the alleged offence would not have constituted an offence under these Regulations if the amendments made by regulation 2 of the Food Labelling (Declaration of Allergens) (Wales) Regulations 2011 had not been in operation when the food was sold.".

## Revocation

3. The Food Labelling (Declaration of Allergens) (Wales) Regulations 2009(2) are revoked.
