EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

1. Mae'r Rheoliadau hyn yn rhoi ar waith yng Nghymru ddwy Gyfarwyddeb Ewropeaidd sy'n ymwneud â meini prawf purdeb ar gyfer rhai ychwanegion bwyd ("y Cyfarwyddebau sy'n diwygio"). Y canlynol yw'r Cyfarwyddebau sy'n diwygio—

1. These Regulations implement in Wales two European Directives concerned with the purity criteria for certain food additives ("the amending Directives"). The amending Directives are—

- (a) Cyfarwyddeb y Comisiwn 2010/37/EU sy'n diwygio Cyfarwyddeb 2008/60/EC sy'n pennu meini prawf purdeb penodol ar gyfer melysyddion (OJ Rhif L152, 18.6.2010, t.12);
a
- (b) Cyfarwyddeb y Comisiwn 2010/67/EU sy'n diwygio Cyfarwyddeb 2008/84/EC sy'n pennu meini prawf purdeb penodol ar gyfer ychwanegion bwyd ac eithrio lliwiau a melysyddion (OJ Rhif L277, 21.10.2010, t.17).

- (a) Commission Directive 2010/37/EU amending Directive 2008/60/EC laying down specific purity criteria on sweeteners (OJ No. L152, 18.6.2010, p.12); and
- (b) Commission Directive 2010/67/EU amending Directive 2008/84/EC laying down specific purity criteria on food additives other than colours and sweeteners (OJ No. L277, 21.10.2010, p.17).

2. Mae'r Rheoliadau hyn yn rhoi ar waith y Cyfarwyddebau sy'n diwygio drwy wneud diwygiadau i reoliad 2 o Reoliadau Ychwanegion Bwyd (Cymru) 2009 (O.S. 2009/3378 (Cy.300)) fel bod y diffiniadau o Gyfarwyddeb 08/60 a Chyfarwyddeb 08/84 yn y rheoliad hwnnw'n cynnwys cyfeiriad at y Gyfarwyddeb berthnasol sy'n diwygio (rheoliad 2(2)).

2. These Regulations implement the amending Directives by making amendments to regulation 2 of the Food Additives (Wales) Regulations 2009 (S.I. 2009/3378 (W.300)) so that the definitions of Directive 08/60 and Directive 08/84 in that regulation include reference to the relevant amending Directive (regulation 2(2)).

**The Food Additives (Wales)
(Amendment) Regulations 2011**

Made 5 March 2011

Coming into force 31 March 2011

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(a) and (f), 17(1) and 48(1) of the Food Safety Act 1990(1) which are now vested in them(2).

In accordance with section 48(4A) of that Act, they have had regard to relevant advice given by the Food Standards Agency.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in

Title and commencement

1. The title of these Regulations is The Food Additives (Wales) (Amendment) Regulations 2011 and they come into force on 31 March 2011.

Amendment of the Food Additives (Wales) Regulations 2009

2.—(1) The Food Additives (Wales) Regulations 2009(2) are amended in accordance with paragraph (2).

(2) In paragraph (1) of regulation 2 (interpretation)—

- (a) at the end of the definition of "Directive 08/60" add the expression "as amended by Commission Directive 2010/37/EU amending Directive 2008/60 laying down specific purity criteria on sweeteners"; and
- (b) at the end of the definition of "Directive 08/84" add the expression "as amended by Commission Directive 2010/67/EU amending Directive 2008/84 laying down specific purity criteria on food additives other than colours and sweeteners".
