Mae'r Gorchymyn hwn yn sefydlu corfforaeth addysg bellach a elwir Coleg Caerdydd a'r Fro o dan adran 16(1)(a) o Ddeddf Addysg Bellach ac Uwch 1992 ("y Ddeddf") at y diben o redeg y sefydliad addysgol sydd â'r un enw. Mae'r Gorchymyn hefyd yn darparu ar gyfer pennu 1 Awst 2011 yn ddyddiad gweithredu at ddibenion Rhan 1 o'r Ddeddf, sef y dyddiad y bydd Coleg Caerdydd a'r Fro yn ymgymryd â rhedeg, o hynny ymlaen, y sefydliad addysgol o'r un enw.

This Order establishes a further education corporation called "Cardiff and Vale College" under section 16(1)(a) of the Further and Higher Education Act 1992 ("the Act") for the purpose of conducting the educational institution of the same name. The Order also provides for the appointment of 1 August 2011 as the operative date for the purposes of Part 1 of the Act, being the date from which Cardiff and Vale College is to conduct the educational institution of the same name.

This Order is made in exercise of the powers conferred on the Secretary of State by sections 16(1)(a) and 17 of the Further and Higher Education Act 1992(1) and now exercisable by the Welsh Ministers(2).

Mae Gweinidogion Cymru wedi cyhoeddi drafft a chrynodeb o'r Gorchymyn hwn yn unol ag adran 51(3)(3) o Ddeddf Addysg Bellach ac Uwch 1992 a Rheoliadau Corfforaethau Addysg Bellach (Cyhoeddi Gorchymynion Drafft) (Cymru) 2007(4).

The Welsh Ministers have published a draft and summary of this Order in accordance with section 51(3)(3) of the Further and Higher Education Act 1992 and the Further Education Corporations (Publication of Draft Orders) (Wales) Regulations 2007(4).

Corfforaeth Newydd

2. Ar 8 Ebrill 2011 sefydlir corff corfforaethol o'r enw Coleg Caerdydd a'r Fro, at ddibenion sefydlu a rhedeg, o'r dyddiad gweithredu ymlaen, sefydliad addysgol newydd o'r un enw.

Dyddiad gweithredu

3. Y dyddiad gweithredu a bennwyd mewn perthynas â Choleg Caerdydd a'r Fro yw 1 Awst 2011, a bydd y gorfforaeth yn rhedeg y sefydliad addysgol Coleg Caerdydd a'r Fro o'r dyddiad hwnnw ymlaen.

Accordingly, the Welsh Ministers make the following Order:

Title and commencement

1. The title of this Order is the Cardiff and Vale College (Incorporation) Order 2011 and it comes into force on 8 April 2011.

New Corporation

2. On 8 April 2011 a body corporate called Cardiff and Vale College is to be established, for the purposes of establishing and conducting from the operative date a new educational institution of the same name.

Operative date

3. The operative date appointed in relation to Cardiff and Vale College is 1 August 2011, and the corporation is to conduct the educational institution of Cardiff and Vale College from that date.
