The Welsh Ministers, in exercise of the powers conferred on them by sections 336(1) and (2) and 569(4) and (5) of the Education Act 1996(1) and after consulting the Administrative Justice and Tribunals Council in accordance with paragraph 24(1) of Schedule 7 to the Tribunals, Courts and Enforcement Act 2007(2), make the following Regulations.

Title, commencement and application

1.—(1) The title of these Regulations is the Special Educational Needs Tribunal for Wales (Amendment) Regulations 2012 and they come into force on 21 June 2012.

(2) These Regulations apply in relation to Wales.

**Amendments to the Special Educational Needs
Tribunal for Wales Regulations 2012**

2.—(1) The Special Educational Needs Tribunal for Wales Regulations 2012(3) are amended as follows.

(2) In regulation 13(4) (appeal application), in the Welsh text—
