Mae Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Disgyblu) 2001 ("Rheoliadau 2001") yn darparu ynglŷn â swyddogaethau disgyblu Cyngor Addysgu Cyffredinol Cymru ("y Cyngor"). Mae'r Rheoliadau hyn yn diwygio Rheoliadau 2001 o ganlyniad i Ddeddf Addysg 2011, sy'n darparu ar gyfer diddymu Cyngor Addysgu Cyffredinol Lloegr ("y CACL") ac yn gwneud darpariaethau newydd o ran gwahardd personau rhag cyflawni gwaith addysgu.

Mae rheoliad 2(2) o'r Rheoliadau hyn yn diwygio'r ddarpariaeth o ddiffiniadau yn Rheoliadau 2001 er mwyn cymryd i ystyriaeth ddiddymiad CACL a'r darpariaethau newydd a fewnosodwyd yn Nedd Addysg 2002 ("Deddf 2002") sy'n darparu bod gan yr Ysgrifennydd Gwladol y pŵer i wneud gorchymyn gwahardd sy'n gwahardd person rhag cyflawni gwaith addysgu.

Mae rheoliad 2(3) o'r Rheoliadau hyn yn diwygio rheoliad 9(1)(b) o Reoliadau 2001. Mae'r diwygiad yn ychwanegu darpariaeth yn ôl yr hon nid oes gan Bwyllgor Ymchwilio o'r Cyngor, fel y'i sefydlwyd o dan reoliad 3(1) o Reoliadau 2001, unrhyw swyddogaethau o ran ymchwilio i athro neu athrawes gofrestredig, o dan amgylchiadau lle mae'r Ysgrifennydd Gwladol yn dymuno ystyried yr achos gyda golwg ar arfer pwerau'r Ysgrifennydd Gwladol o dan adran 141B o Ddeddf 2002.

Mae rheoliad 2(4) o'r Rheoliadau hyn yn rhoi darpariaeth newydd yn lle rheoliad 25 o Reoliadau

The General Teaching Council for Wales (Disciplinary Functions) (Amendment) Regulations 2012

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

The General Teaching Council for Wales (Disciplinary Functions) Regulations 2001 ("the 2001 Regulations") make provision about the disciplinary functions of the General Teaching Council for Wales ("the Council"). These Regulations amend the 2001 Regulations as a consequence of the Education Act 2011, which provides for the abolition of the General Teaching Council for England ("the GTCE") and makes new provisions in relation to the prohibition of persons from carrying out teaching work.

Regulation 2(2) of these Regulations amends the definitions provision of the 2001 Regulations to account for the abolition of the GTCE and the new provisions inserted into the Education Act 2002 ("the 2002 Act") which provide for the Secretary of State to have the power to make a prohibition order prohibiting a person from carrying out teaching work.

Regulation 2(3) of these Regulations amends regulation 9(1)(b) of the 2001 Regulations. The amendment adds a provision whereby an Investigating Committee of the Council, as established under regulation 3(1) of the 2001 Regulations, has no functions in relation to investigation of a registered teacher, in circumstances where the Secretary of State wishes to consider the case with a view to exercising the Secretary of State's powers under section 141B of the 2002 Act.

Regulation 2(4) of these Regulations substitutes a new provision for regulation 25 of the 2001

2001, sy'n darparu y bydd gorchymyn gwahardd sydd wedi'i wneud gan yr Ysgrifennydd Gwladol o dan adran 141B o Ddeddf 2002 yn gymwys o ran Cymru fel y mae'n gymwys o ran Lloegr. Yr oedd y geiriad blaenorol sydd wedi ei ddiddymu yn rheoliad 25 yn gwneud darpariaeth gyffelyb o ran gorchymyn disgylbu a oedd wedi'i wneud gan CACLi.

Regulations which provides that a prohibition order made by the Secretary of State under section 141B of the 2002 Act will apply in relation to Wales as it applies in relation to England. The previous wording of regulation 25 that has been removed made a similar provision in relation to a disciplinary order made by the GTCE.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 6 a 42(6) a (7) o Ddeddf Addysgu ac Addysg Uwch 1998(1), a pharagraff 1(1) a (4) o Atodlen 2 iddi, ac sydd bellach wedi eu breinio ynddynt hwy(2), ac ar ôl ymgynghori â Chyngor Addysgu Cyffredinol Cymru yn unol ag adran 42(9) o'r Ddeddf honno:

**Enwi a chychwyn**

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Disgyblu) (Diwygio) 2012.

(2) Daw'r Rheoliadau hyn i rym ar y diwrnod y daw adran 8 o Ddeddf Addysg 2011(3) i rym.

The Welsh Ministers make the following Regulations in exercise of the powers conferred on the Secretary of State by sections 6 and 42(6) and (7) of, and paragraph 1(1) and (4) of Schedule 2 to, the Teaching and Higher Education Act 1998(1) and now vested in them(2), and having consulted the General Teaching Council for Wales in accordance with section 42(9) of that Act:

**Title and commencement**

1.—(1) The title of these Regulations is the General Teaching Council for Wales (Disciplinary Functions) (Amendment) Regulations 2012.

(2) These Regulations come into force on the day on which section 8 of the Education Act 2011(3) comes into force.

Cafodd paragraff 1(4) o Atodlen 2 ei ddiwygio gan baragraff 86(2) o Atodlen 21 i Ddeddf Addysg 2002 (p. 32) a'i ddiwygio ymhellach gan baragraffau 2 a 7 o Atodlen 9 i Ddeddf Diogelu Grwpiau Hyglwyf 2006 (p. 47). Am ystyr "prescribed" a "regulations" gweler adran 43(1).

## **Diwygio Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Disgyblu) 2001**

**2.**—(1) Diwygir Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Disgyblu) 2001(1) fel a ganlyn.

(2) Yn rheoliad 2(1)—

- (a) hepgorer y geiriau "neu Loegr" yn y diffiniad o "gorchymyn disgyblu".
- (b) mewnosoder, yn y man priodol yn ôl trefn yr wyddor, y diffiniad a ganlyn—

"ystyr "gorchymyn gwahardd" ("prohibition order") mewn perthynas ag athro neu athrawes yn Lloegr yw gorchymyn gwahardd sydd wedi'i wneud gan yr Ysgrifennydd Gwladol o dan adran 141B o Ddeddf Addysg 2002(2);".

- (c) hepgorer y geiriau "neu Loegr" yn y diffiniad o "achos disgyblu".
- (ch) rhodder y canlynol yn lle'r diffiniad o "tramgwydd perthnasol"—

"mae i "tramgwydd perthnasol", o ran Cymru, yr un ystyr ag sydd i "relevant offence" yn Atodlen 2 i Ddeddf 1998, ac o ran Lloegr mae iddo'r un ystyr ag sydd i "relevant offence" yn adran 141B(4) o Ddeddf Addysg 2002;".

(3) Yn rheoliad 9(1)(b) hepgorer y geiriau "neu'r Ysgrifennydd Gwladol" ar yr achlysur cyntaf y maent yn ymddangos, ac ychwanegor y canlynol ar ôl y geiriau "o dan adran 142 o Ddeddf Addysg 2002"—

"neu fod yr Ysgrifennydd Gwladol yn dymuno ystyried yr achos gyda'r bwriad o arfer pwerau'r Ysgrifennydd Gwladol o dan adran 141B o Ddeddf Addysg 2002".

(4) Rhodder y canlynol yn lle rheoliad 25—

## **"25 Gorchmyntion gwahardd**

Bydd gorchymyn gwahardd yn gymwys o ran Cymru fel y mae'n gymwys o ran Lloegr.".

## **Amendment of the General Teaching Council for Wales (Disciplinary Functions) Regulations 2001**

**2.**—(1) The General Teaching Council for Wales (Disciplinary Functions) Regulations 2001(1) are amended as follows.

(2) In regulation 2(1)—

- (a) omit the words "or England" in the definition of "disciplinary order".
- (b) insert in the appropriate place in the alphabetical order the following definition—

"prohibition order" ("gorchymyn gwahardd") in relation to a teacher in England means a prohibition order made by the Secretary of State under section 141B of the Education Act 2002(2);".

- (c) omit the words "or England" in the definition of "disciplinary proceedings".
- (d) substitute for the definition of "relevant offence" the following—

"relevant offence" ("tramgwydd perthnasol") in relation to Wales has the same meaning as in Schedule 2 to the 1998 Act and in relation to England has the same meaning as in section 141B(4) of the Education Act 2002;".

(3) In regulation 9(1)(b) omit the words "or the Secretary of State" on the first occasion that they appear and add the following after the words "under section 142 of the Education Act 2002"—

"or the Secretary of State wishes to consider the case with a view to exercising the Secretary of State's powers under section 141B of the Education Act 2002".

(4) Substitute the following for regulation 25—

## **"25 Prohibition orders**

A prohibition order will apply in relation to Wales as it applies in relation to England.".
