Mae'r Gorchymyn hwn, sy'n gymwys o ran Cymru, yn gwahardd pysgota am bysgod môr â chychedd pysgota sy'n defnyddio offer pysgota sy'n llusgo'r gwaelod o fewn yr ardaloedd môr penodedig.

Mae darpariaethau'r Gorchymyn hwn hefyd yn dirymu ac yn disodli Is-ddeddf 21 cyn Bwyllgor Pysgodfeydd Môr Gogledd-orllewin Lloegr a Gogledd Cymru ("y Pwyllgor Pysgodfeydd Môr").

Diddymwyd y Pwyllgor Pysgodfeydd Môr, o ran Cymru, ar 1 Ebrill 2010 pan ddiddymwyd Deddf Rheoleiddio Pysgodfeydd Môr 1966, o ran Cymru, gan adran 187 o Ddeddf y Môr a Mynediad i'r Arfordir 2009. Er y dyddiad hwnnw, mae Is-ddeddf 21 y Pwyllgor Pysgodfeydd Môr wedi cael effaith fel pe bai wedi ei gwneud gan Weinidogion Cymru mewn offeryn statudol yn rhinwedd erthygl 13(3) o Orchymyn Deddf y Môr a Mynediad i'r Arfordir 2009 (Cychwyn Rhif 1, Darpariaethau Canlyniadol, Trosiannol a Darpariaethau Arbed) (Cymru a Lloegr) 2010 ac Atodlen 4 iddo.

Gwaharddodd Is-ddeddf 21 y Pwyllgor Pysgodfeydd Môr y defnydd o offer pysgota sy'n llusgo'r gwaelod oddi ar unrhyw gwch pysgota o fewn un o'r ardaloedd môr penodedig y rhoddir manylion amdanynt yn yr Atodlen i'r Gorchymyn hwn.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order, which applies in relation to Wales, prohibits fishing for sea fish with fishing boats using bottom towed fishing gear within the specified sea areas.

The provisions of this Order also revoke and replace Byelaw 21 of the former North Western and North Wales Sea Fisheries Committee ("the Sea Fisheries Committee").

The Sea Fisheries Committee was abolished, in relation to Wales, on 1 April 2010 when the Sea Fisheries Regulation Act 1966 was repealed in relation to Wales by section 187 of the Marine and Coastal Access Act 2009. Since that date, Byelaw 21 of the Sea Fisheries Committee has had effect as though made by the Welsh Ministers in a statutory instrument by virtue of article 13(3) of and Schedule 4 to the Marine and Coastal Access Act 2009 (Commencement No. 1, Consequential, Transitional and Savings Provisions) (England and Wales) Order 2010.

Byelaw 21 of the Sea Fisheries Committee prohibited the use of bottom towed fishing gear from any fishing boat within one of the specified sea areas detailed in the Schedule to this Order.

Article 3 of this Order prohibits fishing for sea fish within the specified sea areas using bottom towed fishing gear and requires that all bottom towed fishing

Article 4 of this Order revokes Byelaw 21 of the Sea Fisheries Committee and makes the necessary consequential amendment to the Marine and Coastal Access Act 2009 (Commencement No. 1, Consequential, Transitional and Savings Provisions) (England and Wales) Order 2010.

**Enwi, cychwyn a chymhwysyo**

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Pysgod Môr (Ardaloedd Môr Penodedig) (Gwahardd Dull Pysgota) (Cymru) 2012 a daw i rym ar 1 Tachwedd 2012.

(2) Mae'r Gorchymyn hwn yn gymwys o ran Cymru.

2. Yn y Gorchymyn hwn—

ystyr "ardaloedd môr penodedig" ("specified sea areas") yw'r ardaloedd a ddisgrifir yn yr Atodlen i'r Gorchymyn hwn;

(2) Yn rhinwedd erthygl 2(a) o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac Atodlen 1 iddo, trosglwyddwyd y swyddogaethau a oedd yn arferadwy o dan adran 5 o Ddeddf 1967 i Gynulliad Cenedlaethol Cymru (fel y'i cyfansoddwyd o dan Ddeddf Llywodraeth Cymru 1998 (p.38)) i'r graddau yr oeddent yn arferadwy o ran Cymru. Trosglwyddwyd y swyddogaethau hynny a oedd gan Gynulliad Cenedlaethol Cymru i Weinidogion Cymru yn rhinwedd adran 162 o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30 o Atodlen 11 iddi.

The Welsh Ministers make the following Order in exercise of the powers conferred by sections 5(1) and (1B), 5A(1) and 20(1) of the Sea Fish (Conservation) Act 1967(1) which are now vested (2) in them.

**Title, commencement and application**

1.—(1) The title of this Order is the Sea Fish (Specified Sea Areas) (Prohibition of Fishing Method) (Wales) Order 2012 and it comes into force on 1 November 2012.

(2) This Order applies in relation to Wales.

**Interpretation**

2. In this Order—

"bottom towed fishing gear" ("offer pysgota sy'n llusgo'r gwaelod") means any fishing gear or equipment which is capable of being towed, dragged or moved along the seabed including, but not limited to, any fishing dredge, beam trawl or otter trawl;

(2) By virtue of article 2(a) of and Schedule 1 to the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) the functions exercisable under section 5 of the 1967 Act were transferred to the National Assembly for Wales (as constituted under the Government of Wales Act 1998 (c.38)) in so far as exercisable in relation to Wales. Those functions of the National Assembly for Wales were transferred to the Welsh Ministers by virtue of section 162 of and paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32).

ystyr "cyfesuryn" ("co-ordinate") yw cyfesuryn lledred a hydred wedi ei roi mewn graddau, munudau a ffracsynau degol o funud ar System Geodetic y Byd 1984;

mae i "Cymru" yr ystyr a roddir i "Wales" yn adran 158 o Ddeddf Llywodraeth Cymru 2006(1); ac

ystyr "offer pysgota sy'n llusgo'r gwaelod" ("bottom towed fishing gear") yw unrhyw offer neu gyfarpar pysgota a all gael eu llusgo, eu tynnu neu eu symud ar hyd gwely'r môr gan gynnwys unrhyw lusgrwyd bysgota, treillrwyd drawst neu dreillrwyd estyllod, ond heb fod yn gyfyngedig iddynt.

## Gwaharddiad

3.—(1) Mae pysgota am bysgod môr o fewn yr ardaloedd môr penodedig gan ddefnyddio offer pysgota sy'n llusgo'r gwaelod drwy hyn wedi ei wahardd.

(2) Pan fo unrhyw gwch pysgota o fewn yr ardaloedd môr penodedig rhaid i'r holl offer pysgota sy'n llusgo'r gwaelod fod wedi eu stowio a'u diogelu y tu mewn i'r cwch.

## Dirymu a Diwygiad Canlyniadol

4.—(1) Mae Is-ddeddf 21 (Gwahardd Offer Pysgota sy'n Llusgo'r Gwaelod)(2) cyn Bwyllgor Pysgodfeydd Môr Gogledd-orllewin Lloegr a Gogledd Cymru(3) wedi ei dirymu o ran Cymru.

(2) Yn y Tabl yn Atodlen 4 i Orchymyn Deddf y Môr a Mynediad i'r Arfordir 2009 (Cychwyn Rhif 1, Darpariaethau Canlyniadol, Trosiannol a Darpariaethau Arbed) (Cymru a Lloegr) 2010(4) mae'r rhes sy'n ymwneud ag Is-ddeddf 21 wedi ei dileu.

"co-ordinate" ("cyfesuryn") means a co-ordinate of latitude and longitude given in degrees, minutes and decimal fractions of a minute on the World Geodetic System 1984;

"specified sea areas" ("ardaloedd môr penodedig") means the areas described in the Schedule to this Order; and

"Wales" ("Cymru") has the meaning given in section 158 of the Government of Wales Act 2006(1).

## Prohibition

3.—(1) Fishing for sea fish within the specified sea areas using bottom towed fishing gear is hereby prohibited.

(2) All bottom towed fishing gear must be inboard, stowed and secured when any fishing boat is within the specified sea areas.

## Revocation and Consequential Amendment

4.—(1) Byelaw 21 (Prohibition of Bottom Towed Fishing Gear)(2) of the former North Western and North Wales Sea Fisheries Committee(3) is revoked in relation to Wales.

(2) In the Table in Schedule 4 to the Marine and Coastal Access Act 2009 (Commencement No. 1, Consequential, Transitional and Savings Provisions) (England and Wales) Order 2010(4) the row relating to Byelaw 21 is deleted.
