**EXPLANATORY NOTE**

Mae'r Rheoliadau hyn yn rhagnodi'r amgylchiadau pan gaiff awdurdod derbyn amrywio'r trefniadau derbyn y mae wedi penderfynu arnynt ar gyfer blwyddyn ysgol benodol (yn ychwanegol at yr amgylchiadau a nodir yn adran 89(5) o Ddeddf Safonau a Fframwaith Ysgolion 1998 ("DSFfY 1998")).

These Regulations prescribe the circumstances in which an admission authority may vary the admission arrangements they have determined for a particular school year (in addition to the circumstances set out in section 89(5) of the School Standards and Framework Act 1998 ("SSFA 1998")).

Mae rheoliad 3 yn darparu y caiff awdurdod derbyn, heb unrhyw weithdrefnau pellach na chymeradwyaeth gan Weinidogion Cymru, amrywio'r trefniadau derbyn y mae wedi penderfynu arnynt ar gyfer unrhyw grŵp oedran perthnasol pan fo angen amrywiad o'r fath er mwyn rhoi effaith i'r Cod Derbyniadau Ysgol; rhoi'r cynigion a gymeradwywyd ar waith; neu gywiro unrhyw beth a hepgorwyd o'r trefniadau derbyn neu unrhyw wall argraffu ynddynt.

Regulation 3 provides that an admission authority may, without further procedures or approval from the Welsh Ministers, vary the admission arrangements that they have determined for any relevant age group where such a variation is necessary to give effect to the School Admissions Code; the implementation of approved proposals; or a correction to any omission or misprint in the admission arrangements.

O dan yr amgylchiadau hynny, nid yw'r gweithdrefnau ar gyfer newid trefniadau derbyn yn adran 89(5) i (7) o DSFfY 1998 yn gymwys.

In those circumstances, the procedures for changing admission arrangements in section 89(5) to (7) of the SSFA 1998 do not apply.

Ni chynhaliwyd asesiad effaith rheoleiddiol ar gyfer yr offeryn hwn gan nad yw'n cael effaith arwyddocaol ar gostau busnesau, elusennau, cyrff gwirfoddol na'r sector cyhoeddus.

No regulatory impact assessment has been carried out for this instrument as it has no significant impact on the costs of business, charities, voluntary bodies or the public sector.

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(4) Mae Rheoliadau Addysg (Amrywio Trefniadau Derbyn) (Cymru) 2006(2) wedi eu dirymu.

2.—(1) Yn y Rheoliadau hyn—

ystyr "Cod Derbyniadau Ysgol" ("*School Admissions Code*") yw unrhyw god ar gyfer derbyniadau ysgol a ddyroddwyd o dan adran 84 o DSFFY 1998;

ystyr "cynigion a gymeradwywyd" ("*approved proposals*") yw—

Mae adran 90ZA yn darparu, yn adrannau 89 i 90 o DSFFY 1998, mai ystyr "prescribed" yw wedi ei ragnodi gan Weinidogion Cymru ac ystyr "regulations" yw rheoliadau a wnaed gan Weinidogion Cymru. The Welsh Ministers in exercise of their powers in sections 89(8)(e) and 138A of the School Standards and Framework Act 1998(1) make the following Regulations:

**Title, commencement, application and revocation**

1.—(1) The title of these Regulations is the School Admissions (Variation of Admission Arrangements) (Wales) Regulations 2013.

(2) These Regulations come into force on 8 July 2013.

(3) These Regulations apply in relation to Wales.

(4) The Education (Variation of Admission Arrangements) (Wales) Regulations 2006(2) are revoked.

**Interpretation**

2.—(1) In these Regulations—

"the SSFA 1998" ("*DSFFY 1998*") means the School Standards and Framework Act 1998;

"the SSOA 2013" ("*DSThY 2013*") means the School Standards and Organisation (Wales) Act 2013(3);

"approved proposals" ("*cynigion a gymeradwywyd*") means—

ystyr "DSFFY 1998" ("*the SSFA 1998*") yw Deddf Safonau a Fframwaith Ysgolion 1998;

ystyr "DSThY 2013" ("*the SSOA 2013*") yw Deddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013(1).

### Amrywio trefniadau derbyn

3.—(1) Mae'r rheoliad hwn yn rhagnodi at ddibenion adran 89(8)(e) o DSFFY 1998 yr amgylchiadau pan gaiff awdurdod derbyn, ar ôl penderfynu ar y trefniadau derbyn(2) sydd i fod yn gymwys ar gyfer blwyddyn ysgol benodol, (yn ychwanegol at yr amgylchiadau hynny a nodir yn adran 89(5)) amrywio'r trefniadau hynny.

(2) Caiff awdurdod derbyn amrywio'r trefniadau derbyn i'r graddau y mae angen amrywiad o'r fath er mwyn rhoi effaith i unrhyw un neu ragor o'r canlynol—

- (a) y Cod Derbyniadau Ysgol;
- (b) rhoi'r cynigion a gymeradwywyd ar waith; neu
- (c) cywiro unrhyw beth a hepgorwyd o'r trefniadau derbyn neu unrhyw wall argraffu ynddynt.

- (a) until such time as section 99 of, and Schedule 5 to the SSOA 2013 (in so far as they repeal paragraphs 8 and 9 of Schedule 6 to the SSFA 1998) have been commenced—
- (i) proposals published under sections 28 or 29 of the SSFA 1998 that have been approved under paragraph 8 of Schedule 6 to that Act, or
- (ii) proposals published under sections 28 or 29 of the SSFA 1998 that a body or promoter who published them has determined should be implemented under paragraph 9 of Schedule 6 to that Act; and
- (b) upon the commencement of section 99 of, and Schedule 5 to the SSOA 2013 (in so far as they repeal paragraphs 8 and 9 of Schedule 6 to the SSFA 1998) have been commenced—
- (i) proposals published under section 48 of the SSOA 2013 that have been approved under section 50 or 51 of the SSOA 2013, or
- (ii) proposals published under section 49 of the SSOA 2013 that a proposer who published them has determined should be implemented under section 53 of the SSOA 2013.

"School Admissions Code" ("*Cod Derbyniadau Ysgol*") means any code for school admissions issued under section 84 of the SSFA 1998

### Variation of admission arrangements

3.—(1) This regulation prescribes for the purposes of section 89(8)(e) of the SSFA 1998 the circumstances in which an admission authority, having determined the admission arrangements(1) which are to apply for a particular school year, may (in addition to those circumstances set out in section 89(5)) vary those arrangements.

(2) An admission authority may vary the admission arrangements to the extent that such variation is necessary to give effect to any of the following—

- (a) the School Admissions Code;
- (b) the implementation of approved proposals; or
- (c) a correction to any omission or misprint in the admission arrangements.
