EXPLANATORY NOTE

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn pennu ffioedd sy'n daladwy i Weinidogion Cymru ym maes iechyd planhigion. Maent yn dirymu ac yn disodli Rheoliadau Iechyd Planhigion (Ffioedd) (Cymru) 2012 (O.S. 2012/1493 (Cy.191)) ("Rheoliadau 2012") (rheoliad 7). Nid ydynt yn cyflwyno unrhyw fathau newydd o ffi na ddarparwyd ar eu cyfer yn Rheoliadau 2012.

These Regulations, which apply in relation to Wales specify fees payable to the Welsh Ministers in the field of plant health. They revoke and replace the Plant Health (Fees) (Wales) Regulations 2012 (S.I. 2012/1493 (W.191)) (the "2012 Regulations") (regulation 7). They do not introduce any new types of fee which were not provided for in the 2012 Regulations.

Mae'r ffioedd yn daladwy mewn perthynas ag arolygiadau penodedig a gweithrediadau eraill a gyflawnir yn unol â Chyfarwyddeb y Cyngor 2000/29/EC ar fesurau i amddiffyn rhag dwyn i mewn i'r Gymuned organebau sy'n niweidiol i blanhigion neu gynhyrchion planhigion, a rhag i'r organebau hynny ymledu o fewn y Gymuned (OJ Rhif L 169, 10.7.2000, t.1).

The fees are payable in relation to specified inspections and other operations carried out pursuant to Council Directive 2000/29/EC on protective measures against the introduction into the Community of organisms harmful to plants or plant products and against their spread within the Community (OJ No L 169, 10.7.2000, p.1).

Pennir y ffioedd am wiriadau dogfennol, gwiriadau adnabod a gwiriadau iechyd planhigion mewn perthynas â mewnfurion penodol o blanhigion, cynhyrchion planhigion a gwrthrychau eraill o drydydd gwledydd (rheoliad 2 ac Atodlenni 1, 2 a 3) yn unol â'r gofyniad yn Erthygl 13d o Gyfarwyddeb 2000/29/EC.

The fees for documentary, identity and plant health checks in relation to certain imports of plants, plant products and other objects from third countries (regulation 2 and Schedules 1, 2 and 3) are specified pursuant to the requirement in Article 13d of Council Directive 2000/29/EC.

Lefelau'r ffioedd y darperir ar eu cyfer yn y Rheoliadau hyn yw'r ail ran o symudiad fesul cam, dros gyfnod o dair blynedd, tuag at ffioedd sy'n adennill y gost lawn. Mae'r Rheoliadau hyn yn darparu ar gyfer cynnydd cyfartalog ar y ffioedd a bennwyd yn Rheoliadau 2012 fel a ganlyn:

The fee levels provided for in these Regulations form the second part of a phased move towards full cost recovery of fees over a period of three years. These Regulations provide for average increases on the fees specified in the 2012 Regulations as follows:

(1) ffioedd arolygu mewnfurio (heblaw gwiriad dogfennol a gwiriad adnabod) yn ôl 5% (rheoliad 2 ac Atodlenni 1 a 2);

(1) import inspection fees (other than documentary and identity checks) by 5% (regulation 2 and Schedules 1 and 2);

(2) ffioedd ynglŷn ag arolygu tatws hadyd yn ôl 5% (rheoliad 3 ac Atodlen 4);

(3) ffioedd trwyddedu yn ôl 1.6% (rheoliad 4 ac Atodlen 5);

(4) ffioedd am wasanaethau pasbortau planhigion yn ôl 20% (rheoliad 5); a

(5) ffioedd am arolygu tatws sy'n tarddu o'r Aiff yn ôl 25% (rheoliad 6).

Mae'r Rheoliadau hyn hefyd yn darparu ar gyfer gostyngiad o 19% ar y ffioedd a bennwyd yn Rheoliadau 2012 am wiriad dogfennol a gwiriad adnabod wrth fewnforio (rheoliad 2 ac Atodlen 3). Ceir rhagor o fanylion yn y Memorandwm Esboniadol.

Cafodd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol ei ystyried o ran y Rheoliadau hyn. O ganlyniad, mae asesiadau effaith rheoleiddiol wedi eu paratoi ynghylch yr effaith a gaiff yr offeryn hwn ar gostau busnes, o ran pob un o'r pum math o ffioedd yr ymdrinnir â hwy yn yr offeryn hwn a gellir eu cael oddi wrth Adran yr Amgylchedd a Datblygu Cynaliadwy, Llywodraeth Cymru, Parc Cathays, Caerdydd CF10 3NQ.

(2) fees relating to seed potato inspections by 5% (regulation 3 and Schedule 4);

(3) licensing fees by 1.6% (regulation 4 and Schedule 5);

(4) fees for plant passporting services by 20% (regulation 5); and

(5) fees for inspections of potatoes originating in Egypt by 25% (regulation 6).

These Regulations also provide for decreases by 19% on the fees specified in the 2012 Regulations for import inspection documentary and identity checks (regulation 2 and Schedule 3). Further details are provided in the Explanatory Memorandum.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, regulatory impact assessments of the effect that this instrument will have on the costs of business, in relation to each of the five types of fees covered by this instrument, have been prepared and are available from the Department of Environment and Sustainable Development, Welsh Government, Cathays Park, Cardiff CF10 3NQ.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn, â chydysyniad y Trysorlys, drwy arfer pwerau a roddir gan adran 56(1) a (2) o Deddf Cyllid 1973(1) ac sydd bellach wedi eu breinio ynddynt hwy(2).

The Welsh Ministers make these Regulations, with the consent of the Treasury, in exercise of powers conferred by section 56(1) and (2) of the Finance Act 1973(1) and now vested in them(2).

Enwi, cymhwyso, cychwyn a dehongli

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Iechyd Planhigion (Ffioedd) (Cymru) 2013. Maent yn gymwys o ran Cymru a deuant i rym ar 2 Awst 2013.

(2) Yn y Rheoliadau hyn—

- (a) ystyr “y Gyfarwyddeb (“*the Directive*”) yw Cyfarwyddeb y Cyngor 2000/29/EC ar fesurau i amddiffyn rhag dwyn i mewn i'r Gymuned organebau sy'n niweidiol i blanhigion neu gynhyrchion planhigion, a rhag i'r organebau hynny ymledu o fewn y Gymuned(3); a
- (b) ystyr “y GIP” (“*the PHO*”) yw Gorchymyn Iechyd Planhigion (Cymru) 2006(4).

Title, application, commencement and interpretation

1.—(1) The title of these Regulations is the Plant Health (Fees) (Wales) Regulations 2013. They apply in relation to Wales and come into force on 2 August 2013.

(2) In these Regulations—

- (a) “the Directive” (“*y Gyfarwyddeb*”) means Council Directive 2000/29/EC on protective measures against the introduction into the Community of organisms harmful to plants or plant products and against their spread within the Community(3); and
- (b) “the PHO” (“*y GIP*”) means the Plant Health (Wales) Order 2006(4).

(3) Mae i'r termau a ddefnyddir yn y Rheoliadau hyn, ac y defnyddir eu cyfystyron Saesneg yn y Gyfarwyddeb, yr un ystyr yn y Rheoliadau hyn ag a roddir i'w cyfystyron Saesneg yn y Gyfarwyddeb.

Ffioedd arolygu mewnforio

2.—(1) Mae'r rheoliad hwn yn gymwys o ran llwythi o'r canlynol—

- (a) planhigion, cynhyrchion planhigion a gwrthrychau eraill o ddisgrifiad a bennir yng ngholofn 1 o Atodlen 1 a restrir yn Rhan B o Atodiad V i'r Gyfarwyddeb, a
- (b) hadau *Solanaceae*, pa un a restrir hwy ai peidio yn y Rhan honno,

a ddygir i mewn i Gymru o wlad neu diriogaeth ac eithrio un sydd o fewn yr Undeb Ewropeaidd neu sy'n destun cytundeb a wnaed o dan erthygl 12(6) o'r GIP.

(2) Ar yr adeg y mewnfir llwyth y mae'r rheoliad hwn yn gymwys iddo, rhaid i'r mewnfirwr dalu i Weinidogion Cymru—

- (a) y ffi a bennir—
 - (i) yng ngholofn 3 o Atodlen 1 mewn perthynas â llwyth o blanhigyn, cynnyrch planhigion neu wrthrych arall a restrir yng ngholofn 1 o'r Atodlen honno, ac eithrio llwyth o blanhigyn neu gynnyrch planhigion y mae paragraff (ii) o'r is-baragraff hwn yn gymwys iddo; neu
 - (ii) yng ngholofn 4 o Atodlen 2 mewn perthynas â llwyth o blanhigyn neu gynnyrch planhigion a restrir yng ngholofn 1 o'r Atodlen honno ac sy'n tarddu o wlad a restrir yng ngholofn 3 o'r Atodlen honno; a
- (b) y ffioedd a bennir yng ngholofn 3 o Atodlen 3 am wiriad dogfennol a gwiriad adnabod.

(3) Ond, pan gynhelir gwiriad iechyd planhigion ar lwyth y tu allan i oriau gwaith yn ystod y dydd, a hynny ar gais y mewnfirwr neu unrhyw berson arall sy'n gyfrifol am y llwyth, y ffi sy'n daladwy o dan baragraff (2)(a) mewn perthynas â'r llwyth hwnnw yw—

- (a) y ffi a bennir yng ngholofn 4 o Atodlen 1 os yw'r llwyth yn un y mae paragraff (2)(a)(i) yn gymwys iddo; neu
- (b) y ffi a bennir yng ngholofn 5 o Atodlen 2 os yw'r llwyth yn un y mae paragraff (2)(a)(ii) yn gymwys iddo.

(3) Terms used in these Regulations which are also used in the Directive have the meaning they have in the Directive.

Import inspection fees

2.—(1) This regulation applies in relation to consignments of—

- (a) plants, plant products and other objects of a description specified in column 1 of Schedule 1 that are listed in Part B of Annex V to the Directive, and
- (b) seeds of *Solanaceae* whether or not listed in that Part,

that are introduced into Wales from a country or territory other than one within the European Union or are the subject of an agreement made under article 12(6) of the PHO.

(2) Upon import of a consignment to which this regulation applies, an importer must pay to the Welsh Ministers—

- (a) the fee specified—
 - (i) in column 3 of Schedule 1 in respect of a consignment of a plant, plant product or other object listed in column 1 of that Schedule, other than a consignment of a plant or plant product to which paragraph (ii) of this sub-paragraph applies, or
 - (ii) in column 4 of Schedule 2 in respect of a consignment of a plant or plant product listed in column 1 of that Schedule and originating from a country listed in column 3 of that Schedule; and
- (b) the fees specified in column 3 of Schedule 3 for a documentary check and an identity check.

(3) But where, at the request of an importer or any other person responsible for the consignment, a plant health check is carried out on a consignment outside daytime working hours, the fee payable under paragraph (2)(a) in respect of that consignment is—

- (a) the fee specified in column 4 of Schedule 1 if the consignment is a consignment to which paragraph (2)(a)(i) applies; or
- (b) the fee specified in column 5 of Schedule 2 if the consignment is a consignment to which paragraph (2)(a)(ii) applies.

(4) Yn y rheoliad hwn, ystyr “oriau gwaith yn ystod y dydd” (“*daytime working hours*”) yw unrhyw amser rhwng yr oriau 8.30 a.m. a 5.00 p.m. ar unrhyw ddiwrnod ac eithrio dydd Sadwrn, dydd Sul, Dydd Nadolig, Dydd Gwener y Groglith neu ddiwrnod sy'n wyl banc o dan Ddeddf Bancio a Thrafodion Ariannol 1971(1).

Tatws hadyd: ffioedd

3.—(1) Mae'r ffioedd a bennir yn Atodlen 4 yn daladwy mewn perthynas â'r swyddogaethau a bennir yng ngholofn 1 o'r Atodlen honno, sy'n ymwneud â chais am y canlynol—

- (a) ardystiad o datws hadyd yn unol â rheoliad 9 o'r Rheoliadau Tatws Hadyd;
- (b) awdurdodiad i farchnata tatws hadyd yn unol â rheoliad 8 o'r Rheoliadau hynny.

(2) Mae'r ffi sy'n daladwy mewn perthynas â swyddogaeth yn ddarostyngedig i unrhyw leiafswm ffi a bennir yng ngholofn 3 o Atodlen 4 mewn perthynas â'r swyddogaeth honno.

(3) Rhaid talu'r ffi mewn perthynas â swyddogaeth a bennir yn Atodlen 4 i Weinidogion Cymru neu i unrhyw berson a awdurdodir gan Weinidogion Cymru i gyflawni'r swyddogaeth honno o dan y Rheoliadau Tatws Hadyd ar ran Gweinidogion Cymru.

(4) Yn y rheoliad hwn, ystyr “y Rheoliadau Tatws Hadyd” (“*the Seed Potatoes Regulations*”) yw Rheoliadau Tatws Hadyd (Cymru) 2006(2).

Ffioedd am drwyddedau iechyd planhigion

4.—(1) Mae'r ffioedd sy'n daladwy o dan y rheoliad hwn yn ymwneud â thrwydded a ddisgrifir yn erthygl 40 neu 41 o'r GIP.

(2) Mewn perthynas â chais neu arolygiad o fath a ddisgrifir yng ngholofn 2 o Atodlen 5, rhaid i berson dalu i Weinidogion Cymru y ffi a bennir yng ngholofn 3 o'r Atodlen honno mewn perthynas â'r math hwnnw o gais neu arolygiad.

Ffioedd am awdurdodi pasbortau planhigion

5.—(1) Rhaid talu'r ffi a bennir ym mharagraff (2) i Weinidogion Cymru mewn perthynas ag unrhyw arolygiad (gan gynnwys arolygiad o gofnodion busnes) a gyflawnir mewn cysylltiad â'r canlynol—

- (a) cais am awdurdod; neu

(4) In this regulation “daytime working hours” (“*oriau gwaith yn ystod y dydd*”) means any time between the hours of 8.30 a.m. and 5.00 p.m. on any day except a Saturday, Sunday, Christmas Day, Good Friday or a day which is a bank holiday in Wales under the Banking and Financial Dealings Act 1971(1).

Seed potatoes: fees

3.—(1) The fees specified in Schedule 4 are payable in respect of the functions specified in column 1 of that Schedule, which relate to an application for—

- (a) certification of seed potatoes in accordance with regulation 9 of the Seed Potatoes Regulations;
- (b) an authorisation to market seed potatoes in accordance with regulation 8 of those Regulations.

(2) The fee payable in respect of a function is subject to any minimum fee specified in column 3 of Schedule 4 in relation to that function.

(3) The fee in respect of a function specified in Schedule 4 must be paid to the Welsh Ministers or to any person authorised by the Welsh Ministers to carry out that function under the Seed Potatoes Regulations on behalf of the Welsh Ministers.

(4) In this regulation “the Seed Potatoes Regulations” (“*y Rheoliadau Tatws Hadyd*”) means the Seed Potatoes (Wales) Regulations 2006(2).

Plant health licence fees

4.—(1) Fees payable under this regulation relate to a licence described in article 40 or 41 of the PHO.

(2) In respect of an application or inspection of a type described in column 2 of Schedule 5, a person must pay to the Welsh Ministers the fee specified in column 3 of that Schedule in relation to that type of application or inspection.

Plant passport authorisation fees

5.—(1) The fee specified in paragraph (2) must be paid to the Welsh Ministers in respect of an inspection (which may include an inspection of business records) carried out in connection with—

- (a) an application for an authority; or

(b) sicrhau y cydymffurfir ag unrhyw ofynion a osodir ar ddeiliad awdurdod.

(2) Y ffi yw £38.05(1) am bob chwarter awr neu ran o chwarter awr (gan gynnwys yr amser a dreulir ar arolygu, ar deithio ac ar weinyddu cysylltiedig), yn ddarostyngedig i leiafswm ffi o £76.10(2) am bob ymweliad.

(3) Yn y rheoliad hwn ystyr “awdurdod” (“*authority*”) yw awdurdod i ddyroddi pasbortau planhigion a roddir o dan erthygl 8 o Orchymyn Iechyd Planhigion (*Phytophthora ramorum*) (Cymru) 2006(3) neu erthygl 29 o'r GIP.

Tatws sy'n tarddu o'r Aiff: ffioedd

6.—(1) Pan fo arolygydd yn cymryd sampl o datws sy'n tarddu o'r Aiff, er mwyn canfod, at ddibenion paragraff 5 o'r Atodiad i'r Penderfyniad, a yw'r tatws hynny wedi eu heintio â *Ralstonia solanacearum* (Smith) Yabuuchi et al., rhaid i'r mewnoforiwr dalu i Weinidogion Cymru ffi o £117.36(4) mewn perthynas â phob lot y cymerir sampl ohoni.

(2) Yn y rheoliad hwn ystyr “y Penderfyniad” (“*the Decision*”) yw Penderfyniad Gweithredu'r Comisiwn 2011/787/EU sy'n awdurdodi Aelod-wladwriaethau i weithredu mesurau argyfwng dros dro yn erbyn lledaenu *Ralstonia solanacearum* (Smith) Yabuuchi et al., mewn cysylltiad â'r Aiff(5).

(b) ensuring compliance with any requirements imposed on the holder of an authority.

(2) The fee is £38.05(1) for each quarter of an hour or part of quarter of an hour (including time spent on an inspection, on travelling and on associated administration), subject to a minimum fee of £76.10(2) per visit.

(3) In this regulation “authority” (“*awdurdod*”) means an authority to issue plant passports conferred under article 8 of the Plant Health (*Phytophthora ramorum*) (Wales) Order 2006(3) or article 29 of the PHO.

Potatoes originating in Egypt: fees

6.—(1) Where an inspector takes a sample of potatoes originating in Egypt in order to ascertain whether, for the purposes of paragraph 5 of the Annex to the Decision, those potatoes are infected with *Ralstonia solanacearum* (Smith) Yabuuchi et al., the importer must pay to the Welsh Ministers £117.36(4) in respect of each lot sampled.

(2) In this regulation “the Decision” (“*y Penderfyniad*”) means Commission Implementing Decision 2011/787/EU authorising Member States temporarily to take emergency measures against the dissemination of *Ralstonia solanacearum* (Smith) Yabuuchi et al. as regards Egypt(5).

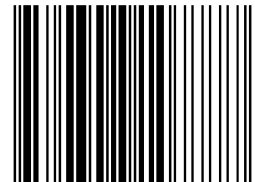
