Mae'r Gorchymyn hwn yn diddymu'r gorfforaeth addysg uwch a sefydlwyd i redeg Prifysgol Cymru, Casnewydd ("Prifysgol Casnewydd"). Sefydlwyd Prifysgol Casnewydd fel corfforaeth addysg uwch o'r enw Coleg Addysg Uwch Gwent o dan adran 122 o Ddeddf Diwygio Addysg 1988 a newidodd ei henw i Goleg Prifysgol Cymru, Casnewydd ac wedi hynny i Brifysgol Cymru, Casnewydd gyda chydysniad y Cyfrin Gyngor.

Mae'r Gorchymyn hwn yn darparu i'r holl eiddo, hawliau a rhwymedigaethau yr oedd gan Brifysgol Casnewydd hawlogaeth iddynt neu yr oedd yn ddarostyngedig iddynt yn union cyn ei diddymu, gael eu trosglwyddo i Gorfforaeth Addysg Uwch Prifysgol Morgannwg ("Prifysgol Morgannwg").

Mae'r Gorchymyn hwn hefyd yn gwneud darpariaeth i adran 127 o Ddeddf Diwygio Addysg 1988 fod yn gymwys mewn perthynas â phersonau a gyflogwyd gan Brifysgol Casnewydd yn union cyn 1 Ebrill 2013. Mae adran 127 o Ddeddf 1988, fel y'i cymhwysir gan y Gorchymyn hwn, yn gwneud darpariaeth ar gyfer trosglwyddo'r cyflogeion hynny i Brifysgol Morgannwg ar 1 Ebrill 2013 ac mewn cysylltiad â hawliau a dyletswyddau cysylltiedig Prifysgol Morgannwg a'r cyflogeion a drosglwyddir.

Ymgorfforwyd Prifysgol Morgannwg fel corfforaeth addysg uwch o'r enw Polytechnig Cymru ym 1982 a newidodd ei henw gyda chydysniad y Cyfrin Gyngor.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order dissolves the higher education corporation established to conduct the University of Wales, Newport ("the University of Newport"). The University of Newport was established as a higher education corporation under section 122 of the Education Reform Act 1988 as Gwent College of Higher Education and changed its name to the University of Wales College, Newport and subsequently to the University of Wales, Newport with the consent of the Privy Council.

This Order provides for all property, rights and liabilities to which the University of Newport was entitled or subject to immediately before its dissolution to be transferred to the University of Glamorgan Higher Education Corporation ("the University of Glamorgan").

This Order also makes provision for section 127 of the Education Reform Act 1988 to apply in relation to persons who were employed by the University of Newport immediately before 1 April 2013. Section 127 of the 1988 Act, as applied by this Order, makes provision for the transfer of such employees to the University of Glamorgan on 1 April 2013 and in respect of associated rights and duties of the University of Glamorgan and the transferred employees.

The University of Glamorgan was incorporated as a higher education corporation in 1992 as the Polytechnic of Wales and changed its name with the consent of the Privy Council.

Mae Gweinidogion Cymru yn gwneud y Gorchymyn a ganlyn drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adran 128 o Ddeddf Diwygio Addysg 1988(1) ac sy'n arferadwy bellach ganddynt hwy(2).

Yn unol ag adran 128(2) o Ddeddf Diwygio Addysg 1988, mae Corfforaeth Addysg Uwch Prifysgol Morgannwg ("*the University of Glamorgan Higher Education Corporation*")(3), sef corff corfforaethol a sefydlwyd at ddibenion sy'n cynnwys darparu cyfleusterau neu wasanaethau addysgol o fewn ystyr adran 128(1)(b)(ii) o'r Ddeddf honno, wedi cydsynio i eiddo, hawliau a rhwymedigaethau Corfforaeth Addysg Uwch Prifysgol Cymru, Casnewydd ("*University of Wales, Newport Higher Education Corporation*")(4) gael eu trosglwyddo iddi.

**The University of Wales, Newport
Higher Education Corporation
(Dissolution) Order 2013**

The Welsh Ministers make the following Order in exercise of the powers conferred on the Secretary of State by section 128 of the Education Reform Act 1988(1) and now exercisable by them(2).

In accordance with section 128(2) of the Education Reform Act 1988, the University of Glamorgan Higher Education Corporation(3) ("*Corfforaeth Addysg Uwch Prifysgol Morgannwg*"), being a body corporate established for purposes which include the provision of educational facilities or services within the meaning of section 128(1)(b)(ii) of that Act, has consented to the transfer to it of the property, rights and liabilities of the University of Wales, Newport Higher Education Corporation(4) ("*Corfforaeth Addysg Uwch Prifysgol Cymru, Casnewydd*").

2. Yn y Gorchymyn hwn—

ystyr "Corfforaeth Casnewydd" ("*the Newport Corporation*") yw Corfforaeth Addysg Uwch Prifysgol Cymru, Casnewydd;

ystyr "Prifysgol Morgannwg" ("*University of Glamorgan*") yw Corfforaeth Addysg Uwch Prifysgol Morgannwg.

Diddymu Prifysgol Cymru, Casnewydd

3. Ar 1 Ebrill 2013 mae Corfforaeth Casnewydd wedi ei diddymu ac mae ei holl eiddo, hawliau a rhwymedigaethau wedi eu trosglwyddo i Brifysgol Morgannwg.

4. Mae adran 127 o Ddeddf Diwygio Addysg 1988 yn gymwys i unrhyw berson a gyflogwyd gan Gorfforaeth Casnewydd yn union cyn 1 Ebrill 2013 fel petai'r cyfeiriadau yn yr adran honno—

- (a) at berson y mae'r adran honno yn gymwys iddo yn gyfeiriadau at berson a gyflogwyd felly;
- (b) at y dyddiad trosglwyddo yn gyfeiriadau at 1 Ebrill 2013;
- (c) at yr awdurdod sy'n trosglwyddo yn gyfeiriadau at Gorfforaeth Casnewydd;
- (d) at y gorfforaeth yn gyfeiriadau at Brifysgol Morgannwg.

The Welsh Ministers have consulted the University of Wales Newport Higher Education Corporation and the Higher Education Funding Council for Wales in accordance with section 128(4) of that Act.

Title and commencement

1. The title of this Order is the University of Wales, Newport Higher Education Corporation (Dissolution) Order 2013 and it comes into force on 11 April 2013.

Interpretation

2. In this Order—

"the Newport Corporation" ("*Corfforaeth Casnewydd*") means the University of Wales, Newport Higher Education Corporation;

"University of Glamorgan" ("*Prifysgol Morgannwg*") means the University of Glamorgan Higher Education Corporation.

Dissolution of the University of Wales, Newport

3. On 1 April 2013 the Newport Corporation is dissolved and all of its property, rights and liabilities are transferred to the University of Glamorgan.

4. Section 127 of the Education Reform Act 1988 applies to any person employed by the Newport Corporation immediately before 1 April 2013 as if references in that section to—

- (a) a person to whom that section applies were to a person so employed;
- (b) the transfer date were to 1 April 2013;
- (c) the transferor authority were to the Newport Corporation;
- (d) the corporation were to the University of Glamorgan.
