Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd gan adrannau 22, 42(6) a 43(1) o Ddeddf Addysgu ac Addysg Uwch 1998(1) ac a freiniwyd bellach ynddynt hwy(2).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 22, 42(6) and 43(1) of the Teaching and Higher Education Act 1998(1) and now vested in them(2).

Title, commencement and application

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Sefydliadau Ewropeaidd) a Chymorth i Fyfyrwyr (Cymru) (Dirymu) 2014.

1.—(1) The title of these Regulations is the Education (European Institutions) and Student Support (Wales) (Revocation) Regulations 2014.

(2) Mae'r Rheoliadau hyn yn dod i rym ar 31 Awst 2014 ac maent yn gymwys o ran Cymru.

(2) These Regulations come into force on 31 August 2014 and apply in relation to Wales.

Diwygiwyd adran 22 gan adran 146 o Ddeddf Dysgu a Sgiliau 2000 (p.21) ac Atodlen 11 iddi, Atodlen 6 i Ddeddf Treth Inewm 2003 (p.1), adran 147 o Ddeddf Cyllid 2003 (p.14), adrannau 42 a 43 o Ddeddf Addysg Uwch 2004 (p.8) ac Atodlen 7 iddi, adran 257 o Ddeddf Prentisiaethau, Sgiliau, Plant a Dysgu 2009 (p.22) ac adran 76 o Ddeddf Addysg 2011 (p.21).

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adran 22 o Ddeddf Addysgu ac Addysg Uwch 1998 (ac eithrio i'r graddau y maent yn ymwneud â gwneud unrhyw ddarpariaethau a awdurdodir gan is-adrannau (2)(a), (c), (j) neu (k), (3)(e) neu (f) neu (5) o adran 22) i Gynulliad Cenedlaethol Cymru gan adran 44 o Ddeddf Addysg Uwch 2004. Darparodd adran 44 o Ddeddf Addysg Uwch 2004 hefyd i swyddogaethau'r Ysgrifennydd Gwladol yn adran 22(2)(a), (c) a (k) fod yn arferadwy yn gydedol â Chynulliad Cenedlaethol Cymru. Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru i Weinidogion Cymru yn rhinwedd paragraffau 30(1) a 30(2) o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p.32).

(1) 1998 c.30. Section 22 was amended by section 146 of and Schedule 11 to the Learning and Skills Act 2000 (c. 21), Schedule 6 to the Income Tax Act 2003 (c. 1), section 147 of the Finance Act 2003 (c. 14), sections 42 and 43 of and Schedule 7 to the Higher Education Act 2004 (c. 8), section 257 of the Apprenticeships, Skills, Children and Learning Act 2009 (c. 22) and section 76 of the Education Act 2011 (c. 21).

(2) The functions of the Secretary of State under section 22 of the Teaching and Higher Education Act 1998 (except so far as they relate to the making of any provisions authorised by sub-sections (2)(a), (c), (j) or (k), (3)(e) or (f) or (5) of section 22) were transferred to the National Assembly for Wales by section 44 of the Higher Education Act 2004. Section 44 of the Higher Education Act 2004 also provided for the functions of the Secretary of State in section 22(2)(a), (c) and (k) to be exercisable concurrently with the National Assembly for Wales. The functions of the National Assembly for Wales were transferred to the Welsh Ministers by virtue of paragraphs 30(1) and 30(2) of Schedule 11 to the Government of Wales Act 2006 (c.32).

2. The Education (European Institutions) and Student Support (Wales) Regulations 2013(1) are revoked.

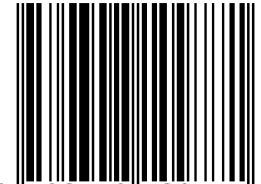
