Mae'r Rheoliadau hyn yn dirymu Rheoliadau Citiau a Gwasanaethau Profi am HIV 1992 (O.S. 1992/460), sy'n ei gwneud yn drosedd, yn ddarostyngedig i eithriadau amrywiol, i wneud y canlynol—

- gwerthu neu gyflenwi cit neu gydran profi am HIV i aelod o'r cyhoedd;
- gwerthu neu gyflenwi cit profi am HIV heb hysbysiad rhybudd cysylltiedig; a
- darparu gwasanaethau profi am HIV nas cyfarwyddir gan ymarferydd meddygol cofrestredig.

Yn ogystal, mae Rheoliadau Citiau a Gwasanaethau Profi am HIV 1992 yn gosod cyfyngiadau ar hysbysebion am gitiau, cydrannau a gwasanaethau o'r fath.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Gellir cael copi oddi wrth y Tîm Nawdd, Sgrinio a Chlefydau Trosglwyddadwy, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations revoke the HIV Testing Kits and Services Regulations 1992 (S.I. 1992/460), which make it an offence, subject to various exceptions—

- to sell or supply an HIV testing kit or component to a member of the public;
- to sell or supply an HIV testing kit without an accompanying warning notice; and
- to provide HIV testing services which are not directed by a registered medical practitioner.

In addition, the HIV Testing Kits and Services Regulations 1992 place restrictions on advertisements for such kits, components and services.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations.
