The Welsh Ministers, in exercise of the powers conferred upon the Secretary of State by section 5 of the Landlord and Tenant Act 1985(1) and now vested in the Welsh Ministers(2), make the following Regulations:

Title and commencement

1.—(1) The title of these Regulations is the Rent Book (Forms of Notice) (Amendment) (Wales) Regulations 2014.

(2) These Regulations come into force on 31 March 2014.

Amendment of forms

2. In the Schedule to the Rent Book (Forms of Notice) Regulations 1982(3)—

(1) 1985 c.70.
(2) The functions of the Secretary of State under section 5 were, so far as exercisable in relation to Wales, transferred to the National Assembly for Wales by article 2 of and Schedule 1 to the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672). These functions now vest in the Welsh Ministers by virtue of section 162 of and paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c. 32).
