Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor (Darganfod Twyll a Gorfodi) (Cymru) 2013 ("Rheoliadau 2013"), Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor a Gofynion Rhagnodedig (Cymru) 2013 a Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor (Cynllun Diofyn) (Cymru) 2013.

These Regulations amend the Council Tax Reduction Schemes (Detection of Fraud and Enforcement) (Wales) Regulations 2013 ("the 2013 Regulations"), the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2013 and the Council Tax Reduction Schemes (Default Scheme) (Wales) Regulations 2013.

Roedd Rheoliadau 2013 yn darparu ar gyfer creu troseddau ac ar gyfer pwerau i wneud darparu gwybodaeth yn ofynnol ac i osod cosbau mewn cysylltiad â chynlluniau gostyngiadau'r dreth gyngor a wnaed o dan Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor a Gofynion Rhagnodedig (Cymru) 2012 a chynlluniau diofyn a oedd yn gymwys ar 1 Ebrill 2013 yn unol â pharagraff 6(1)(e) o Atodlen 1B i Ddeddf Cyllid Llywodraeth Leol 1992.

The 2013 Regulations made provision for the creation of offences and for powers to require information and to impose penalties in connection with council tax reduction schemes made under the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2012 and default schemes applicable on 1 April 2013 in accordance with paragraph 6(1)(e) of Schedule 1B to the Local Government Finance Act 1992.

Mae rheoliad 2 o'r Rheoliadau hyn yn diwygio Rheoliadau 2013 fel bod y troseddau a grëir, ynghyd â'r pwerau i wneud darparu gwybodaeth yn ofynnol ac i osod cosbau, yn ymwneud â chynlluniau a wnaed o dan Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor a Gofynion Rhagnodedig (Cymru) 2013 neu sy'n gymwys yn ddiiofyn ar 1 Ebrill 2014 yn unol â pharagraff 6(1)(e) o Atodlen 1B i Ddeddf Cyllid Llywodraeth Leol 1992.

Regulation 2 of these Regulations amends the 2013 Regulations so that the offences created and the powers to require information and impose penalties relate to schemes made under the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2013 or which apply in default on 1 April 2014 in accordance with paragraph 6(1)(e) of Schedule 1B to the Local Government Finance Act 1992.

Mae rheoliad 3 yn darparu y bydd Rheoliadau 2013 yn parhau i gael effaith o ran unrhyw geisiadau a wneir neu ostyngiadau a ddyfernir yn unol â chynlluniau a wnaed o dan Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor a Gofynion Rhagnodedig (Cymru) 2012, neu sy'n gymwys yn ddiiofyn ar 1 Ebrill 2013 yn unol â

Regulation 3 provides that the 2013 Regulations will continue to have effect in relation to any applications made or reductions awarded in accordance with schemes made under the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2012 or which apply in default on 1 April

Mae rheoliadau 4 a 5 yn diwygio Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor a Gofynion Rhagnodedig (Cymru) 2013 a Rheoliadau Gostyngiadau'r Dreth Gyngor (Cynllun Diofyn) (Cymru) 2013. Maent yn diwygio testun Cymraeg y Rheoliadau hynny drwy ddiwygio'r diffiniad o ysbyty annibynnol yn yr Alban er sicrhau cysondeb â'r testun Saesneg.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. Nid oes Asesiad Effaith Rheoleiddiol wedi'i lunio ar gyfer y Rheoliadau hyn, gan mai gwneud diwygiadau technegol er diweddaru Rheoliadau 2013 yn unig y maent ac nid oes ganddynt effaith sylweddol ar bolisi.

2013 in accordance with paragraph 6(1)(e) of Schedule 1B to the Local Government Finance Act 1992.

Regulations 4 and 5 amend the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2013 and Council Tax Reduction Schemes (Default Scheme) (Wales) Regulations 2013. They amend the Welsh text of those Regulations by amending the definition of an independent hospital in Scotland to ensure consistency with the English text.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. A Regulatory Impact Assessment has not been prepared for these Regulations as they simply make technical amendments to update the 2013 Regulations and have no major policy impact.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd iddynt gan adrannau 13A(4), 14A, 14B, 14C, 14D a 113(1) a (2) o Ddeddf Cyllid Llywodraeth Leol 1992 a pharagraff 6 o Atodlen 1B iddi(1).

The Welsh Ministers make the following Regulations in exercise of the powers conferred upon them by sections 13A(4), 14A, 14B, 14C, 14D and 113(1) and (2) of, and paragraph 6 of Schedule 1B to, the Local Government Finance Act 1992(1).

Yn unol ag adrannau 13A(8) a 14D(3) o'r Ddeddf honno, gosodwyd drafft o'r offeryn hwn gerbron Cynulliad Cenedlaethol Cymru a chymeradwywyd ef ganddo drwy benderfyniad.

In accordance with sections 13A(8) and 14D(3) of that Act, a draft of this instrument has been laid before and approved by a resolution of the National Assembly for Wales.

Title, commencement and application

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cynlluniau Gostyngiadau'r Dreth Gyngor (Diwygiadau Amrywiol) (Cymru) 2014 a deuant i rym drannoeth y diwrnod y'u gwneir.

1.—(1) The title of these Regulations is the Council Tax Reduction Schemes (Miscellaneous Amendments) (Wales) Regulations 2014 and they come into force on the day after the day on which they are made.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(2) These Regulations apply in relation to Wales.

Amendment to the Council Tax Reduction Schemes (Detection of Fraud and Enforcement) (Wales) Regulations 2013

2.—(1) The Council Tax Reduction Schemes (Detection of Fraud and Enforcement) (Wales) Regulations 2013(1) are amended as follows.

(2) In regulation 2(1) (interpretation)—

- (a) in the definition of “the Default Scheme”, for “Council Tax Reduction Schemes (Default Scheme) (Wales) Regulations 2012(2)” substitute “Council Tax Reduction Schemes (Default Scheme) (Wales) Regulations 2013(3)”; and
- (b) in the definition of “the Prescribed Requirements Regulations”, for “Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2012(4)” substitute “Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2013(5)”.

Saving Provision

3. Regulation 2 of these Regulations does not have effect in relation to any applications made or reductions awarded in accordance with the provisions of a scheme made by a billing authority in accordance with the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2012 or which applies in default on 1 April 2013 in accordance with paragraph 6(1)(e) of Schedule 1B to the Local Government Finance Act 1992.

Amendment to the Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2013

4.—(1) The Council Tax Reduction Schemes and Prescribed Requirements (Wales) Regulations 2013 are amended as follows.
