**The Hazardous Waste
(Miscellaneous Amendments)
(Wales) Regulations 2015**

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend certain statutory instruments concerned with hazardous waste, which refer to the List of Wastes (Wales) Regulations 2005 (S.I. 2005/1820 (W. 148)) ("the List of Wastes Regulations"), or to European Union enactments concerning hazardous waste.

The amendments made by these Regulations are necessary in order to—

implement Commission Regulation (EU) No 1357/2014 (OJ No L 365, 19.12.14, p. 89), which amends Directive 2008/98/EC (OJ No L 312, 22.11.2008, p. 3) ("the Waste Directive");

implement Commission Decision 2014/955/EU (OJ No L 370, 30.12.2014, p. 44), which amends Commission Decision 2000/532/EC (OJ No L 226, 6.9.00, p. 3) ("the List of Wastes Decision");

recognise the recasting of Directive 2002/96/EC (OJ L 37, 13.2.2003, p.24) on Waste Electrical and Electronic Equipment ("the WEEE Directive"), as Directive 2012/19/EU (OJ No L 197, 24.7.2012, p 38);

recognise changes in terminology made by Regulation (EC) No 1272/2008 of the European Parliament and of the Council, on classification, labelling and packaging of substances and mixtures (OJ No L 353, 31.12.2008, p.1) ("the CLP Regulation").

At ddiben gweithredu Penderfyniad diwygiedig y Rhestr Wastraffoedd, mae Rheoliadau'r Rhestr Wastraffoedd wedi eu dirymu. Pan fo cyfeiriadau at y Rheoliadau hynny yn codi yn yr offerynnau y mae'r Rheoliadau hyn yn eu diwygio, rhoddir cyfeiriad at Benderfyniad y Rhestr Wastraffoedd ei hun, fel y'i diwygir o bryd i'w gilydd, yn eu lle.

Mae rheoliad 2 o'r Rheoliadau hyn yn diwygio Rheoliadau'r Cynllun Lwfansau Tirlenwi (Cymru) 2004 (O.S. 2004/1490 (Cy. 155)) drwy roi cyfeiriad at Benderfyniad y Rhestr Wastraffoedd yn lle'r cyfeiriadau at Reoliadau'r Rhestr Wastraffoedd.

Mae rheoliad 3 a'r Atodlen yn gwneud diwygiadau i Reoliadau Gwastraff Peryglus (Cymru) 2005 (O.S. 2005/1806 (Cy. 138)) ("y Rheoliadau Gwastraff Peryglus").

Mae rheoliad 3(2) yn amnewid y diffiniad o'r Gyfarwyddeb Wastraff sydd yn rheoliad 2 o'r Rheoliadau Gwastraff Peryglus.

Mae rheoliad 3(3) yn diwygio'r diffiniad o Atodiad III i'r Gyfarwyddeb Wastraff yn rheoliad 3(a) drwy hepgor y cyfeiriad at Atodlen 3 i'r Rheoliadau hynny, a hepgorir Atodlen 3 i'r Rheoliadau hynny ei hunan yn rhinwedd rheoliad 3(8).

Mae rheoliad 3(4) yn amnewid y diffiniad o'r Rhestr Wastraffoedd sydd yn rheoliad 4(1). Mae'r diffiniad newydd yn cyfeirio'n uniongyrchol at Benderfyniad y Rhestr Wastraffoedd fel y'i diwygir o bryd i'w gilydd.

Mae paragraffau (5), (6)(a) a (7)(a) o reoliad 3 yn cywiro cyfeiriad at adran 62A o Ddeddf Diogelu'r Amgylchedd 1990 (p.43).

Mae rheoliad 3(6)(b) yn rhoi cyfeiriad at Erthygl 7(2) o'r Gyfarwyddeb Wastraff yn lle cyfeiriad at Erthygl 3 o Benderfyniad y Rhestr Wastraffoedd.

Mae rheoliad 3(7)(b) yn rhoi cyfeiriad at Erthygl 7(3) o'r Gyfarwyddeb Wastraff yn lle cyfeiriad at Erthygl 3 o Benderfyniad y Rhestr Wastraffoedd.

Mae rheoliad 3(9) a'r Atodlen yn amnewid Atodlen 8 newydd.

Mae rheoliad 4 yn diwygio Rheoliadau Trwyddedu Amgylcheddol (Cymru a Lloegr) 2010 (O.S. 2010/675) ("RhTA 2010").

Mae paragraffau (2), (5)(b) a (7) o reoliad 4, yn diweddu cyfeiriadau at Erthyglau penodol yn y Gyfarwyddeb CTEG er mwyn cysoni'r cyfeiriadau hynny â'r darpariaethau cyfatebol yn y Gyfarwyddeb a ail-luniwyd.

For the purpose of implementing the amended List of Wastes Decision, the List of Wastes Regulations are revoked. References to those Regulations, where they occur in the instruments amended by these Regulations, are substituted with a reference to the List of Wastes Decision itself, as amended from time to time.

Regulation 2 of these Regulations amends the Landfill Allowances Scheme (Wales) Regulations 2004 (S.I. 2004/1490 (W. 155)) by substituting, for references to the List of Wastes Regulations, a reference to the List of Wastes Decision.

Regulation 3 and the Schedule make amendments to the Hazardous Waste (Wales) Regulations 2005 (S.I. 2005/1806 (W. 138)) ("the Hazardous Waste Regulations").

Regulation 3(2) substitutes the definition of the Waste Directive in regulation 2 of the Hazardous Waste Regulations.

Regulation 3(3) amends the definition of Annex III to the Waste Directive in regulation 3(a) by omitting the reference to Schedule 3 to those Regulations, and Schedule 3 to those Regulations is itself omitted by virtue of regulation 3(8).

Regulation 3(4) substitutes the definition of the List of Wastes in regulation 4(1). The new definition refers directly to the List of Wastes Decision as amended from time to time.

Paragraphs (5), (6)(a) and (7)(a) of regulation 3 correct a reference to section 62A of the Environmental Protection Act 1990 (c.43).

Regulation 3(6)(b) substitutes for a reference to Article 3 of the List of Wastes Decision, a reference to Article 7(2) of the Waste Directive.

Regulation 3(7)(b) substitutes for a reference to Article 3 of the List of Wastes Decision, a reference to Article 7(3) of the Waste Directive.

Regulation 3(9) and the Schedule substitute a new Schedule 8.

Regulation 4 amends the Environmental Permitting (England and Wales) Regulations 2010 (S.I. 2010/675) ("the EPR 2010").

Paragraphs (2), (5)(b) and (7) of regulation 4, update references to certain Articles in the WEEE Directive in order to align those references to the equivalent provisions in the recast Directive.

Mae rheoliad 4(3)(a) yn amnewid cyfeiriad at y Gyfarwyddeb Wastraff. Er cysondeb â darpariaethau perthnasol eraill, nid yw'r ddarpariaeth a amnewidir yn cyfeirio'n benodol at Reoliad diwygio EU Rhif 1357/2014. Effaith adran 20A o Ddeddf Dehongli 1978 (p.30) ("Deddf 1978"), fod bynnag, yw pan fo Deddf sydd wedi ei phasio ar ôl dyddiad cychwyn yr adran honno yn cyfeirio at offeryn yr Undeb Ewropeaidd, fod y cyfeiriad, oni amlygir bwriad i'r gwrthwyneb, yn gyfeiriad at yr offeryn fel y'i diwygiwyd ar y dyddiad y daw'r Deddf honno i rym. Mae adran 23(1) o Deddf 1978 hefyd yn cymhwysôr egwyddor honno i is-ddeddfwriaeth. O ganlyniad, effaith yr amnewidiad a wneir gan reoliad 4(3)(a) yw bod cyfeiriadau at y Gyfarwyddeb Wastraff yn RhTA 2010 yn dod yn gyfeiriadau at y Gyfarwyddeb honno fel y'i diwygiwyd ar y dyddiad y daw'r Rheoliadau hyn i rym.

Mae rheoliad 4(3)(b) yn rhoi, yn lle'r cyfeiriad at y Gyfarwyddeb CTEG, gyfeiriad at y Gyfarwyddeb honno fel y'i hail-luniwyd.

Mae rheoliad 4(4) yn mewnosod cyfeiriad at Benderfyniad y Rhestr Wastraffoedd fel y'i diwygir o bryd i'w gilydd, yn Atodlen 3 o RhTA 2010, drwy roi, yn lle cyfeiriadau at Reoliadau'r Rhestr Wastraff, gyfeiriad at y Penderfyniad hwnnw.

Mae paragraffau (5) a (6) o Reoliad 4 yn rhoi cyfeiriadau at "hazardous substances" yn lle amryw o gyfeiriadau at "dangerous substances", er mwyn cysoni'r darpariaethau â'r derminoleg a ddefnyddiwyd yn y Rheoliad DLPh.

Mae rheoliad 5 yn diwygio Rheoliadau Gwastraff (Cymru a Lloegr) 2011 (O.S. 2011/988) drwy fewnosod cyfeiriad at Benderfyniad y Rhestr Wastraffoedd fel y'i diwygir o bryd i'w gilydd, a rhoi, yn lle cyfeiriadau at Reoliadau'r Rhestr Wastraffoedd, gyfeiriadau at y Penderfyniad hwnnw.

Mae rheoliad 6 yn diwygio Rheoliadau Gwastraff a Reolir (Cymru a Lloegr) 2012 (O.S. 2012/811), drwy roi cyfeiriad at Benderfyniad y Rhestr Wastraffoedd yn lle'r cyfeiriad at Reoliadau'r Rhestr Wastraffoedd yn y diffiniad o "offensive waste".

Mae rheoliad 7 yn dirymu Rheoliadau'r Rhestr Wastraffoedd (Cymru) 2005 (O.S. 2005/1820 (Cy.148)) a rheoliad 4 o Reoliadau Gwastraff (Darpariaethau Amrywiol) (Cymru) 2011 (O.S. 2011/971 (Cy.141)).

Ni wnaed asesiad effaith ar gyfer yr offeryn hwn, oherwydd na ragwelir unrhyw effaith ar fusnesau.

Regulation 4(3)(a) substitutes a reference to the Waste Directive. For the purpose of consistency with other relevant provisions, the substituted provision does not refer expressly to the amending Regulation EU No 1357/2014. But the effect of section 20A of the Interpretation Act 1978 (c.30) ("the 1978 Act"), is that where an Act passed after the commencement of that section refers to a European Union instrument, unless a contrary intention appears, the reference is to the instrument as amended at the date the Act comes into force. Section 23(1) of the 1978 Act applies that principle also in relation to secondary legislation. Accordingly, the substitution made by regulation 4(3)(a) has the effect that references to the Waste Directive in the EPR 2010 become references to that Directive as amended at the date on which these Regulations come into force.

Regulation 4(3)(b) substitutes, for the reference to the WEEE Directive, a reference to that Directive as recast.

Regulation 4(4) inserts a reference to the List of Wastes Decision as amended from time to time, in Schedule 3 of the EPR 2010, substituting references to the List of Wastes Regulations, with a reference to that Decision.

Paragraphs (5) and (6) of Regulation 4, substitute for various references to "dangerous substances", references to "hazardous substances", in order to align the provisions with the terminology used in the CLP Regulation.

Regulation 5 amends the Waste (England and Wales) Regulations 2011 (S.I. 2011/988) by inserting a reference to the List of Wastes Decision as amended from time to time, and substituting, for references to the List of Wastes Regulations, references to that Decision.

Regulation 6 amends the Controlled Waste (England and Wales) Regulations 2012 (S.I. 2012/811), by substituting, for the reference to the List of Wastes Regulations in the definition of "offensive waste", a reference to the List of Wastes Decision.

Regulation 7 revokes the List of Wastes (Wales) Regulations 2005 (S.I. 2005/1820 (W. 148)) and regulation 4 of the Waste (Miscellaneous Provisions) (Wales) Regulations 2011 (S.I. 2011/971 (W. 141)).

No impact assessment has been undertaken for this instrument because no impact on business is foreseen.

The Welsh Ministers have, in accordance with section 2(4) of the Pollution Prevention and Control Act 1999(1) ("the PPCA1999") consulted—

- (a) the Natural Resources Body for Wales;
- (b) such bodies or persons appearing to them to be representative of the interests of local government, industry, agriculture and small businesses respectively as they consider appropriate; and
- (c) such other bodies or persons as they consider appropriate.

The Welsh Ministers have also, in accordance with section 27(2) and (4) of the Waste and Emissions Trading Act 2003(2) ("the WETA 2003") consulted—

- (a) such bodies or persons appearing to them to be representative of the interests of waste disposal authorities in their area as they consider appropriate;
- (b) such bodies or persons appearing to them to be representative of the interests of persons concerned in the operation of landfills in their area as they consider appropriate; and

Mae Gweinidogion Cymru wedi eu dynodi(1) at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(2) ("DCE 1972") mewn perthynas â mesurau ynghylch atal, lleihau a dileu llygrededd a achosir gan wastraff(3) ac atal, lleihau a rheoli gwastraff(4).

- (c) such bodies or persons appearing to them to be representative of any other affected persons as they consider appropriate.

The Welsh Ministers are designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) ("the ECA 1972") in relation to measures relating to the prevention, reduction and elimination of pollution caused by waste(3) and the prevention, reduction and management of waste(4).

These Regulations make provision for a purpose mentioned in section 2(2) of the ECA 1972, and it appears to the Welsh Ministers that it is expedient for references to Commission Decision 2000/532/EC(5), referred to in regulations 2(2), 3(4), 4(4)(a), 5(2) and 6, to be construed as references to that instrument as amended from time to time.

The Welsh Ministers make these Regulations in exercise of the powers conferred by section 2(2) of and paragraph 1A of Schedule 2 to the ECA 1972, section 75(8) of the Environmental Protection Act 1990(6), section 2 of and Schedule 1 to the PPCA 1999 and sections 11, 12 and 13 of the WETA 2003.

Title, commencement and application

1.—(1) The title of these Regulations is the Hazardous Waste (Miscellaneous Amendments) (Wales) Regulations 2015.

(2) These Regulations come into force on 20 July 2015.

2.—(1) Mae Rheoliadau'r Cynllun Lwfansau Tirlenwi (Cymru) 2004(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2(1) (dehongli) yn y man priodol, mewnosoder—

“ystyr “y Rhestr Wastraffoedd” (“*the List of Wastes*”) yw'r rhestr o wastraffoedd a sefydlir gan Benderfyniad y Comisiwn 2000/532/EC sy'n disodli Penderfyniad 94/3/EC sy'n sefydlu rhestr wastraffoedd yn unol ag Erthygl 1(a) o Gyfarwyddeb y Cyngor 75/442/EEC ar wastraff a Phenderfyniad y Cyngor 94/904/EC sy'n sefydlu rhestr o wastraffoedd peryglus yn unol ag Erthygl 1(4) o Gyfarwyddeb y Cyngor 91/689/EEC ar wastraff peryglus, fel y'i diwygir o bryd i'w gilydd;”.
