CHAPTER 2

Placement with local authority foster parents

Independent [^{F1}fostering services] – discharge of authority functions

29.—(1) A responsible authority may make arrangements in accordance with this regulation for the duties imposed on it by regulation 15(3) and regulation 23 to be discharged on its behalf by a [^{F2}registered provider].

(2) No arrangements may be made under this regulation unless the responsible authority has entered into a written agreement with the [^{F3}registered provider] which includes the information set out in paragraph 1 of Schedule 6, and where the responsible authority proposes to make an arrangement under this regulation in relation to a particular child, the written agreement must also include the matters set out in paragraph 2 of Schedule 6.

(3) The responsible authority must report to the Chief Inspector of the Care and Social Services Inspectorate Wales any concerns it may have about the services provided by a [^{F4}registered provider].
