EXPLANATORY NOTE

Mae'r Gorchymyn hwn yn dirymu Gorchymyn Awdurdodau Tân ac Achub (Dangosyddion Perfformiad) (Cymru) 2011 (O.S. 2011/558 (Cy. 80)) ac yn pennu, o ran Cymru, set newydd o ddangosyddion perfformiad statudol y bydd perfformiad awdurdodau tân ac achub, wrth iddynt arfer eu swyddogaethau, yn cael eu mesur yn eu herbyn. Bydd y Gorchymyn yn cael effaith o 1 Ebrill 2015.

This Order revokes the Fire and Rescue Authorities (Performance Indicators) (Wales) Order 2011 (S.I. 2011/558 (W. 80)) and specifies for Wales a new set of statutory performance indicators, by reference to which the performance of fire and rescue authorities in exercising their functions will be measured. The Order will have effect from 1 April 2015.

Article 2 of this Order specifies that the performance indicators are set out in the Schedule to this Order.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Awdurdodau Tân ac Achub (Dangosyddion Perfformiad) (Cymru) 2015.

(2) Mae'r Gorchymyn hwn yn gymwys o ran awdurdodau tân ac achub Cymreig(2) a daw i rym ar 1 Ebrill 2015.

Dangosyddion perfformiad

2.—(1) Pennir y dangosyddion perfformiad yn yr Atodlen i'r Gorchymyn hwn at ddiben adran 8(1)(a) o Fesur Llywodraeth Leol (Cymru) 2009.

The Welsh Ministers, in exercise of the powers conferred upon them by section 8(1)(a) of the Local Government (Wales) Measure 2009(1), and having consulted those persons whom they are required under section 8(3) of that Measure, hereby make the following Order.

Title, commencement, and application

1.—(1) The title of this Order is the Fire and Rescue Authorities (Performance Indicators) (Wales) Order 2015.

(2) This Order applies in relation to Welsh fire and rescue authorities(2) and comes into force on 1 April 2015.

Performance indicators

2.—(1) The performance indicators in the Schedule to this Order are specified for the purpose of section 8(1)(a) of the Local Government (Wales) Measure 2009.

(2) O dan adran 1 o Fesur Llywodraeth Leol (Cymru) 2009, awdurdod tân ac achub Cymreig yw awdurdod yng Nghymru a gyfansoddwyd drwy gynllun o dan adran 2 o Ddeddf Gwasasnaethau Tân ac Achub 2004 (p. 21) neu gynllun y mae adran 4 o'r Ddeddf honno yn gymwys iddo.

(2) Under section 1 of the Local Government (Wales) Measure 2009, a Welsh fire and rescue authority is an authority in Wales that is constituted by a scheme under section 2 of the Fire and Rescue Services Act 2004 (c. 21) or a scheme to which section 4 of that Act applies.

(2) Mae'r dangosyddion perfformiad a bennir yn yr Atodlen yn gymwys i flynyddoedd ariannol sy'n dechrau ar 1 Ebrill 2015 ac ar ôl hynny.

(2) The performance indicators specified in the Schedule apply to financial years beginning on and after 1 April 2015.
