Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn cynyddu uchafsymiau ac isafsymiau'r taliadau colli cartref sy'n daladwy o dan Ddeddf Digollediad Tir 1973 ("y Ddeddf") i'r rhai sy'n meddiannu anedd sydd â buddiant perchen ног. Mae'r Rheoliadau hyn yn cynyddu hefyd swm y taliad colli cartref sy'n daladwy o dan y Ddeddf mewn unrhyw achos arall.

Mae hawl gan berson a ddadleolir o anedd drwy brynu gorfodol neu o dan amgylchiadau eraill a bennir yn adran 29 o'r Ddeddf i gael taliad colli cartref.

Mewn achosion pan fo gan berson sy'n meddiannu anedd ar ddyddiad y dadleoli fuddiant perchen ног, mae adran 30(1) o'r Ddeddf yn darparu bod swm y taliad colli cartref yn cael ei gyfrifo fel canran o werth y buddiant hwnnw ar y farchnad, a hynny'n ddarostyngedig i uchafswm ac isafswm.

Mae adran 30(2) o'r Ddeddf yn pennu swm y taliad colli cartref mewn unrhyw achos arall.

Mae rheoliad 2(a) o'r Rheoliadau hyn yn cynyddu'r uchafswm sy'n daladwy o dan adran 30(1) o'r Ddeddf o £53,000 i £55,000 ac mae rheoliad 2(b) yn cynyddu'r isafswm o £5,300 i £5,500.

Mae rheoliad 2(c) yn cynyddu'r taliad colli cartref sy'n daladwy, o dan adran 30(2) o'r Ddeddf, mewn unrhyw achos arall o £5,300 i £5,500.

The Home Loss Payments
(Prescribed Amounts) (Wales)
Regulations 2016

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations, which apply in relation to Wales, increase the maximum and minimum amounts of home loss payments payable under the Land Compensation Act 1973 ("the Act") to those occupying a dwelling who have an owner's interest. These Regulations also increase the amount of home loss payment payable under the Act in any other case.

A person who is displaced from a dwelling by compulsory purchase or in other circumstances specified in section 29 of the Act is entitled to a home loss payment.

Section 30(1) of the Act provides that in cases where a person occupying a dwelling on the date of displacement has an owner's interest, the amount of home loss payment is calculated as a percentage of the market value of that interest, subject to a maximum and minimum amount.

Section 30(2) of the Act specifies the amount of the home loss payment in any other case.

Regulation 2(a) of these Regulations increases the maximum amount payable under section 30(1) of the Act from £53,000 to £55,000 and regulation 2(b) increases the minimum amount from £5,300 to £5,500.

Regulation 2(c) increases the home loss payment payable, under section 30(2) of the Act, in any other case from £5,300 to £5,500.

Mae'r symiau diwygiedig yn gymwys pan fo'r dadleoli'n digwydd ar 5 Rhagfyr 2016 neu ar ôl hynny.

Mae rheoliad 3 yn dirymu, gydag arbedion, Rheoliadau Taliadau Colli Cartref (Symiau Rhagnodedig) (Cymru) 2015.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenreidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The revised amounts apply where the displacement occurs on or after 5 December 2016.

Regulation 3 revokes, with savings, the Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2015.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2016

Made	7 November 2016
Laid before the National Assembly for Wales	11 November 2016
Coming into force	5 December 2016

The Welsh Ministers make the following Regulations in exercise of the powers conferred upon the Secretary of State by section 30(5) of the Land Compensation Act 1973(1) and now exercisable by them in relation to Wales(2):

Title, commencement, application and interpretation

1.—(1) The title of these Regulations is the Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2016 and they come into force on 5 December 2016.

(2) These Regulations apply in relation to Wales.

(3) In these Regulations "the Act" ("y Ddeddf") means the Land Compensation Act 1973.

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adran 30, i'r graddau yr oeddent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan ethylg 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac Atodlen 1 iddo. Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru o dan adran 30 i Weinidogion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p. 32).

(2) The functions of the Secretary of State under section 30 were, so far as exercisable in relation to Wales, transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672), article 2; and Schedule 1. The functions of the National Assembly for Wales under section 30 were transferred to the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c. 32).

Diwygio symiau rhagnodedig ar gyfer y taliad colli cartref

2. Pan fo dyddiad y dadleoli ar 5 Rhagfyr 2016 neu ar ôl hynny—

- (a) £55,000 yw uchafswm rhagnodedig y taliad colli cartref at ddibenion adran 30(1) o'r Ddeddf;
- (b) £5,500 yw isafswm rhagnodedig y taliad colli cartref at ddibenion adran 30(1) o'r Ddeddf; ac
- (c) £5,500 yw swm rhagnodedig y taliad colli cartref at ddibenion adran 30(2) o'r Ddeddf.

Dirymu ac arbedion

3.—(1) Yn ddarostyngedig i baragraff (2), mae Rheoliadau Taliadau Colli Cartref (Symiau Rhagnodedig) (Cymru) 2015(1) wedi eu dirymu.

(2) Bydd y Rheoliadau a grybwyllywyd ym mharagraff (1) yn parhau i gael effaith mewn perthynas â dadleoli sy'n digwydd cyn 5 Rhagfyr 2016.

Revision of prescribed amounts for home loss payment

2. When the date of displacement is on or after 5 December 2016—

- (a) the prescribed maximum amount of home loss payment for the purposes of section 30(1) of the Act is £55,000;
- (b) the prescribed minimum amount of home loss payment for the purposes of section 30(1) of the Act is £5,500; and
- (c) the prescribed amount of home loss payment for the purposes of section 30(2) of the Act is £5,500.

Revocation and savings

3.—(1) Subject to paragraph (2), the Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2015(1) are revoked.

(2) The Regulations mentioned in paragraph (1) will continue to have effect in relation to a displacement occurring before 5 December 2016.
