Gorchymyn Cyngor y Gweithlu Addysg (Cofrestru Gweithwyr Ieuencid, Gweithwyr Cymorth Ieuencid ac Ymarferwyr Dysgu Seiliedig ar Waith) 2016

**NODYN ESBONIADOL**

(*Nid yw'r nodyn hwn yn rhan o'r Gorchymyn*)

Mae Deddf Addysg (Cymru) 2014 (“Deddf 2014”) yn gwneud darpariaeth mewn perthynas â Chyngor y Gweithlu Addysg (“y Cyngor”). Mae Rhan 2 o Ddeddf 2014 yn rhoi swyddogaethau i’r Cyngor mewn perthynas â phersonau y mae’n ofynnol iddynt gofrestru yn y gofrestr y mae’r Cyngor yn ei chynnal yn unol ag adran 9 o’r Ddeddf honno (“y Gofrestr”).

Mae’r categorïau o bersonau cofrestredig wedi eu nodi yn Nhabl 1 ym mharagraff 1 o Atodlen 2 i Ddeddf 2014. Mae gan Weinidogion Cymru bŵer ym mharagraff 2 o’r Atodlen honno i ychwanegu, diwygio neu ddileu categori cofrestru. Yn unol â hynny, mae’r Gorchymyn hwn yn diwygio Tabl 1 ym mharagraff 1 o Atodlen 2 i Ddeddf 2014 i ychwanegu’r categorïau a ganlyn o berson cofrestredig (Rhan 4 o’r Gorchymyn hwn)—

- (a) gweithiwr ieuencid;
- (b) gweithiwr cymorth ieuencid; ac
- (c) ymarferydd dysgu seiliedig ar waith.

Effaith Rhan 2 o’r Gorchymyn hwn yw creu system cofrestru gwirfoddol ar gyfer gweithwyr ieuencid, fel y caiff unrhyw berson sy’n darparu gwasanaethau datblygu ieuencid gofrestru â’r Cyngor. Fodd bynnag, mae Rhan 2 hefyd yn darparu bod rhaid i berson gofrestru â’r Cyngor os yw’n dymuno darparu gwasanaethau datblygu ieuencid ar gyfer neu ar ran corff perthnasol (fel y’i diffinnir yn y Gorchymyn hwn) (erthygl 3(1)).

The Education Workforce Council (Registration of Youth Workers, Youth Support Workers and Work Based Learning Practitioners) Order 2016

**EXPLANATORY NOTE**

(*This note is not part of the Order*)

The Education (Wales) Act 2014 (“the 2014 Act”) makes provision in relation to the Education Workforce Council (“the Council”). Part 2 of the 2014 Act confers functions on the Council in relation to persons who are required to register in the register the Council maintains in accordance with section 9 of that Act (“the Register”).

The categories of registered persons are set out in Table 1 in paragraph 1 in Schedule 2 to the 2014 Act. The Welsh Ministers have a power in paragraph 2 of that Schedule to add, amend or remove a category of registration. Accordingly, this Order amends Table 1 in paragraph 1 in Schedule 2 to the 2014 Act to add the following categories of registered person (Part 4 of this Order)—

- (a) youth worker;
- (b) youth support worker; and
- (c) work based learner practitioner.

The effect of Part 2 of this Order is to create a voluntary registration system for youth workers, so that any person providing youth development services may register with the Council. However, Part 2 also provides that a person must register with the Council if they want to provide youth development services for or on behalf of a relevant body (as defined in this Order) (article 3(1)).

Mae erthygl 3(2) yn nodi eithriad i'r cyfyngiad yn erthygl 3(1); mae'r eithriad hwnnw yn gymwys pan fo person yn symud i'r DU o aelod-wladwriaeth arall yn yr Undeb Ewropeaidd er mwyn gweithio fel gweithiwr ieuenciad ar sail dros dro ac achlysurol. Nid yw'r person hwnnw yn ddarostyngedig i'r gofyniad i gofrestru ("yr esemtiad i weithwyr dros dro ac achlysurol o'r UE"). Mae'r ddarpariaeth hon yn sicrhau cydymffurfedd â Rhan 2 o Reoliadau'r Undeb Ewropeaidd (Cydnabod Cymwysterau Proffesiynol) 2015.

Effaith Rhan 3 o'r Gorchymyn hwn yw creu system cofrestru gwirfoddol ar gyfer gweithwyr cymorth ieuenciad, fel y caiff unrhyw berson sy'n darparu gwasanaethau datblygu ieuenciad gofrestru â'r Cyngor. Fodd bynnag, mae Rhan 3 hefyd yn darparu bod rhaid i berson gofrestru â'r Cyngor os yw'n dymuno darparu gwasanaethau datblygu ieuenciad ar gyfer neu ar ran corff perthnasol. Mae erthygl 5(2) yn darparu bod yr esemtiad i weithwyr dros dro ac achlysurol o'r UE hefyd yn gymwys i'r cyfyngiad yn erthygl 5(1).

Effaith Rhan 4 o'r Gorchymyn hwn yw creu system cofrestru gorfodol ar gyfer ymarferwyr dysgu seiliedig ar waith, fel bod rhaid i unrhyw berson sy'n darparu gwasanaethau ymarferydd dysgu seiliedig ar waith ar gyfer neu ar ran corff dysgu seiliedig ar waith (fel y'i diffinnir yn y Gorchymyn hwn), gofrestru â'r Cyngor (erthygl 7(1)). Nid oes darpariaeth i ymarferwyr dysgu seiliedig ar waith gofrestru'n wirfoddol.

Mae'r tabl diwygiedig ym mharagraff 1 o Atodlen 2 i Ddeddf 2014 yn disgrifio ymarferydd dysgu seiliedig ar waith fel person sy'n darparu gwasanaethau ymarferydd dysgu seiliedig ar waith ar gyfer neu ar ran corff dysgu seiliedig ar waith. Corff dysgu seiliedig ar waith yw corff a gyllidir gan Weinidogion Cymru i ddarparu gwasanaethau dysgu seiliedig ar waith. Gellir gweld rhestr o gyrff o'r fath ar wefan Llywodraeth Cymru yn [www.dysgu.llyw.cymru](http://www.dysgu.llyw.cymru).

Mae'r disgrifiad o ymarferydd dysgu seiliedig ar waith yn cynnwys nifer o rolau proffesiynol sy'n ymwneud â chyflenwi dysgu seiliedig ar waith. O fewn y proffesiwn, adwaenir y rolau hyn yn aml fel "mentoriaid", "hyfforddwyr" ac "aseswyr". Mae erthygl 7(2) yn darparu bod yr esemtiad i weithwyr dros dro ac achlysurol o'r UE hefyd yn gymwys i'r cyfyngiad yn erthygl 7(1).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn. Gellir cael copi oddi wrth yr Adran Addysg a Gwasanaethau Cyhoeddus yn Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

Article 3(2) sets out an exception to the restriction in article 3(1); that exception applies where a person moves to the UK from another member state in the European Union to carry out work as a youth worker on a temporary and occasional basis. That person is not subject to the requirement to register ("the EU temporary and occasional worker exemption"). This provision ensures compliance with Part 2 of the European Union (Recognition of Professional Qualifications) Regulations 2015.

The effect of Part 3 of this Order is also to create a voluntary registration system for youth support workers, so that any person providing youth development services may register with the Council. However, Part 3 also provides that a person must register with the Council if they want to provide youth development services for or on behalf of a relevant body. Article 5(2) provides that the EU temporary and occasional worker exemption also applies to the restriction in article 5(1).

The effect of Part 4 of this Order is to create a compulsory registration system for work based learning practitioners, so that any person providing work based learning practitioner services for or on behalf of a work based learning body (as defined in this Order) must register with the Council (article 7(1)). There is no provision for voluntary registration of work based learning practitioners.

The amended table in paragraph 1 in Schedule 2 to the 2014 Act describes a work based learning practitioner as a person who provides work based learning practitioner services for or on behalf of a work based learning body. A work based learning body is a body which is funded by the Welsh Ministers to provide work based learning services. A list of such bodies can be found on the Welsh Government website at [www.learning.gov.wales](http://www.learning.gov.wales).

The description of a work based learning practitioner includes a number of professional roles involved in the delivery of work based learning. Those roles are often known within the profession as work based learning "mentors", "coaches" and "assessors". Article 7(2) provides that the EU temporary and occasional worker exemption also applies to the restriction in article 7(1).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with this Order. The Welsh Ministers, in exercise of the powers conferred on them by section 47(1) of, and paragraph 2 of Schedule 2 to, the Education (Wales) Act 2014(1), having consulted such persons as they consider appropriate, make the following Order.

In accordance with section 47(2) of the Education (Wales) Act 2014, a draft of this Order was laid before the National Assembly for Wales and approved by a resolution of the National Assembly for Wales.

**PART 1**

**General**

**Title and commencement**

1.—(1) The title of this Order is the Education Workforce Council (Registration of Youth Workers, Youth Support Workers and Work Based Learning Practitioners) Order 2016.

(2) This Order comes into force on 1 March 2017 except articles 4, 6 and 7 which come into force on 1 April 2017.

## Dehongli

### 2. Yn y Gorchymyn hwn—

ystyr “corff dysgu seiliedig ar waith” (“*work based learning body*”) yw corff y darperir adnoddau ariannol iddo yn unol ag adran 34(1) o Ddeddf Dysgu a Sgiliau 2000(1) mewn cysylltiad â darparu dysgu seiliedig ar waith;

## Interpretation

### 2. In this Order—

“the 2014 Act” (“*Deddf 2014*”) means the Education (Wales) Act 2014;

“the 2015 Regulations” (“*Rheoliadau 2015*”) means the European Union (Recognition of Professional Qualifications) Regulations 2015(1);

“relevant body” (“*corff perthnasol*”) means—

- (a) a local authority in Wales;
- (b) a governing body of a school;
- (c) a further education institution in Wales;
- (d) a voluntary body, to the extent that the youth development services provided for or on behalf of the voluntary body are provided to people in Wales;

“voluntary body” (“*corff gwirfoddol*”) means a body, other than a body exercising functions of a public nature, the activities of which are not carried out for profit;

“work based learning body” (“*corff dysgu seiliedig ar waith*”) means a body to which financial resources are provided pursuant to section 34(1) of the Learning and Skills Act 2000(2) in respect of the provision of work based learning.

(2) But paragraph (1) does not apply to a person who is providing youth worker services in respect of which Part 2 of the 2015 Regulations apply (freedom to provide services in the United Kingdom on a temporary and occasional basis).

## PART 3

### YOUTH SUPPORT WORKERS

#### Youth support workers: qualifications and alternative requirements

5.—(1) Part 1 of Schedule 2 to this Order sets out the youth support worker qualifications for the purposes of the description of the category of youth support worker in Table 1 in paragraph 1 of Schedule 2 to the 2014 Act.

(2) Part 2 of Schedule 2 to this Order sets out the alternative requirement for the purposes of that description.

#### Youth support workers: requirement to register

6.—(1) A person falling within the category of youth support worker in Table 1 in paragraph 1 of Schedule 2 to the 2014 Act must not provide youth development services for or on behalf of a relevant body (other than as a volunteer) unless he or she is registered under section 9 of the 2014 Act in the category of youth support worker.

(2) Paragraph (1) does not apply to a person who is providing youth support worker services in respect of which Part 2 of the 2015 Regulations apply (freedom to provide services in the United Kingdom on a temporary and occasional basis).

(2) Paragraph (1) does not apply to a person who is providing work based learning practitioner services in respect of which Part 2 of the 2015 Regulations apply (freedom to provide services in the United Kingdom on a temporary and occasional basis).

- (b) to develop knowledge and skills relevant to a particular trade, occupation or employer;

“work based learning practitioner services” (“*gwasanaethau ymarferydd dysgu seiliedig ar waith*”) are—

- (a) the co-ordination and delivery of work based learning;
- (b) the assessment of the knowledge and skills of a person receiving (or about to receive) work based learning;

“gwasanaethau ymarferydd dysgu seiliedig ar waith” (“*work based learning practitioner services*”) yw—

- (a) cydgysylltu a chyflenwi dysgu seiliedig ar waith;
