Mae'r Rheoliadau hyn yn diwygio Rheoliadau Arolygon Etholiadau Lleol (Cymru) 2012 ("Rheoliadau 2012").

Mae adran 1 o Fesur Llywodraeth Leol (Cymru) 2011 ("y Mesur") yn gosod dyletswydd ar awdurdod lleol (cyngor sir neu gyngor bwrdeistref sirol) i gynnal arolwg, drwy ofyn cwestiynau rhagnodedig i gynghorwyr ac ymgeiswyr sydd wedi sefyll i gael eu hethol yn gynghorwyr i'r cyngor sir neu'r cyngor bwrdeistref sirol neu i gyngor cymuned yn ardal yr awdurdod lleol. Diwygiwyd adran 1 gan Ddeddf Llywodraeth Leol (Cymru) 2015 ("Deddf 2015") ac mae'n darparu bod rhaid cynnal yr arolwg cyn neu ar ôl pob etholiad cyffredin ac i dynnu'r gofyniad i awdurdodau lleol wneud trefniadau i wybodaeth gael ei darparu yn ddiennw.

Mae Rheoliadau 2012 yn rhagnodi'r cwestiynau y mae'n rhaid eu gofyn. Mae rheoliadau 3 a 4 yn diwygio Rheoliadau 2012 ac yn mewnosod arolwg newydd yn Rheoliadau 2012. Mae'r arolwg diwygiedig yn debyg i'r arolwg yn Rheoliadau 2012, gan ychwanegu cwestiynau unigryw sy'n cynnwys gwybodaeth adnabod y gellir eu defnyddio er mwyn canfod a oedd ymatebydd i'r arolwg wedi ei ethol yn gynghorydd. Mae'r diwygiadau hefyd yn ei gwneud yn ofynnol i ofyn cwestiynau gwahanol yn dibynnu ar ba un ai cyn neu ar ôl etholiad cyffredin y cynhelir yr arolwg.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Local Election Survey (Wales) Regulations 2012 ("the 2012 Regulations").

Section 1 of the Local Government (Wales) Measure 2011 ("the Measure") imposes a duty on a local authority (a county council or county borough council), to conduct a survey by asking prescribed questions of councillors and candidates who have stood for election as councillors to the council of the county or county borough or to a community council in the local authority's area. Section 1 was amended by the Local Government (Wales) Act 2015 ("the 2015 Act") and provides that the survey must be conducted before or after each ordinary election, and removes the requirement for local authorities to arrange for information to be provided anonymously.

The 2012 Regulations prescribe the questions that must be asked. Regulations 3 and 4 amend the 2012 Regulations and insert a new survey into the 2012 Regulations. The amended survey is similar to the survey in the 2012 Regulations, with the addition of unique identifying questions which can be used to establish whether a survey respondent was elected as a councillor. The amendments will also require different questions to be asked depending on whether the survey is being conducted before or after an ordinary election.
